Notwithstanding any other law limiting expenditures, 7 the amount of \$1 is established for the biennium beginning July 1, 2021, 8 as the maximum limit for payment of expenses from lottery moneys 9 allocated from the Administrative Services Economic Development 10 Fund to the Public Employees Retirement System for the Employer 11 Incentive Fund.

<sup>12</sup> "<u>SECTION 3.</u> Notwithstanding any other law limiting expenditures, <sup>13</sup> the amount of \$1 is established for the biennium beginning July 1, 2021, <sup>14</sup> as the maximum limit for payment of expenses from fees, moneys, or <sup>15</sup> other revenues, including Miscellaneous Receipts, but excluding lot-<sup>16</sup> tery funds and federal funds, by the Public Employees Retirement <sup>17</sup> System from the Employer Incentive Fund.

18 "SECTION 4. Notwithstanding any other law limiting expenditures, 19 the amount of \$1 is established for the biennium beginning July 1, 2021, 20 as the maximum limit for payment of expenses by the Public Em-21 ployees Retirement System from the School Districts Unfunded Li-22 ability Fund.

23 "SECTION 5. For the biennium beginning July 1, 2021, expenditures 24 by the Public Employees Retirement System for refunds, retirement 25 benefits, deferred compensation and individual account program pay-26 ments, health insurance premiums, health insurance premium subsi-27 dies, third party administrator costs for health and individual account 28 programs and Public Employee Benefit Equalization Fund payments 29 are not limited.

30 "SECTION 6. This 2021 Act being necessary for the immediate

1 preservation of the public peace, health and safety, an emergency is

2 declared to exist, and this 2021 Act takes effect July 1, 2021.".
