**“STATUTES RELATED TO MARIJUANA**

11 **“SECTION 1. ORS 475B.015 is amended to read:**

12 **“475B.015. As used in ORS 475B.010 to 475B.545:**

13 **“(1) ‘Adult use cannabinoid’ includes, but is not limited to,**  
14 **tetrahydrocannabinols, tetrahydrocannabinolic acids that are arti-**  
15 **ficially or naturally derived, delta-8-tetrahydrocannabinol,**  
16 **delta-9-tetrahydrocannabinol, the optical isomers of**  
17 **delta-8-tetrahydrocannabinol or delta-9-tetrahydrocannabinol and any**  
18 **artificially derived cannabinoid that is reasonably determined to have**  
19 **an intoxicating effect.**

20 **“(2) ‘Adult use cannabis item’ means:**

21 **“(a) A marijuana item; or**

1       **“(b) An industrial hemp commodity or product that exceeds:**

2       **“(A) The concentration of adult use cannabinoids established by the**  
3 **Oregon Liquor Control Commission, in consultation with the Oregon**  
4 **Health Authority and the State Department of Agriculture, by rule;**  
5 **or**

6       **“(B) The greater of:**

7       **“(i) A concentration of more than 0.3 percent total**  
8 **delta-9-tetrahydrocannabinol; or**

9       **“(ii) The concentration of total delta-9-tetrahydrocannabinol al-**  
10 **lowed under federal law.**

11       **“(3)(a) ‘Artificially derived cannabinoid’ means a chemical sub-**  
12 **stance that is created by a chemical reaction that changes the molec-**  
13 **ular structure of any chemical substance derived from the plant**  
14 **Cannabis family Cannabaceae.**

15       **“(b) ‘Artificially derived cannabinoid’ does not include:**

16       **“(A) A naturally-occurring chemical substance that is separated**  
17 **from the plant Cannabis family Cannabaceae by a chemical or me-**  
18 **chanical extraction process;**

19       **“(B) Cannabinoids that are produced by decarboxylation from a**  
20 **naturally-occurring cannabinoid acid without the use of a chemical**  
21 **catalyst; or**

22       **“(C) Any other chemical substance identified by the commission, in**  
23 **consultation with the authority and the department, by rule.**

24       **“[(1)] (4) ‘Cannabinoid’ means any of the chemical compounds that are the**  
25 **active constituents derived from marijuana.**

26       **“[(2)] (5) ‘Cannabinoid concentrate’ means a substance obtained by sepa-**  
27 **rating cannabinoids from marijuana by:**

28       **“(a) A mechanical extraction process;**

29       **“(b) A chemical extraction process using a nonhydrocarbon-based solvent,**  
30 **such as water, vegetable glycerin, vegetable oils, animal fats, isopropyl al-**

1   cohol or ethanol;

2       “(c) A chemical extraction process using carbon dioxide, provided that the  
3   process does not involve the use of high heat or pressure; or

4       “(d) Any other process identified by the [*Oregon Liquor Control*] commis-  
5   sion, in consultation with the [*Oregon Health*] authority, by rule.

6       “[(3)] (6) ‘Cannabinoid edible’ means food or potable liquid into which a  
7   cannabinoid concentrate, cannabinoid extract or dried marijuana leaves or  
8   flowers have been incorporated.

9       “[(4)] (7) ‘Cannabinoid extract’ means a substance obtained by separating  
10   cannabinoids from marijuana by:

11       “(a) A chemical extraction process using a hydrocarbon-based solvent,  
12   such as butane, hexane or propane;

13       “(b) A chemical extraction process using carbon dioxide, if the process  
14   uses high heat or pressure; or

15       “(c) Any other process identified by the commission, in consultation with  
16   the authority, by rule.

17       “[(5)(a)] (8)(a) ‘Cannabinoid product’ means a cannabinoid edible and any  
18   other product intended for human consumption or use, including a product  
19   intended to be applied to the skin or hair, that contains cannabinoids or  
20   dried marijuana leaves or flowers.

21       “(b) ‘Cannabinoid product’ does not include:

22       “(A) Usable marijuana by itself;

23       “(B) A cannabinoid concentrate by itself;

24       “(C) A cannabinoid extract by itself; or

25       “(D) Industrial hemp[, *as defined in ORS 571.269*].

26       “[(6)] (9) ‘Consumer’ means a person who purchases, acquires, owns, holds  
27   or uses marijuana items other than for the purpose of resale.

28       “[(7)] (10) ‘Deliver’ means the actual, constructive or attempted transfer  
29   from one person to another of a marijuana item, whether or not there is an  
30   agency relationship.

1 “(11) **‘Delta-9-tetrahydrocannabinol’ or ‘delta-9-THC’ means**  
2 **(6aR,10aR)-6,6,9-trimethyl-3-pentyl-6a,7,8,10a-tetrahydro-6H-benzo**  
3 **[c]chromen-1-ol.**

4 “(12) **‘Delta-9-tetrahydrocannabinolic acid’ or ‘delta-9-THCA’ means**  
5 **(6aR,10aR)-1-hydroxy-6,6,9-trimethyl-3-pentyl-6a,7,8,10a-tetrahyd**  
6 **ro-6H-benzo[c]chromene-2-carboxylic acid.**

7 “[8] (13) **‘Designated primary caregiver’** has the meaning given that term  
8 in ORS 475B.791.

9 “[9(a)] (14)(a) **‘Financial consideration’** means value that is given or  
10 received either directly or indirectly through sales, barter, trade, fees,  
11 charges, dues, contributions or donations.

12 “(b) **‘Financial consideration’** does not include marijuana, cannabinoid  
13 products or cannabinoid concentrates that are delivered within the scope of  
14 and in compliance with ORS 475B.301.

15 “[10] (15) **‘Homegrown’** means grown by a person 21 years of age or older  
16 for noncommercial purposes.

17 “[11] (16) **‘Household’** means a housing unit and any place in or around  
18 a housing unit at which the occupants of the housing unit are producing,  
19 processing, possessing or storing homegrown marijuana, cannabinoid pro-  
20 ducts, cannabinoid concentrates or cannabinoid extracts.

21 “[12] (17) **‘Housing unit’** means a house, an apartment or a mobile home,  
22 or a group of rooms or a single room that is occupied as separate living  
23 quarters, in which the occupants live and eat separately from any other  
24 persons in the building and that has direct access from the outside of the  
25 building or through a common hall.

26 “[13] (18) **‘Immature marijuana plant’** means a marijuana plant that is  
27 not flowering.

28 “(19) **‘Industrial hemp’** has the meaning given that term in ORS  
29 **571.269.**

30 “[14] (20) **‘Licensee’** means a person that holds a license issued under

1 ORS 475B.070, 475B.090, 475B.100 or 475B.105.

2 “[15] (21) ‘Licensee representative’ means an owner, director, officer,  
3 manager, employee, agent or other representative of a licensee, to the extent  
4 that the person acts in a representative capacity.

5 “[16)(a)] (22)(a) ‘Manufacture’ means producing, propagating, preparing,  
6 compounding, converting or processing a marijuana item, either directly or  
7 indirectly, by extracting from substances of natural origin.

8 “(b) ‘Manufacture’ includes any packaging or repackaging of a marijuana  
9 item or the labeling or relabeling of a container containing a marijuana  
10 item.

11 “[17)(a)] (23)(a) ‘Marijuana’ means the plant Cannabis family  
12 Cannabaceae, any part of the plant Cannabis family Cannabaceae and  
13 marijuana seeds.

14 “(b) ‘Marijuana’ does not include:

15 “(A) Industrial hemp[, *as defined in ORS 571.269*]; or

16 “(B) Prescription drugs, as that term is defined in ORS 689.005, including  
17 those containing one or more cannabinoids, that are approved by the United  
18 States Food and Drug Administration and dispensed by a pharmacy, as de-  
19 fined in ORS 689.005.

20 “[18] (24) ‘Marijuana flowers’ means the flowers of the plant genus  
21 Cannabis within the plant family Cannabaceae.

22 “[19] (25) ‘Marijuana items’ means marijuana, cannabinoid products,  
23 cannabinoid concentrates and cannabinoid extracts.

24 “[20] (26) ‘Marijuana leaves’ means the leaves of the plant genus  
25 Cannabis within the plant family Cannabaceae.

26 “[21] (27) ‘Marijuana processor’ means:

27 “(a) A person that processes marijuana items in this state[.]; or

28 “(b) **A person that holds a license issued under ORS 475B.090 and**  
29 **processes industrial hemp commodities or products pursuant to ORS**  
30 **571.336.**

1 “[22] (28) ‘Marijuana producer’ means a person that produces marijuana  
2 in this state.

3 “[23] (29) ‘Marijuana retailer’ means a person that sells marijuana items  
4 to a consumer in this state.

5 “[24)(a)] (30)(a) ‘Marijuana seeds’ means the seeds of the plant Cannabis  
6 family Cannabaceae.

7 “(b) ‘Marijuana seeds’ does not include the seeds of industrial hemp[, *as*  
8 *defined in ORS 571.269*].

9 “[25] (31) ‘Marijuana wholesaler’ means a person that purchases  
10 marijuana items in this state for resale to a person other than a consumer.

11 “[26] (32) ‘Mature marijuana plant’ means a marijuana plant that is not  
12 an immature marijuana plant.

13 “[27] (33) ‘Medical grade cannabinoid product, cannabinoid concentrate  
14 or cannabinoid extract’ means a cannabinoid product, cannabinoid concen-  
15 trate or cannabinoid extract that has a concentration of  
16 [*tetrahydrocannabinol*] **adult use cannabinoids** that is permitted under ORS  
17 475B.625 in a single serving of the cannabinoid product, cannabinoid con-  
18 centrate or cannabinoid extract for consumers who hold a valid registry  
19 identification card issued under ORS 475B.797.

20 “[28] (34) ‘Medical purpose’ means a purpose related to using usable  
21 marijuana, cannabinoid products, cannabinoid concentrates or cannabinoid  
22 extracts to mitigate the symptoms or effects of a debilitating medical condi-  
23 tion, as defined in ORS 475B.791.

24 “[29] (35) ‘Noncommercial’ means not dependent or conditioned upon the  
25 provision or receipt of financial consideration.

26 “[30)(a)] (36)(a) ‘Premises’ includes the following areas of a location li-  
27 censed under ORS 475B.010 to 475B.545:

28 “(A) All public and private enclosed areas at the location that are used  
29 in the business operated at the location, including offices, kitchens, rest  
30 rooms and storerooms;

1 “(B) All areas outside a building that the commission has specifically li-  
2 censed for the processing, wholesale sale or retail sale of marijuana items;  
3 and

4 “(C) For a location that the commission has specifically licensed for the  
5 production of marijuana outside a building, that portion of the location used  
6 to produce marijuana.

7 “(b) ‘Premises’ does not include a primary residence.

8 “[31)(a)] **(37)(a)** ‘Processes’ means the processing, compounding or con-  
9 version of:

10 “**(A)** Marijuana into cannabinoid products, cannabinoid concentrates or  
11 cannabinoid extracts[.]; **or**

12 “**(B) Industrial hemp or industrial hemp commodities or products**  
13 **into industrial hemp commodities or products that contain**  
14 **cannabinoids and are intended for human consumption or use.**

15 “(b) ‘Processes’ does not include packaging or labeling.

16 “[32)(a)] **(38)(a)** ‘Produces’ means the manufacture, planting, cultivation,  
17 growing or harvesting of marijuana.

18 “(b) ‘Produces’ does not include:

19 “**(A)** The drying of marijuana by a marijuana processor, if the marijuana  
20 processor is not otherwise producing marijuana; or

21 “**(B)** The cultivation and growing of an immature marijuana plant by a  
22 marijuana processor, marijuana wholesaler or marijuana retailer if the  
23 marijuana processor, marijuana wholesaler or marijuana retailer purchased  
24 or otherwise received the plant from a licensed marijuana producer.

25 “[33)] **(39)** ‘Propagate’ means to grow immature marijuana plants or to  
26 breed or produce marijuana seeds.

27 “[34)] **(40)** ‘Public place’ means a place to which the general public has  
28 access and includes, but is not limited to, hallways, lobbies and other parts  
29 of apartment houses and hotels not constituting rooms or apartments de-  
30 signed for actual residence, and highways, streets, schools, places of

1 amusement, parks, playgrounds and areas used in connection with public  
2 passenger transportation.

3 “[35] (41) ‘Registry identification cardholder’ has the meaning given that  
4 term in ORS 475B.791.

5 “(42) ‘Total delta-9-tetrahydrocannabinol’ or ‘total delta-9-THC’  
6 means the sum of the concentration or mass of delta-9-THCA multi-  
7 plied by 0.877 plus the concentration or mass of delta-9-THC.

8 “[36)(a)] (43)(a) ‘Usable marijuana’ means the dried leaves and flowers  
9 of marijuana.

10 “(b) ‘Usable marijuana’ does not include:

11 “(A) Marijuana seeds;

12 “(B) The stalks and roots of marijuana; or

13 “(C) Waste material that is a by-product of producing or processing  
14 marijuana.

15 “**SECTION 2.** ORS 475B.025 is amended to read:

16 “475B.025. (1) The Oregon Liquor Control Commission has the duties,  
17 functions and powers specified in ORS 475B.010 to 475B.545 and the powers  
18 necessary or proper to enable the commission to carry out the commission’s  
19 duties, functions and powers under ORS 475B.010 to 475B.545. The jurisdic-  
20 tion, supervision, duties, functions and powers of the commission extend to  
21 any person that produces, processes, transports, delivers, sells or purchases  
22 a marijuana item in this state. The commission may sue and be sued.

23 “(2) The duties, functions and powers of the commission specified in ORS  
24 475B.010 to 475B.545 include the following:

25 “(a) To regulate the production, processing, transportation, delivery, sale  
26 and purchase of marijuana items in accordance with the provisions of ORS  
27 475B.010 to 475B.545.

28 “(b) To issue, renew, suspend, revoke or refuse to issue or renew licenses  
29 for the production, processing or sale of marijuana items, or other licenses  
30 related to the consumption of marijuana items, and to permit, in the



1 commission's discretion, the transfer of a license between persons.

2 “(c) To adopt, amend or repeal rules as necessary to carry out the intent  
3 and provisions of ORS 475B.010 to 475B.545, including rules that the com-  
4 mission considers necessary to protect the public health and safety.

5 “(d) To exercise all powers incidental, convenient or necessary to enable  
6 the commission to administer or carry out the provisions of ORS 475B.010  
7 to 475B.545 or any other law of this state that charges the commission with  
8 a duty, function or power related to marijuana. Powers described in this  
9 paragraph include, but are not limited to:

10 “(A) Issuing subpoenas;

11 “(B) Compelling the attendance of witnesses;

12 “(C) Administering oaths;

13 “(D) Certifying official acts;

14 “(E) Taking depositions as provided by law;

15 “(F) Compelling the production of books, payrolls, accounts, papers, re-  
16 cords, documents and testimony; and

17 “(G) Establishing fees in addition to the application, licensing and re-  
18 newal fees described in ORS 475B.070, 475B.090, 475B.100 and 475B.105, pro-  
19 vided that any fee established by the commission is reasonably calculated  
20 not to exceed the cost of the activity for which the fee is charged.

21 “(e) To adopt rules regulating and prohibiting advertising marijuana  
22 items in a manner:

23 “(A) That is appealing to minors;

24 “(B) That promotes excessive use;

25 “(C) That promotes illegal activity; or

26 “(D) That otherwise presents a significant risk to public health and  
27 safety.

28 “(f) To regulate the use of marijuana items for other purposes as deemed  
29 necessary or appropriate by the commission.

30 “(g) To establish pilot programs, of not more than three years in duration,

1 to expand access to marijuana for medical use for registry identification  
2 cardholders and designated primary caregivers, as defined in ORS 475B.791.

3 **“(h) To regulate the processing, transportation, delivery, sale and**  
4 **purchase of artificially derived cannabinoids in accordance with the**  
5 **provisions of ORS 475B.010 to 475B.545.**

6 “(3) Fees collected pursuant to subsection (2)(d)(G) of this section shall  
7 be deposited in the Marijuana Control and Regulation Fund established un-  
8 der ORS 475B.296.

9 **“SECTION 3.** ORS 475B.090 is amended to read:

10 “475B.090. (1) The processing of marijuana items is subject to regulation  
11 by the Oregon Liquor Control Commission.

12 “(2) A marijuana processor must have a processor license issued by the  
13 commission for the premises at which marijuana items **or industrial hemp**  
14 **commodities or products** are processed. To hold a processor license under  
15 this section, a marijuana processor:

16 “(a) Must apply for a license in the manner described in ORS 475B.040;

17 “(b) Must provide proof that the applicant is 21 years of age or older;

18 “(c) If the marijuana processor processes marijuana extracts[,] **or indus-**  
19 **trial hemp extracts, as defined in ORS 571.269,** may not be located in an  
20 area zoned exclusively for residential use; and

21 “(d) Must meet the requirements of any rule adopted by the commission  
22 under subsection (3) of this section.

23 “(3) The commission shall adopt rules that:

24 “(a) Require a marijuana processor to annually renew a license issued  
25 under this section;

26 “(b) Establish application, licensure and renewal of licensure fees for  
27 marijuana processors;

28 “(c) Require marijuana processed by a marijuana processor to be tested  
29 in accordance with ORS 475B.555;

30 **“(d) Require industrial hemp commodities and products processed**

1 **by a marijuana processor to meet any requirements for industrial**  
2 **hemp commodities or products established under ORS 571.260 to 571.348**  
3 **or rules adopted under ORS 571.260 to 571.348;**

4 “[*d*] (e) Allow a marijuana processor registered under ORS 475B.139 to  
5 process marijuana and usable marijuana into medical grade cannabinoid  
6 products, cannabinoid concentrates and cannabinoid extracts in the same  
7 manner that rules adopted under ORS 475B.010 to 475B.545 allow a  
8 marijuana processor to process marijuana and usable marijuana into general  
9 use cannabinoid products, cannabinoid concentrates and cannabinoid ex-  
10 tracts, excepting those circumstances where differentiating between the pro-  
11 cessing of medical grade cannabinoid products, cannabinoid concentrates and  
12 cannabinoid extracts and the processing of general use cannabinoid products,  
13 cannabinoid concentrates and cannabinoid extracts is necessary to protect  
14 the public health and safety; and

15 “[*e*] (f) Require a marijuana processor to meet any public health and  
16 safety standards and industry best practices established by the commission  
17 by rule related to:

18 “(A) Cannabinoid edibles;

19 “(B) Cannabinoid concentrates;

20 “(C) Cannabinoid extracts; and

21 “(D) Any other type of cannabinoid product **or industrial hemp com-**  
22 **modity or product** identified by the commission by rule.

23 “(4) Fees adopted under subsection (3)(b) of this section:

24 “(a) May not exceed, together with other fees collected under ORS  
25 475B.010 to 475B.545, the cost of administering ORS 475B.010 to 475B.545; and

26 “(b) Shall be deposited in the Marijuana Control and Regulation Fund  
27 established under ORS 475B.296.

28 “**SECTION 4.** ORS 475B.211 is amended to read:

29 “475B.211. Except for a marijuana retailer registered under ORS 475B.146  
30 to sell or deliver marijuana items to a registry identification cardholder who

1 is 18 years of age or older **or as allowed pursuant to ORS 475B.785 to**  
2 **475B.949**, a [*licensee or licensee representative*] **person** may not sell or deliver  
3 [*a marijuana item*] **an adult use cannabis item** to a person under 21 years  
4 of age.

5 **“SECTION 5.** ORS 475B.227 is amended to read:

6 **“475B.227.** (1) For purposes of this section:

7 **“(a)** ‘Export’ includes placing a marijuana item in any mode of transpor-  
8 tation for hire, such as luggage, mail or parcel delivery, even if the trans-  
9 portation of the marijuana item is intercepted prior to the marijuana item  
10 leaving this state.

11 **“(b)** ‘Marijuana item’ includes **an** industrial hemp [*products and com-*  
12 *modities*] **commodity or product** that [*contain more than 0.3 percent*  
13 *tetrahydrocannabinol.*] **exceeds the greater of:**

14 **“(A) A concentration of 0.3 percent total**  
15 **delta-9-tetrahydrocannabinol; or**

16 **“(B) The concentration of total delta-9-tetrahydrocannabinol al-**  
17 **lowed under federal law.**

18 **“(2)** A person may not import marijuana items into this state or export  
19 marijuana items from this state.

20 **“(3)** [*Except as provided in subsection (4) of this section,*] A violation of  
21 this section is a Class B violation[.], **except:**

22 **“(a) As provided in subsection (4) of this section; or**

23 **“(b) If the item is industrial hemp and does not exceed a total**  
24 **delta-9-tetrahydrocannabinol concentration of one percent.**

25 **“(4)** A violation of this section is a:

26 **“(a)** Class A misdemeanor, if the importation or exportation:

27 **“(A)** Is not for consideration and the person holds a license issued under  
28 ORS 475B.070, 475B.090, 475B.100 or 475B.105; or

29 **“(B)** Concerns an amount of marijuana items that exceeds the applicable  
30 maximum amount specified in ORS 475B.337 (1)(a) to (f).

1 “(b) Class C felony, if the importation or exportation:

2 “(A) Is for consideration and the person holds a license issued under ORS  
3 475B.070, 475B.090, 475B.100 or 475B.105;

4 “(B) Concerns an amount of marijuana items that exceeds 16 times the  
5 applicable maximum amount specified in ORS 475B.337 (1)(a) to (f); or

6 “(C) Concerns a cannabinoid extract that was not purchased from a  
7 marijuana retailer that holds a license issued under ORS 475B.105.

8 **“SECTION 5a.** ORS 475B.253 is amended to read:

9 “475B.253. *[(1) As used in this section, ‘industrial hemp’ has the meaning*  
10 *given that term in ORS 571.269.]*

11 “[~~(2)~~] **(1)** An industrial hemp product or commodity offered for sale by a  
12 marijuana retailer that holds a license issued under ORS 475B.105 must carry  
13 a label that clearly identifies whether the product or commodity is derived  
14 from hemp or marijuana.

15 “[~~(3)~~] **(2)** The Oregon Liquor Control Commission may inspect the prem-  
16 ises of a marijuana retailer that holds a license issued under ORS 475B.105  
17 to ensure compliance with this section.

18 **“SECTION 6.** ORS 475B.254 is amended to read:

19 “475B.254. (1) As used in this section:

20 “(a) ‘Consumer’ means a person who purchases, acquires, owns, holds or  
21 uses marijuana items other than for the purpose of resale.

22 “(b) ‘Marijuana item’ includes [*industrial hemp products and*  
23 *commodities*] **an industrial hemp commodity or product** that [*contain*  
24 *more than 0.3 percent tetrahydrocannabinol.*] **exceeds:**

25 **“(A) The concentration of adult use cannabinoids established by the**  
26 **Oregon Liquor Control Commission, in consultation with the Oregon**  
27 **Health Authority and the State Department of Agriculture, by rule;**  
28 **or**

29 **“(B) The greater of:**

30 **“(i) A concentration of 0.3 percent total**

1 **delta-9-tetrahydrocannabinol; or**

2 **“(ii) The concentration of total delta-9-tetrahydrocannabinol al-**  
3 **lowed under federal law.**

4 **“(2) A person other than a marijuana retailer that holds a license issued**  
5 **under ORS 475B.105 may not sell marijuana items to a consumer.**

6 **“SECTION 7. ORS 475B.529 is amended to read:**

7 **“475B.529. (1) Notwithstanding the authority granted to the State De-**  
8 **partment of Agriculture under ORS chapters 571, 618 and 633 and ORS**  
9 **632.275 to 632.290, 632.450 to 632.490, 632.516 to 632.625, 632.705 to 632.815,**  
10 **632.835 to 632.850 and 632.900 to 632.985, the department may not exercise**  
11 **authority over marijuana items or a licensee, except that ORS 618.121 to**  
12 **618.161, 618.991, 618.995, 633.311 to 633.479, 633.992 and 633.994 apply to**  
13 **marijuana items or to a licensee.**

14 **“(2) In exercising its authority under ORS chapter 616, the department**  
15 **may not:**

16 **“(a) Establish standards for marijuana as a food additive, as defined in**  
17 **ORS 616.205;**

6       **“(A) One member who represents counties in this state;**  
7       **“(B) One member who represents cities in this state;**  
8       **“(C) One member who represents law enforcement agencies;**  
9       **“(D) One member who represents industrial hemp growers licensed**  
10 **under ORS 571.281;**  
11       **“(E) One member who represents industrial hemp handlers licensed**  
12 **under ORS 571.281;**  
13       **“(F) The director of the Oregon State University Global Hemp In-**  
14 **novation Center, or designee of the director;**  
15       **“(G) Two members who represent licensees, as defined in ORS**  
16 **475B.015;**  
17       **“(H) The Director of Agriculture, or a designee of the director;**  
18       **“(I) The director of the Oregon Health Authority Public Health Di-**  
19 **vision, or designee of the director; and**  
20       **“(J) The administrator of the Oregon Liquor Control Commission,**  
21 **or a designee of the administrator.**  
22       **“(3) The task force shall consider:**  
23       **“(a) Changes to state law to support the regulation of intoxicating**  
24 **cannabis-derived products and artificially derived cannabinoids;**  
25       **“(b) The consolidation of administrative functions related to the**  
26 **regulation of cannabis;**  
27       **“(c) Methods to prevent sales to minors of industrial hemp com-**  
28 **modities or products that contain intoxicating cannabinoids;**  
29       **“(d) Regulation to address genetic engineering of cannabis;**  
30       **“(e) Testing requirements and methods of enforcement of testing**

1 requirements for cannabinoids, including artificially derived  
2 cannabinoids, to protect the public health and safety;

3 “(f) Policy changes related to interstate commerce and transporta-  
4 tion of cannabis;

5 “(g) Changes to state regulation of cannabis as a result of federal  
6 laws; and

7 “(h) Input from marijuana and industrial hemp industry members.

8 “(4) A majority of the voting members of the task force constitutes  
9 a quorum for the transaction of business.

10 “(5) Official action by the task force requires the approval of a  
11 majority of the voting members of the task force.

12 “(6) The task force shall elect one of its members to serve as  
13 chairperson.

14 “(7) If there is a vacancy for any cause, the appointing authority  
15 shall make an appointment to become immediately effective.

16 “(8) The task force shall meet at times and places specified by the  
17 call of the chairperson or of a majority of the voting members of the  
18 task force.

19 “(9) The task force may adopt rules necessary for the operation of  
20 the task force.

21 “(10) Not later than June 30, 2022, the State Department of Agri-  
22 culture shall report to the task force on the implementation of section  
23 18 of this 2021 Act.

24 “(11)(a) The task force shall submit a report in the manner provided  
25 by ORS 192.245, and shall include initial findings and recommendations  
26 for legislation, to the interim committee of the Legislative Assembly  
27 related to economic development no later than December 31, 2021.

28 “(b) The task force shall submit a report in the manner provided  
29 by ORS 192.245, and shall include final findings and recommendations  
30 for legislation, to the interim committee of the Legislative Assembly

1 related to economic development no later than December 31, 2022. The  
2 report submitted under this paragraph must include a summary of the  
3 information submitted to the task force by the department under  
4 subsection (10) of this section.

5 “(12) The Oregon Liquor Control Commission and the State De-  
6 partment of Agriculture, in consultation with the Oregon Health Au-  
7 thority and the Department of Revenue, shall provide staff support to  
8 the task force.

9 “(13) Members of the task force who are not members of the Leg-  
10 islative Assembly are not entitled to compensation or reimbursement  
11 for expenses and serve as volunteers on the task force.

12 “(14) All agencies of state government, as defined in ORS 174.111,  
13 are directed to assist the task force in the performance of the duties  
14 of the task force and, to the extent permitted by laws relating to  
15 confidentiality, to furnish information and advice the members of the  
16 task force consider necessary to perform their duties.

17 “SECTION 38. Section 37 of this 2021 Act is repealed on January 2,  
18 2023.

20 “ILLEGAL MARIJUANA MARKET ENFORCEMENT  
21 GRANT PROGRAM FUNDING  
22

23 “SECTION 39. Section 16, chapter 103, Oregon Laws 2018, is amended to  
24 read:

25 “**Sec. 16.** (1) Notwithstanding ORS 475B.759, before making any other  
26 distribution from the Oregon Marijuana Account established under ORS  
27 475B.759, the Department of Revenue shall first distribute quarterly from the  
28 account the following:

29 “(a) \$875,000 to the Oregon Liquor Control Commission for deposit in the  
30 Marijuana Control and Regulation Fund established under ORS 475B.296;

1 and

2 “(b) [~~\$375,000~~] **\$750,000** to the Oregon Criminal Justice Commission for  
3 deposit into the Illegal Marijuana Market Enforcement Grant Program Fund  
4 established under section 15 [*of this 2018 Act*], **chapter 103, Oregon Laws**  
5 **2018**, for the purposes of paying the costs incurred by the commission in  
6 carrying out the provisions of section 13 [*of this 2018 Act*], **chapter 103,**  
7 **Oregon Laws 2018.**

8 “(2) The final distribution made under subsection (1) of this section shall  
9 be made in the fiscal quarter beginning on October 1, 2023.

## “ENFORCEMENT

12

13 **“SECTION 40. (1) The Oregon Liquor Control Commission shall,**  
14 **with the assistance of the State Department of Agriculture, create and**  
15 **continually update a map of the locations of industrial hemp oper-**  
16 **ations licensed under ORS 571.281 and premises for which a license has**  
17 **been issued under ORS 475B.070.**

18 **“(2) The commission shall make the map described in subsection (1)**  
19 **of this section available to law enforcement agencies in this state and**  
20 **public employees and officials who are responsible for the enforcement**  
21 **of state and local laws regulating industrial hemp or marijuana.**

22 **“SECTION 41. (1) A person commits the crime of unlawful pro-**  
23 **duction of marijuana if the person produces marijuana or industrial**  
24 **hemp at a location that is not:**

25 **“(a) Included on the map described in section 40 of this 2021 Act;**

26 **“(b) Otherwise confirmed by the Oregon Health Authority, the**  
27 **Oregon Liquor Control Commission or the State Department of Agri-**  
28 **culture to be the location of an industrial hemp operation licensed**  
29 **under ORS 571.281, a premises for which a license was issued under**  
30 **ORS 475B.090 or a marijuana grow site registered under ORS 475B.810;**

1 or

2 “(c) In a manner that is not otherwise allowed by state law.

3 “(2) An unlawful marijuana grow is a Class A misdemeanor.

4 “(3) A law enforcement agency may eradicate marijuana or indus-  
5 trial hemp that is unlawfully produced.

6 “SECTION 42. (1) The State Department of Agriculture may enter  
7 into an interagency agreement with the Oregon Liquor Control Com-  
8 mission to allow representatives of the commission to carry out in-  
9 spections of industrial hemp crops under ORS 571.281 (7).

10 “(2) The department and the commission may adopt rules to carry  
11 out this section.

12 “SECTION 43. (1) Law enforcement officers and public employees  
13 and officials who are responsible for the enforcement of state and local  
14 laws may, pursuant to rules adopted by the State Department of Ag-  
15 riculture under subsection (2) of this section, accompany the depart-  
16 ment to an industrial hemp operation for the purposes of providing  
17 assistance in carrying out inspections under ORS 571.281 (7), including  
18 protection for the department’s representatives and the testing of  
19 plants at an industrial hemp operation to distinguish between indus-  
20 trial hemp and marijuana.

21 “(2) The department shall adopt rules to carry out this section.

22 “SECTION 44. The Governor may order that the Oregon National  
23 Guard provide assistance and support to the State Department of Ag-  
24 riculture in carrying out inspections of industrial hemp crops under  
25 ORS 571.281 (7) and other duties of the department related to the  
26 enforcement of ORS 571.260 to 571.348.

27 “SECTION 45. Sections 40 to 44 of this 2021 Act are repealed on  
28 January 1, 2024.

9 **preservation of the public peace, health and safety, an emergency is**
