**PROPOSED AMENDMENTS TO
SENATE BILL 562**

1 In line 2 of the printed bill, after “children;” delete the rest of the line
2 and insert “creating new provisions; amending ORS 109.092, 109.096, 109.098,
3 109.252, 109.304, 109.308, 109.309, 109.315, 109.317, 109.319, 109.321, 109.322,
4 109.323, 109.324, 109.326, 109.330, 109.350, 109.385, 418.270, 418.312, 419A.116,
5 419B.090, 419B.100, 419B.150, 419B.171, 419B.185, 419B.234, 419B.305, 419B.310,
6 419B.325, 419B.328, 419B.365, 419B.366, 419B.368, 419B.395, 419B.449, 419B.452,
7 419B.470, 419B.476, 419B.498, 419B.500, 419B.517, 419B.521, 419B.524, 419B.529,
8 419B.532, 419B.875, 419B.878, 419B.923 and 419C.626 and sections 2, 3, 4, 5, 7,
9 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 21, 22, 23, 61, 63 and 64, chapter 14,
10 Oregon Laws 2020 (first special session); and declaring an emergency.”.

13 **“ADOPTIONS OF INDIAN CHILDREN**

14 **“(Jurisdiction; Domicile; Hearing)**

15

16 **“SECTION 1.** Section 12, chapter 14, Oregon Laws 2020 (first special
17 session), is amended to read:

18 **“Sec. 12.** (1) Except as otherwise provided in this section, the [*juvenile*]
19 court’s jurisdiction under ORS **109.309 (4) or** 419B.100 (1) in a case involving
20 an Indian child is concurrent with the Indian child’s tribe.

21 **“(2)** If a tribe is not subject to Public Law 83-280, the tribe has exclusive

1 jurisdiction in a case described in ORS **109.309 (4) or** 419B.100 (1) involving
2 an Indian child if:

3 “(a) The Indian child is a ward of a tribal court of the [*Indian child’s*]
4 tribe; or

5 “(b) The Indian child resides or is domiciled within the reservation of the
6 tribe.

7 “(3)(a) An Indian tribe subject to Public Law 83-280 may limit the [*juve-*
8 *nile*] court’s exercise of jurisdiction under ORS **109.309 (4) or** 419B.100 (1)
9 over an Indian child by entering into a tribal-state agreement described in
10 section 10, **chapter 14, Oregon Laws 2020 (first special session)** [*of this*
11 *2020 special session Act*].

12 “(b) The [*juvenile*] court shall decline to exercise its jurisdiction under
13 ORS **109.309 (4) or** 419B.100 (1) over an Indian child who is a ward of a tribal
14 court [*of the Indian child’s tribe,*] or who resides or is domiciled within the
15 reservation of [*the*] a tribe[,] if:

16 “(A) The tribe has entered into a tribal-state agreement in which the state
17 has agreed to decline jurisdiction; and

18 “(B) The tribal-state agreement provides that the tribe has default juris-
19 diction over those cases.

20 “(c)(A) If the [*juvenile*] court declines to exercise its jurisdiction under
21 paragraph (b) of this subsection, the court shall coordinate with the tribal
22 court to facilitate the tribal court’s assumption of jurisdiction.

23 “(B) The [*juvenile*] court shall:

24 “(i) Allow the Indian child’s parent, Indian custodian or tribe to partic-
25 ipate in any communications under this subsection with a tribal court or, if
26 the person is unable to participate in a communication, provide the person
27 with an opportunity to represent facts and legal arguments supporting the
28 person’s position before the [*juvenile*] court makes a decision regarding ju-
29 risdiction;

30 “(ii) Create records of any communications under this subsection;

1 “(iii) Notify the Indian child’s parent, Indian custodian or tribe in ad-
2 vance of each communication; and

3 “(iv) Provide the Indian child’s parent, Indian custodian or tribe with
4 access to the record of the communication.

5 “(C) Communications between the [*juvenile*] court and a tribal court re-
6 garding calendars, court records and similar matters may occur without in-
7 forming the parties or creating a record of the communications.

8 “(D) As used in this paragraph, ‘record’ means information that is in-
9 scribed on a tangible medium or that is stored in an electronic or other
10 medium and is retrievable in perceivable form.

11 “(4) Notwithstanding subsections (2) and (3) of this section, the juvenile
12 court has temporary exclusive jurisdiction over an Indian child who is taken
13 into protective custody under ORS 419B.150 or 419B.152.

14 “**SECTION 2.** ORS 109.309 is amended to read:

15 “109.309. (1) Any person may petition the circuit court for leave to adopt
16 another person and, if desired, for a change of the other person’s name. Ex-
17 cept as provided in ORS 419B.529 **or section 65a of this 2021 Act**, a separate
18 petition must be filed for each person for whom leave to adopt is sought.

19 “(2) One petitioner, the child, one parent or the person, who is not an
20 adoption agency, consenting to the adoption as required under ORS 109.321
21 (1) must be a resident of this state. As used in this subsection, ‘resident’
22 means a person who has resided in this state continuously for a period of
23 six months prior to the date of the petition.

24 “(3) Except as provided in subsection (4) of this section, when the petition
25 is for the adoption of a minor child, the adoption is governed by the Uniform
26 Child Custody Jurisdiction and Enforcement Act, ORS 109.701 to 109.834.

27 “(4)(a) Notwithstanding ORS 109.741 and 109.744 **and except as provided**
28 **in section 12, chapter 14, Oregon Laws 2020 (first special session)**, a
29 court of this state has jurisdiction over the adoption of a minor child if,
30 immediately prior to the filing of a petition for adoption:

1 “(A) The minor child resided in this state for at least six consecutive
2 months including periods of temporary absence;

3 “(B) One parent or another person, who is not an adoption agency, con-
4 senting to the adoption as required under ORS 109.321 (1) **or section 19 of**
5 **this 2021 Act** resided in this state for at least six consecutive months in-
6 cluding periods of temporary absence;

7 “(C) The prospective adoptive parent resided in this state for at least six
8 consecutive months including periods of temporary absence and substantial
9 evidence is available in this state concerning the present or future care of
10 the minor child;

11 “(D) It appears that no court of another state would have jurisdiction
12 under circumstances substantially in accordance with subparagraphs (A) to
13 (C) of this paragraph; or

14 “(E) A court of another state has declined to exercise jurisdiction on the
15 grounds that this state is a more appropriate forum to hear a petition for
16 adoption of the minor child and it is in the best interests of the minor child
17 that a court of this state assume jurisdiction.

18 “(b) As used in paragraph (a) of this subsection, ‘periods of temporary
19 absence’ means periods of absence of not more than a total of 30 days in the
20 prior six consecutive months.

21 “(5) In a petition to adopt a minor child, venue lies in the Oregon county
22 with which the child has the most significant connection or in the Oregon
23 county in which the licensed adoption agency is located.

24 “(6) A petition for adoption of a minor child must comply with the re-
25 quirements, and be served in the manner, described in ORS 109.315.

26 “(7)(a) In a proceeding for the adoption of a minor child, a current home
27 study must be approved by either the Department of Human Services or an
28 Oregon licensed adoption agency for the purpose of demonstrating that the
29 petitioner meets the minimum standards for adoptive homes as set forth in
30 the department’s administrative rules.

1 “(b) **Except when the court finds that there is reason to know that**
2 **the child is an Indian child,** the department, upon request by the
3 petitioner, may waive the home study requirement in an adoption proceeding
4 in which one of the child’s biological parents or adoptive parents retains
5 parental rights, or when a relative who qualifies under the department’s ad-
6 ministrative rules for a waiver of the home study requirement is the pro-
7 spective adoptive parent.

8 “(c) The department shall, subject to ORS 109.306, adopt rules to imple-
9 ment the provisions of this subsection.

10 “(8)(a)(A) Within 90 days after service upon the Director of Human Ser-
11 vices as required under ORS 109.315, the Department of Human Services
12 shall investigate and file for the consideration of the judge before whom the
13 petition for adoption is pending a placement report containing information
14 regarding the status of the child and evidence concerning the suitability of
15 the proposed adoption. The department may designate an Oregon licensed
16 adoption agency to investigate and report to the court. If the department
17 designates an Oregon licensed adoption agency to investigate and report to
18 the court, the department shall make the designation and provide all neces-
19 sary information and materials to the Oregon licensed adoption agency no
20 later than 30 days after the service on the director and upon receipt of all
21 required documentation and fees.

22 “(B) **Except when the court finds that there is reason to know that**
23 **the child is an Indian child,** the department:

24 “(i) May waive the placement report requirement under this subsection;
25 [*but*] **and**

26 “(ii) Shall waive the placement report requirement in an adoption pro-
27 ceeding in which one of the child’s biological parents or adoptive parents
28 retains parental rights.

29 “(b) Upon receipt of a written request by the petitioner or the petitioner’s
30 attorney, the department shall furnish to the petitioner or the petitioner’s

1 attorney copies of any information that the department has filed with the
2 court.

3 “(c) Information gathered by the department or by an Oregon licensed
4 adoption agency during the preparation of the placement report may include
5 information concerning the child’s social, medical and genetic history and
6 the birth parent’s history as may be required by ORS 109.321 or 109.342 **or**
7 **section 19 of this 2021 Act.**

8 “(d) The court shall file and retain the placement report filed under this
9 subsection in the same location in the records, papers and files in the court’s
10 record of the adoption case as the petition and exhibits filed under ORS
11 109.315 are located. The placement report must be segregated from the
12 Adoption Summary and Segregated Information Statement and the exhibits
13 submitted under ORS 109.317.

14 “(e) The department shall, subject to ORS 109.306, adopt rules to imple-
15 ment the provisions of this subsection.

16 “(9) The department may charge the petitioner a fee for investigating a
17 proposed nonagency adoption and preparing the home study required under
18 subsection (7) of this section and the placement report required under sub-
19 section (8) of this section. The petitioner shall report the fee amount to the
20 court. The court granting the adoption shall make a finding as to whether
21 the fee is necessary and reasonable. Any fee charged may not exceed rea-
22 sonable costs for investigation, home study and placement report prepara-
23 tion. The department shall prescribe by rule the procedure for computing the
24 investigation, home study and placement report preparation fee. The rules
25 shall provide a waiver of either part or all of the fee based upon the
26 petitioner’s ability to pay.

27 “(10) The court may not rule upon a petition for the adoption of a minor
28 child until at least 90 days after the date that the petition and documents
29 required to be served on the Director of Human Services under ORS 109.315
30 and 109.317 have been served upon the director. The department may waive

1 the 90-day waiting period.

2 “(11) The amounts of any fees collected under subsection (9) of this sec-
3 tion are continuously appropriated to the department for use in preparing
4 home studies and placement reports required under this section.

5 “(12)(a) Except as provided in paragraph (b) of this subsection, a court
6 may not grant a judgment for the adoption of a minor child unless the
7 petitioner has filed with the court:

8 “(A) A petition, including exhibits attached to the petition, meeting the
9 requirements of ORS 109.315;

10 “(B) Written evidence that a home study has been completed and ap-
11 proved, unless waived, under subsection (7) of this section;

12 “(C) A placement report under subsection (8) of this section unless
13 waived; and

14 “(D) The Adoption Summary and Segregated Information Statement under
15 ORS 109.317, including exhibits attached to the statement.

16 “(b) **Except when the court finds that there is reason to know that**
17 **child is an Indian child**, a person is not required to file a home study or
18 a placement report with the court when the department has granted the
19 person a waiver under department rules.

20 “[*(13) The adoption shall comply with the Indian Child Welfare Act (25*
21 *U.S.C. 1901 et seq.), if applicable.*]

22 “(13) **When the court conducts a hearing under ORS 109.304 to**
23 **109.410 regarding the adoption of a minor child, the court shall make**
24 **the inquiries described in section 15 (4)(b), chapter 14, Oregon Laws**
25 **2020 (first special session), and make a finding and order subject to the**
26 **procedures under section 15 (4), chapter 14, Oregon Laws 2020 (first**
27 **special session), regarding whether there is reason to know that the**
28 **child is an Indian child.**

29 “**SECTION 3.** Section 9, chapter 14, Oregon Laws 2020 (first special ses-
30 sion), is amended to read:

1 “**Sec. 9.** In any **child custody** proceeding [*under*] **based on allegations**
2 **that an Indian child is within the jurisdiction of the court under ORS**
3 **109.304 to 109.410 or** ORS chapter 419B [*involving an Indian child*], the [*ju-*
4 *venile*] court must determine the residence and domicile of the Indian child
5 and whether the Indian child is a ward of tribal court. The [*juvenile*] court
6 shall communicate with any tribal courts to the extent necessary to make a
7 determination under this section.

8 “**SECTION 4.** Section 13, chapter 14, Oregon Laws 2020 (first special
9 session), is amended to read:

10 “**Sec. 13.** (1) Except as provided in subsection (5) of this section, the [*ju-*
11 *venile*] court shall transfer a **child custody** proceeding under **ORS 109.304**
12 **to 109.410 or** ORS chapter 419B involving an Indian child if, at any time
13 during the proceeding, the Indian child’s parent, Indian custodian or tribe
14 petitions the court to transfer the proceeding to the tribal court.

15 “(2) Upon receipt of a transfer motion, the [*juvenile*] court shall contact
16 the Indian child’s tribe and request a timely response regarding whether the
17 tribe intends to decline the transfer.

18 “[(3) A party may object to the transfer motion on the basis of one of the
19 following:]

20 “**(3) Transfer of the proceeding is inappropriate if:**

21 “(a) [*That*] The Indian child’s tribe has declined the transfer;

22 “(b) [*That*] One or both of the Indian child’s parents object to the trans-
23 fer; or

24 “(c) [*That*] Good cause exists to deny the transfer.

25 “(4)(a) If a party objects to the transfer motion for good cause, the court
26 shall fix the time for hearing on objections to the motion.

27 “(b) At the hearing, the objecting party has the burden of proof of estab-
28 lishing by clear and convincing evidence that good cause exists to deny the
29 transfer.

30 “(c) If the Indian child’s tribe contests the assertion that good cause ex-

1 ists to deny the transfer, the court shall give the tribe’s argument substantial
2 weight.

3 “(d) When making a determination whether good cause exists to deny the
4 transfer motion, the [*juvenile*] court may not consider:

5 “(A) Whether the proceeding is at an advanced stage;

6 “(B) Whether there has been a prior proceeding involving the Indian child
7 in which a transfer motion was not filed;

8 “(C) Whether the transfer could affect the placement of the Indian child;

9 “(D) The Indian child’s cultural connections with the tribe or the tribe’s
10 reservation;

11 “(E) The socioeconomic conditions of the Indian child’s tribe or any neg-
12 ative perception of tribal or United States Bureau of Indian Affairs’ social
13 services or judicial systems; or

14 “(F) Whether the transfer serves the best interests of the Indian child.

15 “(5)(a) The court shall deny the transfer motion if:

16 “(A) The tribe declines the transfer orally on the record or in writing;

17 “(B) The Indian child’s parent objects to the transfer; or

18 “(C) The court finds by clear and convincing evidence, after hearing, that
19 good cause exists to deny the transfer.

20 “(b) Notwithstanding paragraph (a)(B) of this subsection, the objection
21 of the Indian child’s parent does not preclude the transfer if:

22 “(A) The objecting parent dies or the objecting parent’s parental rights
23 are terminated and have not been reinstated under ORS 419B.532; and

24 “(B) The Indian child’s remaining parent, Indian custodian or tribe files
25 a new transfer motion subsequent to the death of the objecting parent or the
26 termination of the parental rights of the objecting parent.

27 “(6) If the [*juvenile*] court denies a transfer under this section, the court
28 shall document the basis for the denial in a written order.

29 **“SECTION 5.** Section 14, chapter 14, Oregon Laws 2020 (first special
30 session), is amended to read:

1 “**Sec. 14.** Upon granting a transfer motion under section 13, **chapter 14,**
2 **Oregon Laws 2020 (first special session)** [*of this 2020 special session Act*],
3 the [*juvenile*] court shall expeditiously:

4 “(1) Notify the tribal court of the pending dismissal of the **child custody**
5 proceeding;

6 “(2) Transfer all information regarding the proceeding, including [*but not*
7 *limited to*] pleadings and court records, to the tribal court;

8 “(3) **If the Indian child is alleged to be within the jurisdiction of the**
9 **juvenile court under ORS 419B.100,** direct the Department of Human Ser-
10 vices to:

11 “(a) Coordinate with the tribal court and the Indian child’s tribe to en-
12 sure that the transfer of the proceeding and the transfer of custody of the
13 Indian child is accomplished with minimal disruption of services to the In-
14 dian child and the Indian child’s family; and

15 “(b) Provide the Indian child’s tribe with documentation related to the
16 Indian child’s eligibility for state and federal assistance and information re-
17 lated to the Indian child’s social history, treatment diagnosis and services
18 and other relevant case and service related data; and

19 “(4) Dismiss the proceeding upon confirmation from the tribal court that
20 the tribal court received the transferred information.

21

22 “(**Inquiry; Verification; ICWA Compliance Reports**)

23

24 “**SECTION 6. Section 7 of this 2021 Act is added to and made a part**
25 **of ORS 109.304 to 109.410.**

26 “**SECTION 7. (1) In a proceeding for the adoption or readoption of**
27 **a minor child, within 90 days after service of a petition or amended**
28 **petition upon the Director of Human Services as required under ORS**
29 **109.315 or 109.385, the Department of Human Services shall file with**
30 **the court an ICWA compliance report. The ICWA compliance report**

1 must reflect the department's review of the petition or amended peti-
2 tion and must advise the court on whether the documentation sub-
3 mitted by the petitioner is sufficient and complete for the court to
4 make the findings required under subsection (2) of this section. Noth-
5 ing in this subsection or subsection (3) of this section requires the
6 department to make a determination of law regarding the documen-
7 tation provided by the petitioner.

8 “(2)(a) Upon receiving an ICWA compliance report, the court shall
9 order the matter to proceed if the court finds that the petitioner sat-
10 isfied the inquiry requirements under section 15 (2), chapter 14, Oregon
11 Laws 2020 (first special session), and, if applicable, the notice require-
12 ments under section 16 (2), chapter 14, Oregon Laws 2020 (first special
13 session).

14 “(b)(A) If the court finds, subject to the procedures under section
15 15 (4), chapter 14, Oregon Laws 2020 (first special session), that there
16 is reason to know that the child is an Indian child, the court's order
17 under this subsection must include a finding regarding whether the
18 proposed adoptive placement complies with the preferences under
19 section 23 (2), chapter 14, Oregon Laws 2020 (first special session). If
20 the court finds that the proposed adoptive placement does not comply
21 with the preferences or that the documentation provided by the
22 petitioner is insufficient for the court to make a finding, the court
23 shall direct the petitioner to amend the petition to cure the deficiency
24 or file a motion under section 23 (3), chapter 14, Oregon Laws 2020
25 (first special session), for authority to make the placement contrary
26 to the placement preferences under section 23 (2), chapter 14, Oregon
27 Laws 2020 (first special session).

28 “(B) If the court finds that the petitioner failed to satisfy the in-
29 quiry or, if applicable, the notice requirements under sections 15 (2)
30 and 16 (2), chapter 14, Oregon Laws 2020 (first special session), or if the

1 **documentation supplied by the petitioner is insufficient for the court**
2 **to make those findings, the court shall direct the petitioner to cure**
3 **the inquiry or notice deficiency and file an amended petition.**

4 **“(c) The court shall order the petitioner to appear and show cause**
5 **why the court should not dismiss the petition if the court directs the**
6 **petitioner to file an amended petition or a motion under paragraph (b)**
7 **of this subsection and the petitioner fails to do so within a reasonable**
8 **amount of time.**

9 **“(3)(a) The department shall, by rule, provide a nonexhaustive de-**
10 **scription of the documentation that petitioners or moving parties in**
11 **proceedings under ORS 109.304 to 109.410 may submit to the court to**
12 **document compliance with the inquiry and notice requirements under**
13 **sections 15 (2) and (4) and 16 (2) and (3), chapter 14, Oregon Laws 2020**
14 **(first special session), and the placement preferences under section 23,**
15 **chapter 14, Oregon Laws 2020 (first special session), including:**

16 **“(A) Descriptions of the consultations the petitioner or moving**
17 **party made with the individuals described in section 15 (2), chapter 14,**
18 **Oregon Laws 2020 (first special session), and the responses the**
19 **petitioner or moving party obtained;**

20 **“(B) Descriptions of any oral responses and copies of any written**
21 **responses the petitioner or moving party obtained from the individuals**
22 **described in section 15 (2) or 16 (3), chapter 14, Oregon Laws 2020 (first**
23 **special session);**

24 **“(C) Copies of any identification cards or other records indicating**
25 **the membership of the child or the child’s parent in an Indian tribe;**

26 **“(D) Copies of any tribal court records regarding the Indian child;**

27 **“(E) Any reports, declarations or testimony on the record docu-**
28 **menting the due diligence of the petitioner or moving party to identify**
29 **and work with all of the tribes of which the petitioner or moving party**
30 **has reason to know that the child may be a member or in which the**

1 **child may be eligible for membership; and**

2 **“(F) The declaration of compliance regarding the section 16 (2),**
3 **chapter 14, Oregon Laws 2020 (first special session), notices the**
4 **petitioner sent, as described in ORS 109.315 (5)(d) and 109.385 (7)(b).**

5 **“(b) The department shall adopt any other rules for the preparation**
6 **of ICWA compliance reports that are necessary for the department to**
7 **carry out the department’s duties under ORS 109.304 to 109.410.**

8 **“(c) The State Court Administrator may prepare and make available**
9 **to the public forms and information to assist petitioners to comply**
10 **with the requirements under this section, ORS 109.315 and 109.385 and**
11 **sections 15 (2), 16 (2) and (3) and 23 (2) and (3), chapter 14, Oregon Laws**
12 **2020 (first special session), and any related rules, including:**

13 **“(A) Forms of petitions required under ORS 109.315 and 109.385,**
14 **motions to request a deviation from the placement preferences under**
15 **section 23 (3), chapter 14, Oregon Laws 2020 (first special session), and**
16 **notices required under section 16 (2), chapter 14, Oregon Laws 2020**
17 **(first special session); and**

18 **“(B) Worksheets and checklists to assist petitioners with the in-**
19 **quiry required under section 15 (2), chapter 14, Oregon Laws 2020 (first**
20 **special session), the notices required under section 16 (2), chapter 14,**
21 **Oregon Laws 2020 (first special session), and assessing whether pro-**
22 **posed adoptive placements satisfy the preferences under section 23 (2),**
23 **chapter 14, Oregon Laws 2020 (first special session).**

24 **“(d) The Judicial Department may design and offer trainings to**
25 **courts having jurisdiction over adoption matters regarding the appli-**
26 **cation of sections 1 to 23, chapter 14, Oregon Laws 2020 (first special**
27 **session), to adoptions of minor children, including but not limited to**
28 **identifying when there is reason to know that the child is an Indian**
29 **child and making findings regarding the sufficiency of inquiry and**
30 **notice and the appropriateness of adoptive placements.**

1 **“SECTION 8.** ORS 109.315 is amended to read:

2 “109.315. (1) A petition for adoption of a minor child must be signed by
3 the petitioner and, unless stated in the petition why the information or
4 statement is omitted, must contain the following:

5 “(a) The full name of the petitioner;

6 “(b) The state and length of residency in the state of the petitioner and
7 information sufficient to establish that the residency requirement of ORS
8 109.309 (2) has been met;

9 “(c) The current marital or domestic partnership status of the petitioner;

10 “(d) An explanatory statement as to why the petitioner is of sufficient
11 ability to bring up the minor child and furnish suitable nurture and educa-
12 tion sufficient for judgment to be entered under ORS 109.350;

13 “(e) Information sufficient for the court to establish that the petitioner
14 has complied with the jurisdictional and venue requirements of ORS 109.309
15 (4) and (5);

16 “(f) The full name, gender and date and place of birth of the minor child;

17 “(g) The marital or domestic partnership status of the biological mother
18 at the time of conception, at the date of birth and during the 300 days prior
19 to the date of birth of the minor child;

20 “*[(h) A statement that the minor child is not an Indian child as defined*
21 *in the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) or, if the Indian Child*
22 *Welfare Act applies:]*

23 “*[(A) A statement of the efforts to notify the appropriate Indian tribe or*
24 *tribes of the adoption; and]*

25 “*[(B) A statement of the efforts to comply with the placement preferences*
26 *of the Indian Child Welfare Act or the placement preferences of the appropri-*
27 *ate Indian tribe;]*

28 **“(h) A declaration under penalty of perjury and documentation, as**
29 **described by the Department of Human Services by rule, of the**

19 **ORS 419C.626 or ORS chapter 109, 418, 419A or 419B in which the legal**
20 **custody or physical custody of an Indian child is an issue.**

21 **“(b) ‘Child custody proceeding’ does not include:**

22 **“(A) A proceeding for the custody or support of, or parenting time**
23 **with, a child under ORS 109.100, 109.103 or 109.119; or**

24 **“(B) An emergency proceeding.**

25 **“[(1)] (2) ‘Emergency proceeding’ means any court action that involves the**
26 **emergency removal or emergency placement of an Indian child, including**
27 **removal under ORS 419B.150, with or without a protective custody order, or**
28 **a shelter care proceeding under ORS 419B.185.**

29 **“[(2)(a)] (3)(a) ‘Extended family member’ has the meaning given that term**
30 **by the law or custom of an Indian child's tribe.**

1 “(b) If the meaning of ‘extended family member’ cannot be determined
2 under paragraph (a) of this subsection, ‘extended family member’ means a
3 person who has attained 18 years of age and who is the Indian child’s
4 grandparent, aunt, uncle, brother, sister, sister-in-law, brother-in-law, niece,
5 nephew, first cousin, second cousin, stepparent or, as determined by the In-
6 dian child’s tribe, clan or band member.

7 “[3] (4) ‘Indian’ means a person who is a member of an Indian tribe or
8 who is an Alaska Native and a member of a regional corporation as defined
9 in section 7 of the Alaska Native Claims Settlement Act (43 U.S.C. 1606).

10 “[4] (5) ‘Indian child’ means any unmarried person who has not attained
11 18 years of age and:

12 “(a) Is a member or citizen of an Indian tribe; or

13 “(b) Is eligible for membership or citizenship in an Indian tribe and is the
14 biological child of a member of an Indian tribe.

15 “[5] (6) ‘Indian custodian’ means an Indian, other than the Indian child’s
16 parent, who has custody, as described in section 3 (1), **chapter 14, Oregon**
17 **Laws 2020 (first special session)** [*of this 2020 special session Act*], of the
18 Indian child, or to whom temporary physical care, custody and control has
19 been transferred by the Indian child’s parent.

20 “[6] (7) ‘Indian tribe’ or ‘tribe’ means any Indian tribe, band, nation or
21 other organized group or community of Indians federally recognized as eli-
22 gible for the services provided to Indians by the United States Secretary of
23 the Interior because of their status as Indians, including any Alaska Native
24 village as defined in 43 U.S.C. 1602(c).

25 “[7] (8) ‘Juvenile court’ has the meaning given that term in ORS
26 419A.004.

27 “[8] (9) ‘Member’ or ‘membership’ means a determination by an Indian
28 tribe that a person is a member or citizen in that Indian tribe.

29 “[9] (10) ‘Parent’ means:

30 “(a) A biological parent of an Indian child;

1 “(b) An Indian who has lawfully adopted an Indian child, including
2 adoptions made under tribal law or custom; or

3 “(c) A father whose parentage has been acknowledged or established un-
4 der **ORS 109.065** or section 4, **chapter 14, Oregon Laws 2020 (first special**
5 **session)** [*of this 2020 special session Act*].

6 “[~~(10)~~] **(11)** ‘Party’ or ‘parties’ means parties to a proceeding, as described
7 in ORS 419B.875.

8 “[~~(11)~~] **(12)** ‘Reservation’ means Indian country as defined in 18 U.S.C.
9 1151 and any lands not covered under that section, title to which is held by
10 the United States in trust for the benefit of an Indian tribe or individual or
11 held by an Indian tribe or individual subject to a restriction by the United
12 States against alienation.

13 “[~~(12)~~] **(13)** ‘Tribal court’ means a court with jurisdiction over child cus-
14 tody proceedings and that is either a Court of Indian Offenses, a court es-
15 tablished and operated under the code or custom of an Indian tribe or any
16 other administrative body of a tribe that is vested with authority over child
17 custody proceedings.

18 **“SECTION 12.** Section 8, chapter 14, Oregon Laws 2020 (first special
19 session), is amended to read:

20 **“Sec. 8. (1) In a child custody proceeding in which an Indian child is**
21 **alleged to be within the jurisdiction of the court** under ORS chapter **109,**
22 **418, 419A or 419B** [*when there is reason to know that the child is an Indian*
23 *child*], the Indian child’s tribe is:

24 “(a) If the Indian child is a member of or is eligible for membership in
25 only one tribe, the tribe of which the Indian child is a member or eligible
26 for membership.

27 “(b) If the Indian child is a member of one tribe but is eligible for mem-
28 bership in one or more other tribes, the tribe of which the Indian child is a
29 member.

30 “(c) If the Indian child is a member of more than one tribe or if the Indian

1 child is not a member of any tribe but is eligible for membership with more
2 than one tribe:

3 “(A) The tribe designated by agreement between the tribes of which the
4 Indian child is a member or in which the Indian child is eligible for mem-
5 bership; or

6 “(B) If the tribes are unable to agree on the designation of the Indian
7 child’s tribe, the tribe designated by the court.

8 “(2) When designating an Indian child’s tribe under subsection (1)(c)(B)
9 of this section, the court shall, after hearing, designate the tribe with which
10 the Indian child has the more significant contacts, taking into consideration
11 the following:

12 “(a) The preference of the Indian child’s parent;

13 “(b) The duration of the Indian child’s current or prior domicile or resi-
14 dence on or near the reservation of each tribe;

15 “(c) The tribal membership of the Indian child’s custodial parent or Indian
16 custodian;

17 “(d) The interests asserted by each tribe;

18 “(e) Whether a tribe has previously adjudicated a case involving the In-
19 dian child; and

20 “(f) If the court determines that the Indian child is of sufficient age and
21 capacity to meaningfully self-identify, the self-identification of the Indian
22 child.

23 “[*(3) If an Indian child is a member of or is eligible for membership in*
24 *more than one tribe, the court may, in its discretion, permit a tribe, in addition*
25 *to the Indian child’s tribe determined under subsection (1) of this section, to*
26 *participate in a proceeding under ORS chapter 419B involving the Indian*
27 *child in an advisory capacity or as a party.*]

28 “**SECTION 13.** ORS 419B.875, as amended by section 28, chapter 14,
29 Oregon Laws 2020 (first special session), is amended to read:

30 “419B.875. (1)(a) Parties to proceedings in the juvenile court under ORS

1 419B.100 and 419B.500 are:

2 “(A) The child or ward;

3 “(B) The parents or guardian of the child or ward;

4 “(C) A putative father of the child or ward who has demonstrated a direct
5 and significant commitment to the child or ward by assuming, or attempting
6 to assume, responsibilities normally associated with parenthood, including
7 but not limited to:

8 “(i) Residing with the child or ward;

9 “(ii) Contributing to the financial support of the child or ward; or

10 “(iii) Establishing psychological ties with the child or ward;

11 “(D) The state;

12 “(E) The juvenile department;

13 “(F) A court appointed special advocate, if appointed;

14 “(G) The Department of Human Services or other child-caring agency if
15 the agency has temporary custody of the child or ward; and

16 “(H) [*In cases where there is reason to know, as described in section 15,*

21 “(b) An intervenor who is granted intervention under ORS 419B.116 is a
22 party to a proceeding under ORS 419B.100. An intervenor under this para-
23 graph is not a party to a proceeding under ORS 419B.500.

24 “(c) **If an Indian child is a member of or is eligible for membership**
25 **in more than one tribe, the court may, in its discretion, permit a tribe,**
26 **in addition to the Indian child’s tribe, to participate in a proceeding**
27 **under this chapter involving the Indian child in an advisory capacity**
28 **or as a party.**

29 “(2) The rights of the parties include, but are not limited to:

30 “(a) The right to notice of the proceeding and copies of the petitions,

1 answers, motions and other papers;

2 “(b) The right to appear with counsel and, except for intervenors under
3 subsection (1)(b) of this section, to have counsel appointed as otherwise
4 provided by law;

5 “(c) The right to call witnesses, cross-examine witnesses and participate

28 “(8) Interpreters for parties and persons granted rights of limited partic-
29 ipation shall be appointed in the manner specified by ORS 45.275 and 45.285.

30 **SECTION 14.** Section 15, chapter 14, Oregon Laws 2020 (first special

1 session), is amended to read:

2 “**Sec. 15.** (1) In an emergency proceeding, the person taking the child into
3 protective custody shall make a good faith effort to:

4 “(a) Determine whether [*there is*] **the person has** reason to know that
5 the child is an Indian child; and [*to*]

6 “(b) Contact by telephone, electronic mail, facsimile or other means of
7 immediate communication any tribe of which the child is or may be a mem-
8 ber to determine the child’s affiliation.

9 “(2) Except as provided in subsection (1) of this section **or if the person**
10 **already knows that a child is an Indian child**, whenever a person is re-
11 quired under ORS chapter **109, 418, 419A or 419B** to determine whether [*there*
12 *is*] **the person has** reason to know that [*a*] **the child is an Indian child**, [*if*
13 *the person has not already determined that the child is an Indian child, the*
14 *person shall make a good faith effort to determine whether there is reason to*
15 *know the child is an Indian child, including by consulting with:*] **the person**
16 **shall make a good faith effort to determine whether the child is an**
17 **Indian child, including, at a minimum, consulting with:**

18 “(a) The child;

19 “(b) The child’s parent or parents;

20 “(c) Any person having custody of the child or with whom the child re-
21 sides;

22 “(d) Extended family members of the child;

23 “(e) Any other person who may reasonably be expected to have informa-
24 tion regarding the child’s membership or eligibility for membership in an
25 Indian tribe; and

26 “(f) Any Indian tribe of which the child may be a member or of which the
27 child may be eligible for membership.

28 “[*(3)(a) At the commencement of any hearing in which the court is required*
29 *to inquire whether a child is an Indian child, the court shall ask, on the re-*
30 *cord, each individual present on the matter whether the individual knows or*

1 *has reason to know that the child is an Indian child.]*

2 “[*b*] *If no individual in the proceeding knows or has reason to know that*
3 *the child is an Indian child, the court shall instruct each party to inform the*
4 *court immediately if the party later receives information that provides reason*
5 *to know the child is an Indian child.]*

6 “[~~4~~] **(3)** A court **or person** has reason to know that a child is an Indian
7 child if:

8 **“(a) The person knows that the child is an Indian child;**

9 **“(b) The court has found that the child is an Indian child or that**
10 **there is reason to know that the child is an Indian child;**

11 “[*a*] **(c)** Any individual present in the proceeding, officer of the court
12 involved in the proceeding, Indian tribe, Indian organization or agency in-

15 involved in the proceeding, **agency**, Indian tribe[,] **or** Indian organization

19 is an Indian child;

20 “[*d*] **(f)** The court **or the person** is informed that the domicile or resi-
21 dence of the child, the child’s parent or the child’s Indian custodian is on a
22 reservation or in an Alaska Native village;

23 “[*e*] **(g)** The court **or the person** is informed that the child is or has
24 been a ward of a tribal court;

25 “[*f*] **(h)** The court **or the person** is informed that the child or the child’s
26 parent possesses an identification card or other record indicating member-

24 “**(b) A consenting parent’s request for anonymity does not relieve**
25 **the court or any party in an adoption proceeding from the duty to**

27 “**SECTION 15.** Section 16, chapter 14, Oregon Laws 2020 (first special
28 session), is amended to read:

29 “**Sec. 16.** (1)(a) In an emergency proceeding, if there is reason to know
30 that a child is an Indian child and the nature of the emergency allows, the

1 Department of Human Services must notify by telephone, electronic mail,
2 facsimile or other means of immediate communication any tribe of which the
3 child is or may be a member.

4 “(b) Notification under this subsection must include the basis for the
5 child’s removal, the time, date and place of the initial hearing and a state-
6 ment that the tribe[, *as a party to the proceeding under ORS 419B.875,*] has
7 the right to participate in the proceeding **as a party or in an advisory**
8 **capacity under ORS 419B.875.**

9 “(2) Except as provided in subsection (1) of this section, if there is reason
10 to know **that** a child [*in a proceeding*] **alleged to be within the court’s**
11 **jurisdiction** under ORS chapter **109, 418, 419A or 419B** is an Indian child
12 and notice is required, the party providing notice must:

13 “(a) Promptly send notice of the proceeding as described in subsection (3)
14 of this section; and

15 “(b) File [*an original or*] a copy of each notice sent under this section
16 with the court, together with any return receipts or other proof of service.

17 “(3) Notice under subsection (2) of this section must:

18 “(a) Be sent to:

19 “(A) Each tribe of which the child may be a member or of which the In-
20 dian child may be eligible for membership;

21 “(B) The child’s parents;

22 “(C) The child’s Indian custodian, if applicable; and

23 “(D) The appropriate United States Bureau of Indian Affairs Regional
24 Director listed in 25 C.F.R. 23.11(b), if the identity or location of the child’s
25 parents, Indian custodian or tribe cannot be ascertained.

26 “(b) Be sent by registered or certified mail, return receipt requested.

27 “(c) Be in clear and understandable language and include the following:

28 “(A) The child’s name, date of birth and place of birth;

29 “(B) To the extent known, all names, including maiden, married and for-
30 mer names or aliases, of the child’s parents, the parents’ birthplaces and

1 tribal enrollment numbers;

2 “(C) To the extent known, the names, dates of birth, places of birth and
3 tribal enrollment information of other direct lineal ancestors of the child;

4 “(D) The name of each Indian tribe [*in*] **of** which the child is a member
5 or [*of*] **in** which the Indian child may be eligible for membership;

6 “(E) If notice is required to be sent to the United States Bureau of Indian
7 Affairs under paragraph (a) of this subsection, to the extent known, infor-
8 mation regarding the child’s direct lineal ancestors, an ancestral chart for
9 each biological parent, and the child’s tribal affiliations and blood quantum;

10 “(F) A copy of the petition **or motion** initiating the proceeding and, if
11 a hearing has been scheduled, information on the date, time and location of
12 the hearing;

13 “(G) The name of the petitioner and the name and address of the
14 petitioner’s attorney;

15 “**(H) In a proceeding under ORS chapter 419B:**

16 “[*H*] (i) A statement that the child’s parent or Indian custodian[, *as a*
17 *party to the proceeding under ORS 419B.875,*] has the right to participate in
18 the proceeding **as a party to the proceeding under ORS 419B.875;**

19 “[*I*] (ii) A statement that the child’s tribe[, *as a party to the proceeding*
20 *under ORS 419B.875,*] has the right to participate in the proceeding **as a**
21 **party or in an advisory capacity under ORS 419B.875;**

22 “[*J*] (iii) A statement that if the court determines that the child’s parent
23 or Indian custodian is unable to afford counsel, the parent or Indian custo-
24 dian has the right to court-appointed counsel; **and**

25 “[*K*] (iv) A statement that the child’s parent, Indian custodian or tribe
26 has the right, upon request, to up to 20 additional days to prepare for the
27 proceeding;

28 “**(I) In a proceeding under ORS 109.304 to 109.410, a statement that**
29 **the child’s tribe may intervene in the proceeding;**

30 “[*L*] (J) A statement that the child’s parent, Indian custodian or tribe

1 has the right to petition the court to transfer the **child custody** proceeding
2 to the tribal court;

3 “[*M*] (**K**) A statement describing the potential legal consequences of the
4 proceeding on the future parental and custodial rights of the parent or In-
5 dian custodian;

6 “[*N*] (**L**) The mailing addresses and telephone numbers of the court and
7 contact information for all parties to the proceeding and individuals notified
8 under this section; and

9 “[*O*] (**M**) A statement that the information contained in the notice is
10 confidential and that the notice should not be shared with any person not
11 needing the information to exercise rights under sections 1 to 23, **chapter**
12 **14, Oregon Laws 2020 (first special session)** [*of this 2020 special session*
13 *Act*].

14 “(4) If there is a reason to know that the Indian child’s parent or Indian
15 custodian has limited English proficiency and may not understand the con-
16 tents of the notice under subsection (2) of this section, the court must pro-
17 vide language access services as required by Title VI of the Civil Rights Act
18 of 1964 and other applicable federal and state laws. If the court is unable to
19 secure translation or interpretation support, the court shall contact or direct
20 a party to contact the Indian child’s tribe or the local office of the United
21 States Bureau of Indian Affairs for assistance identifying a qualified trans-
22 lator or interpreter.

23 “(5)(a) [*No*] **A hearing** [*requiring*] **that requires** notice under subsection
24 (2) of this section may **not** be held until at least 10 days after the [*later*]
25 **latest** of receipt of the notice by the Indian child’s parent, Indian custodian

11 **“Sec. 23.** (1) If [*there is reason to know that a child is an Indian child and*
12 *the child*] **the parental rights of an Indian child’s parents have not been**
13 **terminated and the Indian child** is in need of placement or continuation
14 in substitute care, as defined in ORS 419A.004, except as provided in sub-
15 section [(4)] **(3)** of this section the child must be placed in the least restric-
16 tive setting that:

17 “(a) Most closely approximates a family, taking into consideration sibling
18 attachment;

19 “(b) Allows the Indian child’s special needs, if any, to be met;

20 “(c) Is in reasonable proximity to the Indian child’s home, extended family
21 or siblings; and

22 “(d)(A) Is in accordance with the order of preference established by the
23 Indian child’s tribe; or

24 “(B) If the Indian child’s tribe has not established placement preferences,
25 is in accordance with the following order of preference:

26 “(i) A member of the Indian child’s extended family;

27 “(ii) A foster home licensed, approved or specified by the Indian child’s
28 tribe;

29 “(iii) A foster home licensed or approved by a licensing authority in this
30 state and in which one or more of the licensed or approved foster parents is

1 an Indian; or

2 “(iv) An institution for children that has a program suitable to meet the
3 Indian child’s needs and is approved by an Indian tribe or operated by an
4 Indian organization.

5 “(2) *[If the juvenile court finds that an Indian child is in need of a*
6 *guardianship pursuant to ORS 419B.365 or 419B.366]* **If the parental rights**
7 **of the Indian child’s parents have been terminated or if an Indian child**
8 **is in need of a guardianship pursuant to ORS 419B.365 or 419B.366 or**
9 **adoptive placement**, except as provided in subsection [(4)] (3) of this sec-
10 tion, the Indian child shall be placed:

18 “**(B) Must, in applying the placement preferences under this sub-**
19 **section, give weight to a parent’s request for anonymity if the place-**

22 quest of a parent of the Indian child, [*if*] **after** the parent has reviewed the
23 placement options, if any, that comply with the placement preferences under

9 the Department of Human Services or an approved child-caring agency of
10 this or any other state has placed a minor child with a foster parent, the
11 information required under this paragraph regarding the minor child’s ad-
12 dress, whereabouts or places the minor child has lived during the past five
13 years, as required under ORS 107.767, is limited to the fact that the minor
14 child was placed with a foster parent and the county and state of the lo-
15 cation of the foster care placement, and disclosure of the foster parent’s

2 **part of ORS 109.322 to 109.329.**

3 **“SECTION 19. (1) As used in this section, ‘parent’ has the meaning**

5 **session).**

5 are required, the court must determine whether active efforts have been
6 made to prevent the breakup of the family or to reunite the family.

7 “(3) Active efforts require a higher standard of conduct than reasonable
8 efforts.

10 “(a) Be documented in detail in writing and on the record;

6 “(a) The parents of the child, or the survivor of [~~them~~] **the parents.**

8 a motion and order to show cause on the spouse under subsection (3) of this
9 section is not required and the spouse’s consent, authorization or waiver is
10 not required in adoption proceedings concerning the child unless **the child**
11 **is an Indian child or** the spouse has met the requirements of subsection
12 [*(3)(a), (b) or (c)*] (3)(b)(A), (B) or (C) of this section.

13 “[*(12)*] (15) A spouse who was not cohabiting with the mother at the time
14 of the child’s conception has the primary responsibility to protect the
15 spouse’s rights.

16 “[*(13)*] (16) Nothing in this section shall be used to set aside an act of a
17 permanent nature, including but not limited to adoption, unless the parent
18 establishes, within one year **or, if the child is an Indian child, four years**
19 after the entry of the order or general judgment, as defined in ORS 18.005,

27 of the names and addresses of the petitioners for the adoption if the court

29 **“(2) The preservation of confidentiality under this section does not**
30 **relieve the court or any petitioners in an adoption proceeding from the**

1 **duty to comply with the placement preferences under section 23 (2),**

4 **“SECTION 28.** Section 21, chapter 14, Oregon Laws 2020 (first special

12 **“(2) The preservation of confidentiality under this section does not**
13 **relieve the court or any petitioners in an adoption proceeding from the**
14 **duty to comply with the placement preferences under section 23 (2),**
15 **chapter 14, Oregon Laws 2020 (first special session), if the child is an**
16 **Indian child.**

“(Agency Consent)

20 **“SECTION 29.** ORS 418.270 is amended to read:

21 **“418.270. (1)** If licensed for such purposes by the Department of Human
22 Services, a child-caring agency may receive children from the children’s
23 parents or legal guardians for special, temporary or continued care. **Upon**
24 **receiving a child under this section, the agency shall make inquiries,**
25 **as described in section 15 (2), chapter 14, Oregon Laws 2020 (first spe-**
26 **cial session), to determine whether there is reason to know that the**
27 **child is an Indian child.** The parents or guardians may sign releases or
28 surrenders giving to the agency guardianship and control of the children
29 during the period of care, which may be extended until the children arrive
30 at legal age. Releases do not surrender the rights of parents or guardians in

1 respect to the adoption of children and do not entitle the agency to give
2 consent to the adoption of the children unless the release or surrender ex-
3 pressly recites that the release or surrender is given for the purpose of
4 adoption. Child-caring agencies are authorized to place children for adoption
5 or family foster care only if authorized by the department in the license is-
6 sued by the department to the agency.

7 “(2) Severance of family ties with children by adoption or otherwise may

5 “(a) One of the following has occurred:

6 “(A) A juvenile court that is a circuit court has entered an order of per-
7 manent commitment of a ward to the Department of Human Services under
8 ORS 419B.527; or

9 “(B) The parent has signed and the department has accepted a release and
10 surrender to the department, and the parent has signed[:]

11 “[(i)] a certificate of irrevocability and waiver as provided in ORS 418.270
12 regarding a child; [or]

13 “[(ii) *A certificate of waiver under the Indian Child Welfare Act regarding*

1 “(e) At the time the placement report is filed under paragraph (d) of this
2 subsection, the prospective adoptive parent files the adoption report form
3 required under ORS 109.400.

4 **“(2) If the child is an Indian child, a parent’s release, surrender or
5 certificate of irrevocability and waiver under subsection (1)(a) of this
6 section must meet the following requirements:**

7 **“(a) The court explained to the parent, on the record in detail and
8 in the language of the parent, the parent’s right to legal counsel, the
9 terms and consequences of the release, surrender or certificate of
10 irrevocability and waiver and informed the parent that the parent may
11 revoke the release, surrender or certificate of irrevocability and waiver

23 adoptive parent is required to file an Adoption Summary and Segregated In-
24 formation Statement with accompanying exhibits as provided under ORS
25 109.317.**

26 **“[(3)] (4) Notwithstanding ORS 21.135, the clerk of the juvenile court may
27 not charge or collect first appearance fees for a proceeding under this sec-
28 tion.**

29 **“[(4)(a)] (5)(a) After the filing of written evidence of a home study and
30 the placement report requesting the court to enter a judgment of adoption,**

1 the juvenile court that entered the order of permanent commitment, or the
2 juvenile court having jurisdiction over a ward for whom the department has
3 accepted a release and surrender and a certificate **and waiver** signed by the

14 **“SECTION 31. Sections 32 and 33 of this 2021 Act are added to and**
15 **made a part of ORS 109.304 to 109.410.**

16 **“SECTION 32. (1) As used in this section:**

17 **“(a) ‘Former parent’ means a person who was previously the legal**
18 **parent of an Indian child subject to a judgment of adoption under ORS**
19 **109.350 or 419B.529 and whose parental rights have not been restored**
20 **under section 33 or 39 of this 2021 Act.**

21 **“(b) ‘Prior Indian custodian’ means a person who was an Indian**
22 **child’s Indian custodian before entry of a judgment of adoption of the**
23 **child under ORS 109.350 or 419B.529.**

24 **“(2) If a judgment of adoption of an Indian child under ORS 109.350**

14 court must explain to the former parent or prior Indian custodian, on
15 the record in detail and in the language of the former parent or prior
16 Indian custodian:

17 “(A) The former parent’s right to legal counsel, if applicable;

18 “(B) The terms and consequences of the waiver; and

19 “(C) How the waiver may be revoked.

20 “(c) After execution of the waiver, the court shall certify that it

13 together with notice of proceeding in the form required under section
14 16 (3), chapter 14, Oregon Laws 2020 (first special session), to:

15 “(i) Each tribe of which the child may be a member or in which the
16 Indian child may be eligible for membership;

17 “(ii) The child's parents;

18 “(iii) The child's Indian custodian, if applicable; and

28 of the former parent or prior Indian custodian or restore the parental
29 rights to the Indian child unless the court finds, by clear and con-
30 vincing evidence, that the return of custody or restoration of parental

1 **rights is not in the child’s best interests, as described in section 5,**
2 **chapter 14, Oregon Laws 2020 (first special session). The court’s order**
3 **must include a transition plan for the physical custody of the child,**
4 **which may include protective supervision under ORS 419B.331.**

5 **“SECTION 33. (1) A petition to vacate a judgment of adoption of**
6 **an Indian child under ORS 109.350 or 419B.529 may be filed in a state**
7 **or local court of competent jurisdiction by a parent who consented to**
8 **the adoption.**

9 **“(2) Upon the filing of a petition under this section, the court shall**
10 **set a time for a hearing on the petition and provide notice of the pe-**

30 placement preferences under section 23, chapter 14, Oregon Laws 2020

1 (first special session); or

2 “(ii) If the placement does not comply with the placement prefer-

20 **the court’s order must include a transition plan for the physical cus-**
21 **tody of the child, which may include protective supervision under ORS**
22 **419B.331.**

23 “**(c) If the vacated order or judgment terminated parental rights,**
24 **the court shall order the previously terminated parental rights to be**

26 “**(d) If the state or any other party affirmatively asks the court to**

10 *improperly removed, the court shall terminate the proceeding and order the*
11 *Department of Human Services to immediately return the Indian child to the*
12 *Indian child’s parent or Indian custodian, unless the court determines by clear*
13 *and convincing evidence that doing so would subject the Indian child to sub-*
14 *stantial and immediate danger or a threat of substantial and immediate dan-*
15 *ger.]*

16 **“SECTION 38. Section 39 of this 2021 Act is added to and made a**
17 **part of sections 1 to 23, chapter 14, Oregon Laws 2020 (first special**
18 **session).**

19 **“SECTION 39. (1) The juvenile court, on the court’s own motion or**
20 **on the motion of any party, shall expeditiously determine whether an**

2 “(4) After entry of judgment in an adoption proceeding and after the mi-
3 nor child who is the subject of the adoption proceeding has attained 18 years
4 of age, the following may inspect and copy sealed records, papers and files
5 that are maintained in the court’s record of the adoption case without a
6 court order:

7 “(a) Judges of the court operating under the Judicial Department and
8 court staff or other persons operating under the direction of the judges;

9 “(b) The person who was the minor child in the adoption proceeding, ex-

6 “(iii) A report of adoption on a form prescribed and furnished by the State

7 Registrar of the Center for Health Statistics under ORS 432.223 or a similar

8 document in which the court has certified to the state registrar the facts of

9 the live birth of the person adopted;

10 “(iv) A medical history described in ORS 109.342 or a similar document

11 provided to the court for the purpose of describing the medical history of the

12 minor child or of the biological parents; and

13 “(v) Addresses, phone numbers and Social Security numbers of persons

14 or entities described in ORS 109.317 (1)(a) to (d) that are contained in the

15 court’s record of the adoption case.

16 “(c) If the Department of Human Services consented or has the authority

17 to consent to the adoption of a minor child under ORS 109.325 or 419B.529:

18 “(A) A parent who has signed a release and surrender to the department

19 under ORS 418.270, that was accepted by the department, or whose parental

20 rights were terminated under ORS 419B.500 and 419B.502 to 419B.524, may

21 file a motion with the court to inspect or copy sealed records, papers and

22 files that are maintained in the court’s record of the adoption case but may

23 not be granted the right to inspect or copy:

24 “(i) For adoption cases filed on or after January 1, 2014:

25 “(I) The Adoption Summary and Segregated Information Statement filed

26 in accordance with ORS 109.317; and

27 “(II) Exhibits described in ORS 109.317 (2) that are contained in the

28 court’s record of the adoption case.

29 “(ii) For adoption cases filed before January 1, 2014:

30 “(I) Statements, exhibits and other documents provided for purposes of the

1 Uniform Child Custody Jurisdiction and Enforcement Act pursuant to ORS
2 109.767;

3 “(II) A home study;

4 “(III) A report of adoption on a form prescribed and furnished by the
5 State Registrar of the Center for Health Statistics under ORS 432.223 or a
6 similar document in which the court has certified to the state registrar the
7 facts of the live birth of the person adopted; and

8 “(IV) A medical history described in ORS 109.342 or a similar document
9 provided to the court for the purpose of describing the medical history of the
10 minor child or of the biological parents.

11 “(B)(i) The court may grant the motion for good cause. The name, address,
12 phone number, Social Security number or other identifying information of
13 any individual or entity contained in the records, papers and files must be
14 redacted and may not be disclosed as part of the inspection or copying al-

28 *ORS 109.065,]* A man’s parentage of an Indian child is acknowledged or es-
29 tablished for purposes of **ORS 109.304 to 109.410, ORS chapter 419B and**
30 **sections 1 to 23, chapter 14, Oregon Laws 2020 (first special session),**

1 [of this 2020 special session Act and ORS chapter 419B] if the man’s parent-
2 age has been:

3 **“(a) Established under ORS 109.065;**

4 **“[(1)] (b) Established under tribal law;**

5 **“[(2)] (c) Recognized in accordance with tribal custom; or**

6 **“[(3)] (d) [*Openly proclaimed*] Subject to subsection (2) of this section,**
7 **acknowledged orally or in writing** by the man to the court, [*to the Indian*
8 *child’s family,*] to the Department of Human Services or to an Oregon li-
9 censed adoption agency.

10 **“(2)(a) If a man acknowledges paternity of an Indian child as pro-**
11 **vided in subsection (1)(d) of this section, the department or the**
12 **adoption agency must notify the court of the man’s acknowledgement**
13 **immediately or, if a matter is not yet pending in this state, imme-**
14 **diately upon filing a petition or being served with a copy of a petition**
15 **alleging that the child is within the jurisdiction of the court under**

11 **putative** father to surrender the child as provided in ORS 418.270 or to

15 “**SECTION 44.** ORS 109.096 is amended to read:

16 “109.096. (1) When the parentage of a child has not been established under
17 ORS 109.065 **or has not been established or acknowledged under section**
18 **4, chapter 14, Oregon Laws 2020 (first special session),** the putative fa-
19 ther is entitled to reasonable notice in adoption or other court proceedings
20 concerning the custody of the child, except for juvenile court proceedings,
21 if the petitioner knows, or by the exercise of ordinary diligence should have

23 “(a) That the child resided with the putative father at any time during
24 the 60 days immediately preceding the initiation of the proceeding, or at any

13 **der section 16 (2), chapter 14, Oregon Laws 2020 (first special session).**

14 **“(3)** When appropriate, the court shall inform a person before the court
15 claiming to be the parent of a child or ward that parentage establishment

22 **“(b)** ‘Child born out of wedlock’ has the meaning given that term in ORS
23 109.124.

24 **“(c)** ‘Legal parent’ has the meaning given that term in ORS 419A.004 (19).

25

26 **“OREGON INDIAN CHILD WELFARE**

27

28 **“SECTION 47.** Section 7, chapter 14, Oregon Laws 2020 (first special
29 session), is amended to read:

30 **“Sec. 7.** (1) Unless an Indian child’s parent objects, the Department of

1 Human Services shall provide assistance with enrolling an Indian child
2 within the juvenile court's jurisdiction under ORS 419B.100 in a tribe with
3 which the child is eligible for enrollment.

4 “(2) In any **child custody** proceeding under ORS chapter 419B, [*where*
5 *there is*] **when the department determines the department has** reason to
6 know **that** the child is an Indian child, and **if** the department reasonably
7 believes that the Indian child is eligible for enrollment in a tribe, the de-
8 partment shall notify the Indian child's parent of the parent's right to object
9 to the department's assistance under subsection (1) of this section.

10 **“SECTION 48.** Section 3, chapter 14, Oregon Laws 2020 (first special
11 session), is amended to read:

12 **“Sec. 3.** (1) An individual has custody of an Indian child under sections
13 1 to 23, **chapter 14, Oregon Laws 2020 (first special session)**, [*of this 2020*
14 *special session Act*] if the individual has physical custody or legal custody
15 of the Indian child under any applicable tribal law, tribal custom or state
16 law.

17 “(2) An Indian child's parent has continued custody of the Indian child
18 **under sections 1 to 23, chapter 14, Oregon Laws 2020 (first special ses-**
19 **sion)**, if the parent currently has, or previously had, custody of the Indian
20 child.

21 “(3) For purposes of sections 1 to 23, **chapter 14, Oregon Laws 2020**
22 **(first special session)** [*of this 2020 special session Act*], the following indi-
23 viduals are presumed to have continued custody of an Indian child:

24 “(a) The Indian child's biological mother.

25 “(b) A man who is married to the Indian child's biological mother.

26 “(c) A man whose parentage has been acknowledged or established as
27 described in section 4, **chapter 14, Oregon Laws 2020 (first special ses-**
28 **sion)** [*of this 2020 special session Act*].

29 **“SECTION 49.** Section 5, chapter 14, Oregon Laws 2020 (first special
30 session), is amended to read:

1 “**Sec. 5. In a child custody proceeding involving an Indian child,**
2 when making a determination regarding the best interests of [*an Indian*] **the**
3 child under **ORS 109.304 to 109.410, ORS chapter 419B**, sections 1 to 23,
4 **chapter 14, Oregon Laws 2020 (first special session)** [*of this 2020 special*
5 *session Act, ORS chapter 419B*], the Indian Child Welfare Act (25 U.S.C. 1901
6 et seq.) or any regulations or rules regarding **ORS 109.304 to 109.410, ORS**
7 **chapter 419B**, sections 1 to 23, **chapter 14, Oregon Laws 2020 (first spe-**
8 **cial session)**, [*of this 2020 special session Act*] or the Indian Child Welfare
9 Act, the [*juvenile*] court shall, in consultation with the Indian child’s tribe,
10 consider the following [*relevant factors*]:

11 “(1) The protection of the safety, well-being, development and stability of
12 the Indian child;

13 “(2) The prevention of unnecessary out-of-home placement of the Indian
14 child;

15 “(3) The prioritization of placement of the Indian child in accordance with
16 the placement preferences under section 23, **chapter 14, Oregon Laws 2020**
17 **(first special session)** [*of this 2020 special session Act*];

18 “(4) The value to the Indian child of establishing, developing or main-
19 taining a political, cultural, social and spiritual relationship with the Indian
20 child’s tribe and tribal community; and

21 “(5) The importance to the Indian child of the Indian tribe’s ability to
22 maintain the tribe’s existence and integrity in promotion of the stability and
23 security of Indian children and families.

24 “**SECTION 50.** Section 10, chapter 14, Oregon Laws 2020 (first special
25 session), is amended to read:

26 “**Sec. 10.** (1)(a) The Department of Human Services shall make a good
27 faith effort to enter into a tribal-state agreement with any Indian tribe
28 within the borders of this state.

29 “(b) The department may also enter into a tribal-state agreement with any
30 Indian tribe outside of this state having significant numbers of member

1 children or membership-eligible children residing in this state.

2 “(2) The purposes of a tribal-state agreement are to promote the continued
3 existence and integrity of the Indian tribe as a political entity and to protect
4 the vital interests of Indian children in securing and maintaining political,
5 cultural and social relationships with their tribe.

6 “(3) A tribal-state agreement may include[, *but is not limited to,*] agree-
7 ments regarding default jurisdiction over cases in which the state courts and
8 tribal courts have concurrent jurisdiction, the transfer of cases between state
9 courts and tribal courts, the assessment, removal, placement, [*and*] custody
10 **and adoption** of Indian children and any other child welfare services pro-
11 vided to Indian children.

12 “(4) A tribal-state agreement must:

13 “(a) Provide for the cooperative delivery of child welfare services to In-
14 dian children in this state, including the utilization, to the extent available,
15 of services provided by the tribe or an organization whose mission is to serve
16 the American Indian or Alaska Native population to implement the terms
17 of the tribal-state agreement; and

18 “(b) If services provided by the tribe or an organization whose mission is
19 to serve the American Indian or Alaska Native population are unavailable,
20 provide for the department’s use of community services and resources devel-
21 oped specifically for Indian families and that have the demonstrated experi-
22 ence and capacity to provide culturally relevant and effective services to
23 Indian children.

24 “**SECTION 51.** Section 11, chapter 14, Oregon Laws 2020 (first special
25 session), is amended to read:

26 “**Sec. 11.** Section 10 (3), **chapter 14, Oregon Laws 2020 (first special**
27 **session)**, [*of this 2020 special session Act*] applies to tribal-state agreements
28 entered into or renewed on or after [*the effective date of this 2020 special*
29 *session Act*] **January 1, 2021.**

30 “**SECTION 52.** Section 17, chapter 14, Oregon Laws 2020 (first special

1 session), is amended to read:

2 “**Sec. 17.** (1) In any **child custody** proceeding under ORS chapter **109 or**
3 **419B** that requires the testimony of a qualified expert witness, the petitioner
4 shall contact the Indian child’s tribe and request that the tribe identify one
5 or more individuals meeting the criteria described in subsection (3) or (4) of
6 this section. The petitioner may also request the assistance of the United
7 States Bureau of Indian Affairs in locating individuals meeting the criteria
8 described in subsection (3) or (4) of this section. The petitioner shall file a
9 declaration with the court describing the efforts the petitioner made under
10 this subsection to identify a qualified expert witness.

11 “(2) At a hearing under ORS **109.326, 109.330**, 419B.340, 419B.365, 419B.366
12 or 419B.521, [*when there*] **if the court has found that there** is reason to
13 know **that** a child is an Indian child [*and a qualified expert witness is re-*
14 *quired*], at least one qualified expert witness must testify regarding:

15 “(a) Whether the [*Indian child’s*] continued custody **of the Indian child**
16 by the [*Indian*] child’s parent or **custody by the child’s** Indian custodian
17 is likely to result in serious emotional or physical damage to the Indian
18 child; and

19 “(b) The prevailing social and cultural standards and child rearing prac-
20 tices of the Indian child’s tribe.

21 “(3) A person is a qualified expert witness under this section if the Indian
22 child’s tribe has designated the person as being qualified to testify to the
23 prevailing social and cultural standards of the tribe.

24 “(4) If the Indian child’s tribe has not identified a qualified expert wit-
25 ness, the following individuals, in order of priority, may testify as a qualified
26 expert witness:

27 “(a) A member of the Indian child’s tribe or another person [*of the tribe’s*
28 *choice*] who is recognized by the tribe as knowledgeable **about** tribal customs
29 regarding family organization or child rearing practices;

30 “(b) A person having substantial experience in the delivery of child and

1 family services to Indians and extensive knowledge of prevailing social and
2 cultural standards and child rearing practices within the Indian child’s tribe;
3 or

4 “(c) Any person having substantial experience in the delivery of child and
5 family services to Indians and knowledge of prevailing social and cultural
6 standards and child rearing practices in Indian tribes with cultural similar-
7 ities to the child’s tribe.

8 “(5) In addition to testimony from a qualified expert witness, the court
9 may hear supplemental testimony regarding information described in sub-
10 section (2) of this section from a professional having substantial education
11 and experience in the area of the professional’s specialty.

12 “(6) No petitioning party, employees of the petitioning party or an em-
13 ployee of the Department of Human Services may serve as a qualified expert
14 witness or a professional under this section.

15

16 **“JUVENILE DEPENDENCY AND INDIAN CHILDREN**

17

18 **“SECTION 53.** ORS 418.312, as amended by section 53, chapter 14, Oregon
19 Laws 2020 (first special session), and sections 16a and 16b, chapter 19,
20 Oregon Laws 2020 (first special session), is amended to read:

21 “418.312. (1) The Department of Human Services may not require any
22 parent or legal guardian to transfer legal custody of a child in order to have
23 the child placed in a child-caring agency under ORS 418.205 to 418.327,
24 418.470, 418.475, 418.480 to 418.500, 418.950 to 418.970 and 418.992 to 418.998
25 in a foster home, group home or institutional child care setting, when the
26 sole reason for the placement is the need to obtain services for the child’s
27 emotional, behavioral or mental disorder or developmental or physical disa-
28 bility. In all such cases, the child shall be placed pursuant to a voluntary
29 placement agreement. When a child is placed pursuant to a voluntary
30 placement agreement, the department shall have responsibility for the child’s

1 placement and care.

2 “(2) If a child is placed pursuant to a voluntary placement agreement in
3 a qualified residential treatment program as described in section 12b, chapter
4 19, Oregon Laws 2020 (first special session), the placement is subject to ju-
5 dicial approval under section 14b, chapter 19, Oregon Laws 2020 (first special
6 session).

7 “[*(3)(a) If a child is placed pursuant to a voluntary placement agreement*
8 *and there is reason to know under section 15, chapter 14, Oregon Laws 2020*
9 *(first special session), that the child is an Indian child, the placement and*
10 *voluntary placement agreement must be approved by the juvenile court.*]

11 **“(3)(a) When a child is placed pursuant to a voluntary placement**
12 **agreement, the department shall make inquiries, as described in sec-**
13 **tion 15 (2), chapter 14, Oregon Laws 2020 (first special session), to de-**
14 **termine whether the department has reason to know that the child is**
15 **an Indian child.**

16 **“(b) If the department has reason to know that the child is an In-**
17 **dian child, the placement agreement must be executed in person be-**
18 **fore the juvenile court, consistent with this subsection, and the**
19 **placement must be approved by the court.**

20 **“(c) At a hearing, the juvenile court shall explain to the Indian**
21 **child’s parent or Indian custodian, on the record in detail and in the**
22 **language of the parent or Indian custodian, the parent’s right to legal**
23 **counsel, the terms and consequences of the voluntary placement**
24 **agreement, including that if the Indian child remains in custody for**
25 **more than 12 months, the court will hold a permanency hearing that**
26 **could eventually result in the termination of parental rights, and the**
27 **court must inform the parent or Indian custodian that the voluntary**
28 **placement agreement may be revoked at any time prior to an entry**
29 **of a final decree of termination of parental rights and have the child**
30 **returned to the parent’s custody. The parent or Indian custodian must**

1 **execute the voluntary placement agreement before the court. The**
2 **parent or Indian custodian shall file the voluntary placement agree-**
3 **ment with the court. The court shall certify that the court provided**
4 **the explanation consistent with the requirements under this paragraph**
5 **and that the parent or Indian custodian fully understood the explana-**
6 **tion.**

7 “[*b*] (d) The juvenile court may approve the voluntary placement agree-
8 ment if:

9 “(A) The court finds that the Indian child’s parent or Indian custodian
10 entered into the voluntary placement agreement without a threat of removal
11 by the Department of Human Services or an Oregon licensed adoption
12 agency; **and**

13 “(B) The proposed placement conforms with the placement preferences
14 described in section 23, chapter 14, Oregon Laws 2020 (first special
15 session)[;].

16 “[*C*] *The agreement is executed in writing and filed with the court;*]

17 “[*D*] *The court has explained to the Indian child’s parent or Indian*
18 *custodian the terms and consequences of the agreement, including that if the*
19 *Indian child remains in custody for more than 12 months, the juvenile court*
20 *will hold a permanency hearing which could eventually result in the termi-*
21 *nation of parental rights, and that the Indian child’s parent or Indian custo-*
22 *dian may withdraw consent to the agreement at any time prior to an entry of*
23 *a final decree of termination of parental rights and have the child returned to*
24 *the parent’s custody; and]*

25 “[*E*] *The juvenile court certifies that the explanation required under par-*
26 *agraph (b)(D) of this subsection was provided in English or, if English is not*
27 *the primary language of the Indian child’s parent or Indian custodian, in the*
28 *primary language of the Indian child’s parent or Indian custodian, and that*
29 *the explanation was fully understood by the parent or Indian custodian.]*

30 “[*c*] (e) An Indian child’s parent or Indian custodian may terminate the

1 voluntary placement agreement at any time prior to an entry of an order
2 terminating parental rights. To terminate the voluntary placement agree-
3 ment, the parent or Indian custodian must file a written notice of termi-
4 nation with the **juvenile** court or otherwise testify before the court. The
5 court shall promptly notify the department of the termination and order the
6 immediate return of the Indian child to the physical custody of the Indian
7 child’s parent or Indian custodian.

8 “(4)(a) If a child remains in voluntary placement for more than 180 days,
9 the juvenile court shall make a judicial determination, within the first 180
10 days of the placement, that the placement is in the best interests of the child.

11 “(b) If a child remains in voluntary placement for more than 12 months,
12 the juvenile court shall hold a permanency hearing as provided in ORS
13 419B.476 no later than 14 months after the child’s original voluntary place-
14 ment, and not less frequently than once every 12 months thereafter during
15 the continuation of the child’s original voluntary placement, to determine
16 the future status of the child.

17 “(5) As used in this section, ‘voluntary placement agreement’ means a
18 binding, written agreement between the department and the parent or legal
19 guardian of a minor child that does not transfer legal custody to the de-
20 partment but that specifies, at a minimum, the legal status of the child and
21 the rights and obligations of the parent or legal guardian, the child and the
22 department while the child is in placement.

23 **“SECTION 53a.** ORS 419A.116, as amended by section 52, chapter 14,
24 Oregon Laws 2020 (first special session), is amended to read:

25 “419A.116. (1) After reviewing each case, the local citizen review board
26 shall make written findings and recommendations with respect to:

27 “(a) Whether reasonable efforts were made prior to the placement, to
28 prevent or eliminate the need for removal of the child or ward from the
29 home;

30 “(b) If the case plan at the time of the review is to reunify the family,

1 whether the Department of Human Services has made reasonable efforts to
2 make it possible for the child or ward to safely return home and whether the
3 parent has made sufficient progress to make it possible for the child or ward
4 to safely return home;

5 “(c) If the case plan at the time of the review is something other than to
6 reunify the family, whether the department has made reasonable efforts to
7 place the child or ward in a timely manner in accordance with the case plan,
8 including, if appropriate, placement of the child or ward through an inter-
9 state placement, and to complete the steps necessary to finalize the perma-
10 nent placement of the child or ward;

11 “(d) The continuing need for and appropriateness of the placement;

12 “(e) Compliance with the case plan;

13 “(f) The progress which has been made toward alleviating the need for
14 placement;

15 “(g) A likely date by which the child or ward may be returned home or
16 placed for adoption;

17 “(h) Other problems, solutions or alternatives the board determines should
18 be explored;

19 “(i) Whether the court should appoint an attorney or other person as
20 special advocate to represent or appear on behalf of the child or ward under
21 ORS 419B.195;

22 “(j) For a ward 16 years of age or older with a permanency plan of an-
23 other planned permanent living arrangement, the steps the department is
24 taking to ensure that:

25 “(A) The ward’s substitute care provider is following the reasonable and
26 prudent parent standard; and

27 “(B) The ward has regular, ongoing opportunities to engage in age-
28 appropriate or developmentally appropriate activities, including consultation
29 with the ward in an age-appropriate manner about the opportunities the
30 ward has to participate in the activities;

1 “(k) Whether there is reason to know, as described in section 15, chapter
2 14, Oregon Laws 2020 (first special session), that the child or ward is an
3 Indian child; and

4 “(L) If there is reason to know the child or ward is an Indian child:

5 “(A) Whether the department made active efforts, as described in section
6 18, chapter 14, Oregon Laws 2020 (first special session), to prevent the
7 breakup of the Indian family prior to the child’s removal [*and whether those*
8 *efforts did not eliminate the necessity for removal based on serious emotional*
9 *or physical damage to the child*];

10 “(B) If the case plan at the time of the review is to reunify the family,
11 whether the department has provided active efforts to make it possible for
12 the child to safely return home[, *whether active efforts have eliminated the*
13 *necessity for continued removal based on serious emotional or physical damage*
14 *to the child*] and whether the parent has made sufficient progress to make
15 it possible for the child to return home;

16 “(C) If the case plan at the time of review is to reunify the family and
17 the child or ward is placed in a home outside the placement preferences de-
18 scribed in section 23, chapter 14, Oregon Laws 2020 (first special session),
19 whether the department has continued to maintain the relationship of the
20 child or ward with potential adoption preferences or whether the department
21 has continued to search for a permanent placement that satisfies the place-
22 ment preferences described in section 23, chapter 14, Oregon Laws 2020 (first
23 special session); and

24 “(D) If the case plan at the time of the review is something other than
25 to reunify the family, whether the department has made active efforts to
26 place the child in a timely manner in accordance with the placement pref-
27 erences under section 23, chapter 14, Oregon Laws 2020 (first special session).

28 “(2) The local citizen review board may, if the case plan has changed
29 during the period since the last review by a local citizen review board or
30 court hearing, make written findings and recommendations with respect to:

1 “(a) Whether the Department of Human Services has made reasonable ef-
2 forts or, if [*there is reason to know, as described in section 15, chapter 14,*
3 *Oregon Laws 2020 (first special session), that*] the child is an Indian child,
4 active efforts to make it possible for the child or ward to safely return home
5 and whether the parent has made sufficient progress to make it possible for
6 the child or ward to safely return home, if a plan to reunify the family was
7 in effect for any part of the period since the last review or hearing; or

8 “(b) Whether the department has made reasonable efforts to place the
9 child or ward in a timely manner in accordance with the case plan, includ-
10 ing, if appropriate, placement of the child or ward through an interstate
11 placement, and to complete the steps necessary to finalize the permanent
12 placement of the child or ward, if a case plan other than to reunify the
13 family was in effect for any part of the period since the last review or
14 hearing.

15 “(3) In determining whether the Department of Human Services has made
16 reasonable efforts or, if [*there is reason to know, as described in section 15,*
17 *chapter 14, Oregon Laws 2020 (first special session), that*] the child is an In-
18 dian child, active efforts to make it possible for the child or ward to safely
19 return home, the local citizen review board shall consider the child or ward’s
20 health and safety the paramount concerns.

21 “(4) No later than 10 days after receiving the findings and recommen-
22 dations of the local citizen review board, a party adversely affected by the
23 findings and recommendations may request judicial review.

24 “**SECTION 54.** ORS 419B.150, as amended by section 29, chapter 14,
25 Oregon Laws 2020 (first special session), is amended to read:

26 “419B.150. (1) As used in this section:

27 “(a) ‘Abuse’ has the meaning given that term in ORS 419B.005.

28 “(b) ‘Reasonable cause’ means a subjectively and objectively reasonable
29 belief, given all of the circumstances and based on specific and articulable
30 facts.

1 “(c) ‘Severe harm’ means:

2 “(A) Life-threatening damage; or

3 “(B) Significant or acute injury to a person’s physical, sexual or psycho-
4 logical functioning.

5 “(2) The following persons are authorized to take a child into protective
6 custody under this section:

7 “(a) A peace officer, as defined in ORS 420.905;

8 “(b) A counselor; or

9 “(c) An employee of the Department of Human Services.

10 “(3)(a) Prior to taking a child into protective custody under this section,
11 the person taking the child into protective custody shall **conduct the in-**
12 **quiry described in section 15, chapter 14, Oregon Laws 2020 (first spe-**
13 **cial session), to** determine whether [*there is*] **the person has** reason to
14 know **that** the child is an Indian child[, *as provided in section 15, chapter*
15 *14, Oregon Laws 2020 (first special session)*].

16 “(b) If [*there is*] **the person has** reason to know **that** the child is an In-
17 dian child, the **person taking the child into protective custody shall**
18 **provide the** emergency notification [*requirements of*] **under** section 16 (1),
19 chapter 14, Oregon Laws 2020 (first special session), [*must be met prior to*]
20 **before** taking the child into protective custody.

21 “(4)(a) Except as provided in paragraph (b) of this subsection, a child may
22 be taken into protective custody without a court order only when there is
23 reasonable cause to believe that:

24 “(A) There is an imminent threat of severe harm to the child;

25 “(B) The child poses an imminent threat of severe harm to self or others;
26 or

27 “(C) There is an imminent threat that the child’s parent or guardian will
28 cause the child to be beyond the reach of the juvenile court before the court
29 can order that the child be taken into protective custody under subsection
30 (7) of this section.

1 “(b) If [*there is*] **the person has** reason to know that the child is an In-
2 dian child, the child may be taken into protective custody without a court
3 order only when it is necessary to prevent imminent physical damage or
4 harm to the child.

5 “(5) A person authorized to take a child into protective custody shall ap-
6 ply for a protective custody order, as described in subsection (7) of this sec-
7 tion, by submitting a declaration based on information and belief that sets
8 forth with particularity:

9 “(a) Why protective custody is necessary and the least restrictive means
10 available to:

11 “(A) Protect the child from abuse;

12 “(B) Prevent the child from inflicting harm on self or others;

13 “(C) Ensure that the child remains within the reach of the juvenile court
14 to protect the child from abuse or to prevent the child from inflicting harm
15 on self or others; or

16 “(D) If the department [*knows or*] has reason to know that the child is
17 an Indian child, prevent imminent physical damage or harm to the child.

18 “(b) Why protective custody is in the best interests of the child.

19 “(6)(a) The applicant under subsection (5) of this section shall deliver the
20 declaration described in subsection (5) of this section to the juvenile court.

21 “(b) At the applicant’s request, instead of the declaration described in
22 subsection (5) of this section, the judge may take an oral statement under
23 oath. If the applicant makes the oral statement to the judge out of court, the
24 applicant shall record the oral statement and retain a copy of the recording.
25 The recording constitutes a declaration for the purposes of subsection (5) of
26 this section.

27 “(7) The juvenile court may order that a child be taken into protective
28 custody if, after reviewing the declaration described in subsection (5) of this
29 section, the court [*determines that*]:

30 “(a) **Determines that the person complied with the inquiry require-**

1 **ments under section 15, chapter 14, Oregon Laws 2020 (first special**
2 **session);**

3 **“(b) Makes a finding, subject to the procedures under section 15 (4),**
4 **chapter 14, Oregon Laws 2020 (first special session), regarding whether**
5 **there is reason to know that the child is an Indian child;**

6 **“(c) If the court finds that there is reason to know that the child**
7 **is an Indian child, determines that the person complied with the notice**
8 **requirements under section 16 (1), chapter 14, Oregon Laws 2020 (first**
9 **special session);**

10 **“[(a)] (d) Determines that** protective custody is necessary and the least
11 restrictive means available to:

12 **“(A) Protect the child from abuse;**

13 **“(B) Prevent the child from inflicting harm on self or others;**

14 **“(C) Ensure that the child remains within the reach of the juvenile court**
15 **to protect the child from abuse or prevent the child from inflicting harm on**
16 **self or others;**

17 **“(D) Ensure the safety of a child who has run away from home; or**

18 **“(E) If the [department knows or has] court finds that there is reason**
19 **to know that the child is an Indian child, prevent imminent physical damage**
20 **or harm to the child; and**

21 **“[(b)] (e) Determines that** protective custody is in the best interests of
22 the child.

23 **“(8) When the court issues a protective custody order under subsection**
24 **(7) of this section, the court may transmit the signed order to the applicant**
25 **by a form of electronic communication approved by the court that delivers**
26 **a complete printable image of the signed order. The court shall file the ori-**
27 **ginal order in the court record.**

28 **“SECTION 55. ORS 419B.171, as amended by section 30, chapter 14,**
29 **Oregon Laws 2020 (first special session), is amended to read:**

30 **“419B.171. (1) Except where the child is taken into protective custody**

1 pursuant to an order of the court, the person taking the child into protective
2 custody shall promptly file with the court or a counselor a brief written re-
3 port stating all of the following:

4 “(a) The child’s name, age and address.

1 Oregon Laws 2020 (first special session), is amended to read:

2 “419B.521. (1) The court shall hold a hearing on the question of termi-
3 nating the rights of the parent or parents. The court may not hold the
4 hearing any earlier than 10 days after service or final publication of the
5 summons. The facts on the basis of which the rights of the parents are ter-
6 minated, unless admitted, must be established by clear and convincing evi-
7 dence and a stenographic or other report authorized by ORS 8.340 shall be
8 taken of the hearing.

9 “(2) Not earlier than provided in subsection (1) of this section and not
10 later than six months from the date on which summons for the petition to
11 terminate parental rights is served, the court before which the petition is
12 pending shall hold a hearing on the petition except for good cause shown.
13 When determining whether or not to grant a continuance for good cause, the
14 judge shall take into consideration the age of the child or ward and the po-
15 tential adverse effect delay may have on the child or ward. The court shall
16 make written findings when granting a continuance.

17 “(3) The court, on its own motion or upon the motion of a party, may take
18 testimony from any child appearing as a witness and may exclude the child’s
19 parents and other persons if the court finds such action would be likely to
20 be in the best interests of the child. However, the court may not exclude the
21 attorney for each party and any testimony taken under this subsection shall
22 be recorded.

23 “(4)(a) Notwithstanding subsection (1) of this section, [*if an Indian child*
24 *is involved,*] **the** termination of parental rights **to an Indian child** must be
25 supported by [*competent*] evidence beyond a reasonable doubt, including tes-
26 timony of qualified expert witnesses, that continued custody of the **Indian**
27 **child by the child’s parents** is likely to result in serious emotional or
28 physical [*harm*] **damage** to the child.

29 “(b) The court may not enter an order terminating parental rights **to an**
30 **Indian child** unless:

1 “(A) The court has offered the parties the opportunity to participate in
2 mediation as required under ORS 419B.517;

3 “(B) If requested by the tribe, **and if the Department of Human Ser-**
4 **vices has identified a proposed adoptive placement**, an agreement is in
5 place that requires the [*Department of Human Services*] **proposed adoptive**
6 **placement** to maintain connection between the Indian child and the Indian
7 child’s tribe; and

8 “(C) After inquiry as required under section 15, chapter 14, Oregon Laws
9 2020 (first special session), and notice as required under section 16, chapter
10 14, Oregon Laws 2020 (first special session), and in addition to any other
11 findings required under ORS 419B.500 to 419B.524, the court determines:

12 “(i) That evidence, including the testimony of one or more qualified expert
13 witnesses under section 17, chapter 14, Oregon Laws 2020 (first special ses-
14 sion), establishes beyond a reasonable doubt that the [*Indian child’s*] con-
15 tinued custody **of the Indian child** by the child’s parent or custody by the
16 child’s Indian custodian is likely to result in serious emotional or physical
17 damage to the Indian child; and

18 “(ii) That active efforts under section 18, chapter 14, Oregon Laws 2020
19 (first special session), to reunite the Indian family did not eliminate the ne-
20 cessity for termination based on serious emotional or physical damage to the
21 Indian child.

22 “(c) The evidence under this [*section*] **subsection** must show a causal re-
23 lationship between the particular conditions in the Indian child’s home and
24 the likelihood that [*custody or*] continued custody of the Indian child **by the**
25 **child’s parents** will result in serious emotional or physical damage to the
26 particular Indian child who is the subject of the child custody proceeding,
27 **as defined in section 2, chapter 14, Oregon Laws 2020 (first special**
28 **session)**. Evidence that shows the existence of community or family poverty,
29 isolation, single parenthood, custodian age, crowded or inadequate housing,
30 substance abuse or nonconforming social behavior does not, by itself, estab-

1 lish a causal relationship as required by this paragraph.

2 “(d) As used in this subsection, ‘custody’ and ‘continued custody’ have the
3 meanings described in section 3, chapter 14, Oregon Laws 2020 (first special
4 session).

5

6 **“TRIBAL CUSTOMARY ADOPTION**

7

8 **“SECTION 65. Section 65a of this 2021 Act is added to and made a**
9 **part of ORS chapter 419B.**

10 **“SECTION 65a. (1) As used in this section, ‘tribal customary**
11 **adoption’ means the adoption of an Indian child, by and through the**
12 **tribal custom, traditions or law of the child’s tribe, and which may**
13 **be effected without the termination of parental rights.**

14 **“(2) If the juvenile court determines that tribal customary adoption**
15 **is in the best interests, as described in section 5, chapter 14, Oregon**
16 **Laws 2020 (first special session), of a ward who is an Indian child and**
17 **the child’s tribe consents to the tribal customary adoption:**

18 **“(a) The Department of Human Services shall provide the Indian**
19 **child’s tribe and proposed tribal customary adoptive parents with a**
20 **written report on the Indian child, including, to the extent not other-**
21 **wise prohibited by state or federal law, the medical background, if**
22 **known, of the child’s parents, and the child’s educational information,**
23 **developmental history and medical background, including all known**
24 **diagnostic information, current medical reports and any psychological**
25 **evaluations.**

26 **“(b) The court shall accept a tribal customary adoptive home study**
27 **conducted by the Indian child’s tribe if the home study:**

28 **“(A) Includes federal criminal background checks, including reports**
29 **of child abuse, that meet the standards applicable under the laws of**
30 **this state for all other proposed adoptive placements;**

1 **“(B) Uses the prevailing social and cultural standards of the Indian**
2 **child’s tribe as the standards for evaluation of the proposed adoptive**
3 **placement;**

4 **“(C) Includes an evaluation of the background, safety and health**
5 **information of the proposed adoptive placement, including the biolog-**
6 **ical, psychological and social factors of the proposed adoptive place-**
7 **ment and assessment of the commitment, capability and suitability**
8 **of the proposed adoptive placement to meet the Indian child’s needs;**
9 **and**

10 **“(D) Except where the proposed adoptive placement is the Indian**
11 **child’s current foster care placement, is completed prior to the place-**
12 **ment of the Indian child in the proposed adoptive placement.**

13 **“(c)(A) Notwithstanding subsection (3) of this section, the court**
14 **may not accept the tribe’s order or judgment of tribal customary**
15 **adoption if any adult living in the proposed adoptive placement has a**
16 **felony conviction for child abuse or neglect, spousal abuse, crimes**
17 **against a child, including child pornography, or a crime involving vi-**
18 **olence.**

19 **“(B) As used in this paragraph, ‘crime involving violence’ has the**
20 **meaning described by the Department of Human Services by rule,**
21 **which must include rape, sexual assault or homicide, but may not in-**
22 **clude other physical assault or battery.**

23 **“(3)(a) The juvenile court shall accept an order or judgment for**
24 **tribal customary adoption that is filed by the Indian child’s tribe if:**

25 **“(A) The court determines that tribal customary adoption is an**
26 **appropriate permanent placement option for the Indian child;**

27 **“(B) The court finds that the tribal customary adoption is in the**
28 **Indian child’s best interests, as described in section 5, chapter 14,**
29 **Oregon Laws 2020 (first special session); and**

30 **“(C) The order or judgment:**

1 “(i) Includes a description of the modification of the legal relation-
2 ship of the Indian child’s parents or Indian custodian and the child,
3 including contact, if any, between the child and the parents or Indian
4 custodian, responsibilities of the parents or Indian custodian and the
5 rights of inheritance of the parents and child;

6 “(ii) Includes a description of the Indian child’s legal relationship
7 with the tribe; and

8 “(iii) Does not include any child support obligation from the Indian
9 child’s parents or Indian custodian.

10 “(b) The court shall afford full faith and credit to a tribal custom-
11 ary adoption order or judgment that is accepted under this subsection.

12 “(4)(a) Notwithstanding ORS 109.309, a tribal customary adoptive
13 parent is not required to file a petition for adoption when the court
14 accepts a tribal customary adoption order or judgment under sub-
15 section (3) of this section.

16 “(b) The tribal customary adoptive parent shall file an Adoption
17 Summary and Segregated Information Statement with accompanying
18 exhibits as provided under ORS 109.317.

19 “(c) Notwithstanding ORS 21.135, the clerk of the juvenile court
20 may not charge or collect first appearance fees for a proceeding under
21 this subsection.

22 “(d) After accepting a tribal customary adoption order or judgment
23 under subsection (3) of this section, the juvenile court that accepted
24 the order or judgment shall proceed as provided in ORS 109.350 and
25 enter a judgment of adoption. In addition to the requirements under
26 ORS 109.350, the judgment of adoption must include a statement that
27 any parental rights or obligations not specified in the judgment are
28 transferred to the tribal customary adoptive parents and a description
29 of any parental rights or duties retained by the Indian child’s parents,
30 the rights of inheritance of the child and the child’s parents and the

1 **child’s legal relationship with the child’s tribe.**

2 **“(e) A tribal customary adoption under this section does not require**
3 **the consent of the Indian child or the child’s parents.**

4 **“(f) Upon the court’s entry of a judgment of adoption under this**
5 **section, the court’s jurisdiction over the Indian child terminates as**
6 **provided in ORS 419B.328 (2)(d).**

7 **“(g) Records of adoptions filed and established under this subsection**
8 **shall be kept in accordance with, and are subject to, ORS 109.319.**

9 **“(5) Any parental rights or obligations not specifically retained by**
10 **the Indian child’s parents in the juvenile court’s adoption judgment**
11 **are conclusively presumed to transfer to the tribal customary adoptive**
12 **parents.**

13 **“(6) This section shall remain operative only to the extent that**
14 **compliance with the provisions of this section do not conflict with**
15 **federal law as a condition of receiving funding under Title IV-E of the**
16 **Social Security Act.**

17 **“(7)(a) The Department of Human Services shall adopt rules re-**
18 **quiring that any report regarding a ward who is an Indian child that**
19 **the department submits to the court, including home studies, place-**
20 **ment reports or other reports required under ORS chapters 109, 418,**
21 **419A and 419B, must address tribal customary adoption as a**
22 **permanency option.**

23 **“(b) The Chief Justice of the Supreme Court may make rules nec-**
24 **essary for the court processes to implement the provisions of this**
25 **section.**

26 **“(c) The State Court Administrator may prepare necessary forms**
27 **for the implementation of this section.**

28 **“SECTION 65b. ORS 419B.476, as amended by section 38, chapter 14,**
29 **Oregon Laws 2020 (first special session), is amended to read:**

30 **“419B.476. (1) A permanency hearing shall be conducted in the manner**

1 provided in ORS 418.312, 419B.310, 419B.812 to 419B.839 and 419B.908, except
2 that the court may receive testimony and reports as provided in ORS
3 419B.325.

4 “(2) At a permanency hearing the court shall:

5 “(a) If the case plan at the time of the hearing is to reunify the family,
6 determine whether the Department of Human Services has made reasonable
7 efforts or, if [*there is reason to know as described in section 15, chapter 14,*
8 *Oregon Laws 2020 (first special session), that*] the ward is an Indian child,
9 active efforts as described in section 18, chapter 14, Oregon Laws 2020 (first
10 special session), to make it possible for the ward to safely return home and
11 whether the parent has made sufficient progress to make it possible for the
12 ward to safely return home. In making its determination, the court shall
13 consider the ward’s health and safety the paramount concerns.

14 “(b) If the case plan at the time of the hearing is something other than
15 to reunify the family, determine whether the department has made reasonable
16 efforts to place the ward in a timely manner in accordance with the plan,
17 including, if appropriate, reasonable efforts to place the ward through an
18 interstate placement, and to complete the steps necessary to finalize the
19 permanent placement.

20 “(c) If the case plan at the time of the hearing is something other than
21 to reunify the family, determine whether the department has considered
22 permanent placement options for the ward, including, if appropriate, whether
23 the department has considered both permanent in-state placement options
24 and permanent interstate placement options for the ward.

25 “(d) Make the findings of fact under ORS 419B.449 (3).

26 “(e) **If the child is an Indian child and the case plan at the time of**
27 **the hearing is something other than to reunify the family, make a**
28 **finding whether, after the department’s consultation with the child’s**
29 **tribe, and, if the tribe appears at the hearing, the court’s direct con-**
30 **sultation with the tribe, tribal customary adoption, as described in**

1 **section 65a of this 2021 Act, is an appropriate permanent placement for**
2 **the child if reunification is unsuccessful.**

3 “(3) When the ward is 14 years of age or older, in addition to making the
4 determination required by subsection (2) of this section, at a permanency
5 hearing the court shall review the comprehensive plan for the ward’s tran-
6 sition to successful adulthood and determine and make findings as to:

7 “(a) Whether the plan is adequate to ensure the ward’s transition to
8 successful adulthood;

9 “(b) Whether the department has offered appropriate services pursuant to
10 the plan; and

11 “(c) Whether the department has involved the ward in the development
12 of the plan.

13 “(4) At a permanency hearing the court may:

14 “(a) If the case plan changed during the period since the last review by
15 a local citizen review board or court hearing and a plan to reunify the family
16 was in effect for any part of that period, determine whether the department
17 has made reasonable efforts or, if [*there is reason to know as described in*
18 *section 15, chapter 14, Oregon Laws 2020 (first special session), that*] the ward
19 is an Indian child, active efforts as described in section 18, chapter 14,
20 Oregon Laws 2020 (first special session), to make it possible for the ward to
21 safely return home. In making its determination, the court shall consider the
22 ward’s health and safety the paramount concerns;

23 “(b) If the case plan changed during the period since the last review by
24 a local citizen review board or court hearing and a plan other than to reu-
25 nify the family was in effect for any part of that period, determine whether
26 the department has made reasonable efforts to place the ward in a timely
27 manner in accordance with the plan, including, if appropriate, placement of
28 the ward through an interstate placement, and to complete the steps neces-
29 sary to finalize the permanent placement;

30 “(c) If the court determines that further efforts will make it possible for

1 the ward to safely return home within a reasonable time, order that the
2 parents participate in specific services for a specific period of time and make
3 specific progress within that period of time;

4 “(d) Determine the adequacy and compliance with the case plan and the
5 case progress report;

6 “(e) Review the efforts made by the department to develop the concurrent
7 permanent plan, including but not limited to identification of appropriate
8 permanent in-state placement options and appropriate permanent interstate
9 placement options and, if adoption is the concurrent case plan, identification
10 and selection of a suitable adoptive placement for the ward;

11 “(f) Order the department to develop or expand the case plan or concur-
12 rent permanent plan and provide a case progress report to the court and
13 other parties within 10 days after the permanency hearing;

14 “(g) Order the department or agency to modify the care, placement and
15 supervision of the ward;

16 “(h) Order the local citizen review board to review the status of the ward
17 prior to the next court hearing; or

18 “(i) Set another court hearing at a later date.

19 “(5) The court shall enter an order within 20 days after the permanency
20 hearing. In addition to any determinations or orders the court may make
21 under subsection (4) of this section, the order shall include the following:

22 “(a) The court’s determinations required under subsections (2) and (3) of
23 this section, including a brief description of the efforts the department has
24 made with regard to the case plan in effect at the time of the permanency
25 hearing.

26 “(b) The court’s determination of the permanency plan for the ward that
27 includes whether and, if applicable, when:

28 “(A) The ward will be returned to the parent;

29 “(B) The ward will be placed for adoption, and a petition for termination
30 of parental rights will be filed;

1 “(C) The ward will be referred for establishment of legal guardianship;

2 “(D) The ward will be placed with a fit and willing relative; or

3 “(E) If the ward is 16 years of age or older, the ward will be placed in
4 another planned permanent living arrangement.

5 “(c) If the court determines that the permanency plan for the ward should
6 be to return home because further efforts will make it possible for the ward
7 to safely return home within a reasonable time, the court’s determination
8 of the services in which the parents are required to participate, the progress
9 the parents are required to make and the period of time within which the
10 specified progress must be made.

11 “(d) If the court determines that the permanency plan for the ward should
12 be adoption, the court’s determination of whether one of the circumstances
13 in ORS 419B.498 (2) is applicable.

14 “(e) If the court determines that the permanency plan for the ward should
15 be establishment of a legal guardianship, the court’s determination of why
16 neither placement with parents nor adoption is appropriate.

17 “(f) If the court determines that the permanency plan for a ward should
18 be placement with a fit and willing relative, the court’s determination of why
19 placement with the ward’s parents, or for adoption, or placement with a legal
20 guardian, is not appropriate.

21 “(g) If the court determines that the permanency plan for the ward
22 should be tribal customary adoption, the court’s determination of
23 whether one of the circumstances in ORS 419B.498 (2) is applicable.

24 “[g] (h) If the court determines that the permanency plan for a ward 16
25 years of age or older should be another planned permanent living arrange-
26 ment, the court’s determinations:

27 “(A) Why another planned permanent living arrangement is in the ward’s
28 best interests and a compelling reason, that must be documented by the de-
29 partment, why it would not be in the best interests of the ward to be re-
30 turned home, placed for adoption, placed with a legal guardian or placed

1 with a fit and willing relative; and

2 “(B) That the department has taken steps to ensure that:

3 “(i) The ward’s substitute care provider is following the reasonable and
4 prudent parent standard; and

5 “(ii) The ward has regular, ongoing opportunities to engage in age-
6 appropriate or developmentally appropriate activities, including consultation
7 with the ward in an age-appropriate manner about the opportunities the
8 ward has to participate in the activities.

9 “[*h*] (i) If the current placement is not expected to be permanent, the
10 court’s projected timetable for return home or for placement in another
11 planned permanent living arrangement. If the timetable set forth by the court
12 is not met, the department shall promptly notify the court and parties.

13 “[*i*] (j) If [*there is reason to know that an Indian child is involved*] **the**
14 **ward is an Indian child**, the tribal affiliation of the ward.

15 “[*j*] (k) If [*there is reason to know that*] the ward is an Indian child and
16 **if** the court determines that the permanency plan for the ward should be
17 something other than to reunify the family, the court’s determination, by
18 clear and convincing evidence, that:

19 “(A) Active efforts as described in section 18, chapter 14, Oregon Laws
20 2020 (first special session), were provided to make it possible for the Indian
21 child to safely return home;

22 “(B) Despite the efforts provided, continued removal of the Indian child
23 is necessary to prevent serious emotional or physical damage to the Indian
24 child;

25 “(C) The parent has not made sufficient progress to make it possible for
26 the Indian child to safely return home; and

27 “(D) The new permanency plan complies with the placement preferences
28 described in section 23, chapter 14, Oregon Laws 2020 (first special session).

29 “[*k*] (L) If the ward has been placed in an interstate placement, the
30 court’s determination of whether the interstate placement continues to be

1 appropriate and in the best interests of the ward.

2 “(6) In making the determinations under subsection [(5)(g)] **(5)(h)** of this
3 section, the court shall ask the ward about the ward’s desired permanency
4 outcome.

5 “(7) If *[there is reason to know that an Indian child is involved]* **the child**
6 **is an Indian child:**

7 “(a) The court shall follow the placement preferences described in section
8 23, chapter 14, Oregon Laws 2020 (first special session).

9 “(b) If the court finds that the department did not provide active efforts
10 to make it possible for the Indian child to safely return home, the court may
11 not, at that permanency hearing, change the permanency plan to something
12 other than to reunify the family.

13 “(c) If the court finds that the department did not provide active efforts
14 to make it possible for the Indian child to return home, except as otherwise
15 required under ORS 419B.470, the court may not set a date for a subsequent
16 permanency hearing until the department has provided active efforts for the
17 number of days that active efforts were not previously provided.

18 “**(d)(A) If the court determines that tribal customary adoption, as**
19 **described in section 65a of this 2021 Act, is an appropriate permanent**
20 **placement for the child, and the Indian child’s tribe consents, the**
21 **court shall request that the tribe file with the court a tribal customary**
22 **adoption order or judgment evidencing that the tribal customary**
23 **adoption has been completed. The tribe must file the tribal customary**
24 **adoption order or judgment no less than 20 days prior to the date set**
25 **by the court for hearing.**

26 “**(B) Upon the tribe’s request, the court may grant an extension of**
27 **time to file the tribal customary adoption order or judgment, not to**
28 **exceed 60 days.**

29 “**(C) If the tribe does not file the tribal customary adoption order**
30 **or judgment within the designated time period, the court shall order**

1 **a new permanency hearing to determine the best permanency plan for**
2 **the child.**

3 “(8) Any final decision of the court made pursuant to the permanency
4 hearing is appealable under ORS 419A.200. On appeal of a final decision of
5 the court under this subsection, the court’s finding, if any, under ORS
6 419B.340 (5) that the department is not required to make reasonable efforts
7 to make it possible for the ward to safely return home is an interlocutory
8 order to which a party may assign error.

9 **“SECTION 65c.** ORS 419B.498, as amended by section 47, chapter 14,
10 Oregon Laws 2020 (first special session), is amended to read:

11 “419B.498. (1) Except as provided in subsection (2) of this section, the
12 Department of Human Services shall simultaneously file a petition to termi-
13 nate the parental rights of a child or ward’s parents and identify, recruit,
14 process and approve a qualified family for adoption if the child or ward is
15 in the custody of the department and:

16 “(a) The child or ward has been in substitute care under the responsibility
17 of the department for 15 months of the most recent 22 months;

18 “(b) A parent has been convicted of murder of another child of the parent,
19 voluntary manslaughter of another child of the parent, aiding, abetting, at-
20 tempting, conspiring or soliciting to commit murder or voluntary
21 manslaughter of the child or ward or of another child of the parent or felony
22 assault that has resulted in serious physical injury to the child or ward or
23 to another child of the parent; or

24 “(c) A court of competent jurisdiction has determined that the child or
25 ward is an abandoned child.

26 “(2) The department shall file a petition to terminate the parental rights
27 of a parent in the circumstances described in subsection (1) of this section
28 unless:

29 “(a) The child or ward is being cared for by a relative and that placement
30 is intended to be permanent;

1 “(b) There is a compelling reason, which is documented in the case plan,
2 for determining that filing such a petition would not be in the best interests
3 of the child or ward. Such compelling reasons include, but are not limited
4 to:

5 “(A) The parent is successfully participating in services that will make
6 it possible for the child or ward to safely return home within a reasonable
7 time as provided in ORS 419B.476 (5)(c);

8 “(B) Another permanent plan is better suited to meet the health and
9 safety needs of the child or ward, including the need to preserve the child’s
10 or ward’s sibling attachments and relationships; [*or*]

11 “(C) **If the child is an Indian child, the court finds that tribal cus-**
12 **tomary adoption, as described in section 65a of this 2021 Act, is an**
13 **appropriate permanent plan for the child and the Indian child’s tribe**
14 **consents to the tribal customary adoption; or**

15 “[*C*] (D) The court or local citizen review board in a prior hearing or
16 review determined that while the case plan was to reunify the family the
17 department did not make reasonable efforts or, if the child or ward is an
18 Indian child, active efforts, as described in section 18, chapter 14, Oregon
19 Laws 2020 (first special session), to make it possible for the child or ward
20 to safely return home; or

21 “(c) The department has not provided to the family of the child or ward,
22 consistent with the time period in the case plan, such services as the de-
23 partment deems necessary for the child or ward to safely return home, if
24 reasonable efforts to make it possible for the child or ward to safely return
25 home are required to be made with respect to the child or ward.

26 “(3) No petition to terminate the parental rights of a child or ward’s
27 parents pursuant to subsection (1) of this section or pursuant to ORS
28 419B.500, 419B.502, 419B.504, 419B.506 or 419B.508 may be filed until the
29 court has determined that the permanency plan for the child or ward should
30 be adoption after a permanency hearing pursuant to ORS 419B.476.

1 **“STATUS OFFENSES OF INDIAN CHILDREN**

2
3 **“SECTION 66.** ORS 419C.626 is amended to read:

4 “419C.626. (1) Upon receiving a report required by ORS 419C.620:

5 “(a) The court may hold a hearing to review the youth offender’s condi-
6 tion and circumstances and to determine if the court should continue juris-
7 diction over the youth offender or order modifications in the custody,
8 placement and supervision of the youth offender.

9 “(b) And if requested by the youth offender, the attorney for the youth
10 offender, if any, the parents of the youth offender if parental rights have not
11 been terminated, a court appointed special advocate, a local citizen review
12 board, the Oregon Youth Authority, a county juvenile department, a district
13 attorney or a private agency having guardianship or legal custody of the
14 youth offender, the court shall hold a hearing within 30 days of receipt of
15 the request.

16 “(2) The court, on its own motion, may hold a review hearing at any time.
17 Unless good cause otherwise is shown, the court shall hold a review hearing
18 at any time upon the request of the youth offender, the attorney for the
19 youth offender, if any, the parents of the youth offender if parental rights
20 have not been terminated, a court appointed special advocate, a local citizen
21 review board, the youth authority, a county juvenile department, a district
22 attorney or a private agency having guardianship or legal custody of the
23 youth offender.

24 “(3)(a) A hearing under subsection (1) or (2) of this section shall be con-
25 ducted in the manner provided in ORS 419C.400 (1), 419C.405 and 419C.408,
26 except that the court may receive testimony and reports as provided in ORS
27 419C.400 (4).

28 **“(b) At each hearing under subsection (1) or (2) of this section, un-**
29 **less the court has entered an order finding that the youth offender is**
30 **an Indian child, the court shall make a finding, subject to the proce-**

1 **dures under section 15 (4), chapter 14, Oregon Laws 2020 (first special**
2 **session), regarding whether there is reason to know that the child is**
3 **an Indian child.**

4 “(c) At the conclusion of the hearing, the court shall enter findings of
5 fact if the decision is to continue the youth offender in an out-of-home
6 placement in the legal custody of the youth authority, a county juvenile de-
7 partment or a private agency. The findings shall specifically state:

8 “[a] (A) Why continued out-of-home placement is necessary as opposed
9 to returning the youth offender to the youth offender’s home or promptly
10 securing another placement;

11 “[b] (B) The expected timetable for return home; and

12 “[c] (C) Whether the youth offender’s reformation plan or case plan
13 should be modified.

14 “(4) After receiving a report required by ORS 419C.620 (2), if requested
15 by the county juvenile department, the court’s findings under subsection (3)
16 of this section must specifically state:

17 “(a) Whether the county juvenile department has made reasonable efforts
18 or, if [*the Indian Child Welfare Act applies*] **the youth offender is an In-**
19 **dian child**, active efforts to make it possible for the youth offender to safely
20 return home. In making this finding, the court shall consider the youth
21 offender’s health and safety the paramount concerns.

22 “(b) The appropriateness of the youth offender’s placement.

23 “(c) The extent of compliance with the youth offender’s case plan.

24 “(d) The extent of progress that has been made toward alleviating or
25 mitigating the causes necessitating the youth offender’s placement in sub-
26 stitute care.

27 “(5) The court may direct the local citizen review board to review the
28 status of the youth offender prior to the court’s next review under ORS
29 419A.106, 419A.108, 419A.110, 419A.112, 419A.116 and 419A.118.

30 “(6) Any final decision of the court made pursuant to a hearing under

1 subsection (1) or (2) of this section is appealable under ORS 419A.200.

2

3 **“CONFORMING AMENDMENTS REGARDING INDIAN CHILDREN**

4

5 **“SECTION 67.** ORS 419B.090, as amended by section 25, chapter 14,
6 Oregon Laws 2020 (first special session), is amended to read:

7 “419B.090. (1) The juvenile court is a court of record and exercises juris-
8 diction as a court of general and equitable jurisdiction and not as a court
9 of limited or inferior jurisdiction. The juvenile court is called ‘The
10 _____ Court of _____ County, Juvenile Department.’

11 “(2)(a) It is the policy of the State of Oregon to recognize that children
12 are individuals who have legal rights. Among those rights are the right to:

13 “(A) Permanency with a safe family;

14 “(B) Freedom from physical, sexual or emotional abuse or exploitation;
15 and

16 “(C) Freedom from substantial neglect of basic needs.

17 “(b) Parents and guardians have a duty to afford their children the rights
18 listed in paragraph (a) of this subsection. Parents and guardians have a duty
19 to remove any impediment to their ability to perform parental duties that
20 afford these rights to their children. When a parent or guardian fails to
21 fulfill these duties, the juvenile court may determine that it is in the best
22 interests of the child to remove the child from the parent or guardian either
23 temporarily or permanently.

24 “(c) The provisions of this chapter shall be liberally construed to the end
25 that a child coming within the jurisdiction of the court may receive such
26 care, guidance, treatment and control as will lead to the child’s welfare and
27 the protection of the community.

28 “(3) It is the policy of the State of Oregon to safeguard and promote each
29 child’s right to safety, stability and well-being and to safeguard and promote
30 each child’s relationships with parents, siblings, grandparents, other rela-

1 tives and adults with whom a child develops healthy emotional attachments.

2 “(4) It is the policy of the State of Oregon to guard the liberty interest
3 of parents protected by the Fourteenth Amendment to the United States
4 Constitution and to protect the rights and interests of children, as provided
5 in subsection (2) of this section. The provisions of this chapter shall be
6 construed and applied in compliance with federal constitutional limitations
7 on state action established by the United States Supreme Court with respect
8 to interference with the rights of parents to direct the upbringing of their
9 children, including, but not limited to, the right to:

10 “(a) Guide the secular and religious education of their children;

11 “(b) Make health care decisions for their children; and

12 “(c) Discipline their children.

13 “(5) It is the policy of the State of Oregon, in those cases not described
14 as extreme conduct under ORS 419B.502, to offer appropriate reunification
15 services to parents and guardians to allow them the opportunity to adjust
16 their circumstances, conduct or conditions to make it possible for the child
17 to safely return home within a reasonable time. The state shall provide to
18 parents and guardians with disabilities opportunities to benefit from or par-
19 ticipate in reunification services that are equal to those extended to indi-
20 viduals without disabilities. The state shall provide aids, benefits and
21 services different from those provided to parents and guardians without dis-
22 abilities, when necessary to ensure that parents and guardians with disabil-
23 ities are provided with an equal opportunity under this subsection. Although
24 there is a strong preference that children live in their own homes with their
25 own families, the state recognizes that it is not always possible or in the best
26 interests of the child or the public for children who have been abused or
27 neglected to be reunited with their parents or guardians. In those cases, the
28 State of Oregon has the obligation to create or provide an alternative, safe
29 and permanent home for the child.

30 “(6) It is the policy of the State of Oregon, in a case involving an Indian

1 child, to safeguard and promote the Indian child’s connections with the In-
2 dian child’s family, culture and tribe in accordance with the policies re-
3 garding Indian children in [*dependency*] **child custody** proceedings under
4 section 1, chapter 14, Oregon Laws 2020 (first special session).

5 **“SECTION 68.** ORS 419B.100, as amended by section 27, chapter 14,
6 Oregon Laws 2020 (first special session), is amended to read:

7 “419B.100. (1) Except as otherwise provided in subsection (5) of this sec-
8 tion and ORS 107.726, the juvenile court has exclusive original jurisdiction
9 in any case involving a person who is under 18 years of age and:

10 “(a) Who is beyond the control of the person’s parents, guardian or other
11 person having custody of the person;

12 “(b) Whose behavior is such as to endanger the welfare of the person or
13 of others;

14 “(c) Whose condition or circumstances are such as to endanger the wel-
15 fare of the person or of others;

16 “(d) Who is dependent for care and support on a public or private child-
17 caring agency that needs the services of the court in planning for the best
18 interest of the person;

19 “(e) Whose parents or any other person or persons having custody of the
20 person have:

21 “(A) Abandoned the person;

22 “(B) Failed to provide the person with the care or education required by
23 law;

24 “(C) Subjected the person to cruelty, depravity or unexplained physical
25 injury; or

26 “(D) Failed to provide the person with the care, guidance and protection
27 necessary for the physical, mental or emotional well-being of the person;

28 “(f) Who is a runaway;

29 “(g) Who has filed a petition for emancipation pursuant to ORS 419B.550
30 to 419B.558; or

1 “(h) Who is subject to an order entered under ORS 419C.411 (7)(a).

2 “(2) The court shall have jurisdiction under subsection (1) of this section
3 even though the child is receiving adequate care from the person having
4 physical custody of the child.

5 “(3) The provisions of subsection (1) of this section do not prevent a court
6 of competent jurisdiction from entertaining a civil action or suit involving
7 a child.

8 “(4) The court does not have further jurisdiction as provided in subsection
9 (1) of this section after a minor has been emancipated pursuant to ORS
10 419B.550 to 419B.558.

11 “(5) Except as provided in section 12, chapter 14, Oregon Laws 2020 (first
12 special session), jurisdiction over any child custody proceeding, **as defined**
13 **in section 2, chapter 14, Oregon Laws 2020 (first special session)**, in-
14 volving an Indian child is determined as provided in section 12, chapter 14,
15 Oregon Laws 2020 (first special session).

16 **“SECTION 69.** ORS 419B.234 is amended to read:

17 “419B.234. (1) A person appointed as a guardian ad litem under ORS
18 419B.231:

19 “(a) Must be a licensed mental health professional or attorney;

20 “(b) Must be familiar with legal standards relating to competence;

21 “(c) Must have skills and experience in representing persons with mental
22 and physical disabilities or impairments; and

23 “(d) May not be a member of the parent’s family.

24 “(2) The guardian ad litem is not a party in the proceeding but is a rep-
25 resentative of the parent.

26 “(3) The guardian ad litem shall:

27 “(a) Consult with the parent, if the parent is able, and with the parent’s
28 attorney and make any other inquiries as are appropriate to assist the
29 guardian ad litem in making decisions in the juvenile court proceeding.

30 “(b) Make legal decisions that the parent would ordinarily make con-

1 cerning the juvenile court proceeding including, but not limited to, whether
2 to:

3 “(A) Admit or deny the allegations of any petition;

4 “(B) Agree to or contest jurisdiction, wardship, temporary commitment,
5 guardianship or permanent commitment;

6 “(C) Accept or decline a conditional postponement; or

7 “(D) Agree to or contest specific services or placement.

8 “(c) Make decisions concerning the adoption of a child of the parent in-
9 cluding release or surrender, certificates of irrevocability and consent to
10 adoption under ORS 109.321 or 418.270 **or section 19 of this 2021 Act** and
11 agreements under ORS 109.305.

12 “(d) Control the litigation and provide direction to the parent’s attorney
13 on the decisions that would ordinarily be made by the parent in the pro-
14 ceeding.

15 “(e) Inform the court if the parent no longer needs a guardian ad litem.

16 “(4) In making decisions under subsection (3) of this section, the guardian
17 ad litem shall make the decisions consistent with what the guardian ad litem
18 believes the parent would decide if the parent did not lack substantial ca-
19 pacity to either understand the nature and consequences of the proceeding
20 or give direction or assistance to the parent’s attorney on decisions the
21 parent must make in the proceeding.

22 “(5) The parent’s attorney shall follow directions provided by the guard-
23 ian ad litem on decisions that are ordinarily made by the parent in the pro-
24 ceeding. The parent’s attorney shall inquire at every critical stage in the
25 proceeding as to whether the parent’s competence has changed and, if ap-
26 propriate, shall request removal of the guardian ad litem.

27 “(6)(a) A parent for whom a guardian ad litem has been appointed under
28 ORS 419B.231 has a privilege to refuse to disclose and to prevent any other
29 person from disclosing confidential communications made for the purpose of
30 facilitating the rendition of professional services to the parent:

1 “(A) Between the guardian ad litem and the parent’s attorney or a rep-
2 resentative of the attorney; or

3 “(B) Between the guardian ad litem and the parent.

4 “(b) The privilege created by this subsection:

5 “(A) May be claimed by the parent or the guardian ad litem. The
6 guardian ad litem may claim the privilege only on behalf of the parent.

7 “(B) Is subject to ORS 40.280, 40.285 and 40.290.

8 **“SECTION 70.** ORS 419B.310, as amended by section 35, chapter 14,
9 Oregon Laws 2020 (first special session), is amended to read:

10 “419B.310. (1) The hearing shall be held by the court without a jury and
11 may be continued from time to time. During the hearing of a case filed pur-
12 suant to ORS 419B.100, the court, on its own motion or upon the motion of
13 a party, may take testimony from any child appearing as a witness and may
14 exclude the child’s parents and other persons if the court finds such action
15 would be likely to be in the best interests of the child. However, the court
16 may not exclude the attorney for each party and the testimony shall be re-
17 ported.

18 “(2) Stenographic notes or other report of the hearings shall be taken only
19 when required by the court.

20 “(3)(a) Except as otherwise provided in this section, the facts alleged in
21 the petition showing the child to be within the jurisdiction of the court as
22 provided in ORS 419B.100 (1), unless admitted, must be established:

23 “(A) By a preponderance of competent evidence; or

24 “(B) If [*there is reason to know under section 15, chapter 14, Oregon Laws*
25 *2020 (first special session), that*] the child is an Indian child, by clear and
26 convincing competent evidence.

27 “(b) The evidence under paragraph (a)(B) of this section must:

28 “(A) Include testimony of one or more qualified expert witnesses under
29 section 17, chapter 14, Oregon Laws 2020 (first special session), demonstrat-
30 ing that the Indian child’s continued custody by the child’s parent or custody

1 by the child’s Indian custodian is likely to result in serious emotional or
2 physical damage to the Indian child; and

3 “(B) Show a causal relationship between the particular conditions in the
4 Indian child’s home and the likelihood that the [*Indian child’s*] continued
5 custody **of the Indian child** by the child’s parent or custody by the child’s
6 Indian custodian will result in serious emotional or physical damage to the
7 particular Indian child who is the subject of the child custody proceeding,
8 **as defined in section 2, chapter 14, Oregon Laws 2020 (first special**
9 **session)**. Evidence that shows the existence of community or family poverty,
10 isolation, single parenthood, custodian age, crowded or inadequate housing,
11 substance abuse or nonconforming social behavior does not, by itself, estab-
12 lish a causal relationship as required by this paragraph.

13 “(c) As used in this subsection, ‘custody’ and ‘continued custody’ have the
14 meanings described in section 3, chapter 14, Oregon Laws 2020 (first special
15 session).

16 “[*(4)(a) At any hearing of a case filed pursuant to ORS 419B.100, the court*
17 *shall determine whether there is reason to know under section 15, chapter 14,*
18 *Oregon Laws 2020 (first special session), that the child is an Indian child.*]

19 “[*(b)*] **(4) If the court finds under ORS 419B.305 (2), or at any time**
20 **prior to the commencement of the hearing, that** there is reason to know
21 that the child is an Indian child, the jurisdictional requirements of section
22 12, chapter 14, Oregon Laws 2020 (first special session), and ORS 419B.305
23 must be met before the court may assume jurisdiction of the case.

24 **“SECTION 71.** ORS 419B.325, as amended by section 36, chapter 14,
25 Oregon Laws 2020 (first special session), is amended to read:

26 “419B.325. (1) At the termination of the hearing or hearings in the pro-
27 ceeding, the court shall enter an appropriate order directing the disposition
28 to be made of the case.

29 “(2) For the purpose of determining proper disposition of the ward, testi-
30 mony, reports or other material relating to the ward’s mental, physical and

1 social history and prognosis may be received by the court without regard to
2 their competency or relevancy under the rules of evidence.

3 “(3) If [*there is reason to know under section 15, chapter 14, Oregon Laws*
4 *2020 (first special session), that the ward is an Indian child,*] **the child is**
5 **an Indian child**, the court’s order under this section must be in compliance
6 with the placement preferences described in section 23, chapter 14, Oregon
7 Laws 2020 (first special session).

8 **“SECTION 72.** ORS 419B.368, as amended by section 58, chapter 14,
9 Oregon Laws 2020 (first special session), is amended to read:

10 “419B.368. (1) The court, on its own motion or upon the motion of a party
11 and after such hearing as the court may direct, may review, modify or vacate
12 a guardianship order.

13 “(2) The court may modify a guardianship order if the court determines
14 to do so would be in the ward’s best interests.

15 “(3) The court may vacate a guardianship order, return the ward to the
16 custody of a parent and make any other order the court is authorized to
17 make under this chapter if the court determines that:

18 “(a) It is in the ward’s best interests to vacate the guardianship;

19 “(b) The conditions and circumstances giving rise to the establishment
20 of the guardianship have been ameliorated; and

21 “(c) The parent is presently able and willing to adequately care for the
22 ward.

23 “(4) The court may vacate a guardianship order after determining that the
24 guardian is no longer willing or able to fulfill the duties of a guardian. Upon
25 vacating a guardianship order under this subsection, the court shall conduct
26 a hearing:

27 “(a) Within 14 days, make written findings required in ORS 419B.185
28 [(1)(a), (d), (e) and (f)] **(2) and (3)(d) and (e)** and make any order directing
29 disposition of the ward that the court is authorized to make under this
30 chapter; and

1 “(b) Pursuant to ORS 419B.476 within 90 days.

2 “(5) In determining whether it is in the ward’s best interests to modify
3 or vacate a guardianship, the court shall consider, but is not limited to
4 considering:

5 “(a) The ward’s emotional and developmental needs;

6 “(b) The ward’s need to maintain existing attachments and relationships
7 and to form attachments and relationships, including those with the birth
8 family;

9 “(c) The ward’s health and safety; and

10 “(d) The ward’s wishes.

11 “(6) In addition to service required under ORS 419B.851, a party filing a
12 motion to vacate a guardianship shall serve the motion upon the Department
13 of Human Services.

14 “(7) Notwithstanding subsection (1) of this section, a parent may not move
15 the court to vacate a guardianship once a guardianship is granted under ORS
16 419B.365.

17 “(8) If a guardianship is established under ORS 419B.366 and 419B.371, the
18 court shall conduct a court review not later than 60 days before the ward
19 reaches 18 years of age. At the hearing, the court shall inform the ward that
20 after reaching 18 years of age the ward may not be placed in substitute care
21 in the legal custody of the Department of Human Services.

22 “**SECTION 73.** ORS 419B.449, as amended by section 46, chapter 14,

24 “419B.449. (1) Upon receiving any report required by ORS 419B.440, the
25 court may hold a hearing to review the child or ward’s condition and cir-
26 cumstances and to determine if the court should continue jurisdiction and
27 wardship or order modifications in the care, placement and supervision of the
28 child or ward. The court shall hold a hearing:

29 “(a) In all cases under ORS 419B.440 (1)(b)(B) when the parents’ rights
30 have been terminated;

1 “(b) If requested by the child or ward, the attorney for the child or ward,
2 if any, the parents or the public or private agency having guardianship or
3 legal custody of the child or ward within 30 days of receipt of the notice
4 provided in ORS 419B.452;

5 “(c) Not later than six months after receipt of a report made under ORS
6 419B.440 (1)(a) on a ward who is in the legal custody of the Department of
7 Human Services pursuant to ORS 419B.337 but who is placed in the physical
8 custody of a parent or a person who was appointed the ward’s legal guardian
9 prior to placement of the ward in the legal custody of the department;

10 “(d) Within 30 days after receipt of a report made under ORS 419B.440
11 (1)(b)(C); or

12 “(e) Within 10 days after receipt of a report made under ORS 419B.440
13 (1)(c).

14 “(2) The court shall conduct a hearing provided in subsection (1) of this
15 section in the manner provided in ORS 419B.310, except that the court may
16 receive testimony and reports as provided in ORS 419B.325. At the conclusion
17 of the hearing, the court shall enter findings of fact.

18 “(3) If the child or ward is in substitute care and the decision of the court
19 is to continue the child or ward in substitute care, the findings of the court
20 shall specifically state:

21 “(a)(A) Why continued care is necessary as opposed to returning the child
22 or ward home or taking prompt action to secure another permanent place-
23 ment; and

24 “(B) The expected timetable for return or other permanent placement.

25 “(b) Whether the agency having guardianship or legal custody of the child
26 or ward has made diligent efforts to place the child or ward pursuant to ORS
27 419B.192.

28 “(c) The number of placements made, schools attended, face-to-face con-
29 tacts with the assigned case worker and visits had with parents or siblings
30 since the child or ward has been in the guardianship or legal custody of the

1 agency and whether the frequency of each of these is in the best interests
2 of the child or ward.

3 “(d) For a child or ward 14 years of age or older, whether the child or
4 ward is progressing adequately toward graduation from high school and, if
5 not, the efforts that have been made by the agency having custody or
6 guardianship to assist the child or ward to graduate.

7 “(e) For a ward 16 years of age or older with a permanency plan of an-
8 other planned permanent living arrangement, the steps the department is
9 taking to ensure that:

10 “(A) The ward’s substitute care provider is following the reasonable and
11 prudent parent standard; and

12 “(B) The ward has regular, ongoing opportunities to engage in age-
13 appropriate or developmentally appropriate activities, including consultation
14 with the ward in an age-appropriate manner about the opportunities the
15 ward has to participate in the activities.

16 “(4) If the ward is in the legal custody of the department but has been
17 placed in the physical custody of the parent or a person who was appointed
18 the ward’s legal guardian prior to placement of the ward in the legal custody
19 of the department, and the decision is to continue the ward in the legal
20 custody of the department and the physical custody of the parent or guard-
21 ian, the findings of the court shall specifically state:

22 “(a) Why it is necessary and in the best interests of the ward to continue
23 the ward in the legal custody of the department; and

24 “(b) The expected timetable for dismissal of the department’s legal cus-
25 tody of the ward and termination of the wardship.

26 “(5) If [*there is reason to know, as described in section 15, chapter 14,*
27 *Oregon Laws 2020 (first special session), that*] the child or ward is an Indian
28 child and the child or ward is in the legal custody of the department but has
29 been placed in the physical custody of the parent or a person who was ap-
30 pointed the child’s or ward’s legal guardian prior to placement of the child

1 or ward in the legal custody of the department, the court may order that the
2 child or ward be placed in the physical custody of a substitute care provider
3 only after making all of the inquiry, notice and findings required under ORS
4 419B.305 and 419B.310.

5 “(6) In making the findings under subsection (2) of this section, the court
6 shall consider the efforts made to develop the concurrent case plan, includ-
7 ing, but not limited to, identification of appropriate permanent placement
8 options for the child or ward both inside and outside this state and, if
9 adoption is the concurrent case plan, identification and selection of a suit-
10 able adoptive placement for the child or ward.

11 “(7)(a) If [*there is reason to know, as described in section 15, chapter 14,*
12 *Oregon Laws 2020 (first special session), that*] the child or ward is an Indian
13 child, the findings of the court shall specifically state whether the depart-
14 ment has provided active efforts to reunify the Indian child with the Indian
15 child’s parent or Indian custodian.

16 “(b) If the court finds that active efforts have not been provided, the court
17 shall order that the Indian child be immediately returned to the Indian
18 child’s parent.

19 “(c) Notwithstanding paragraph (b) of this subsection, if the court finds
20 that returning the Indian child to the Indian child’s parent will result in
21 substantial and immediate danger or threat of danger to the Indian child, the
22 court shall:

23 “(A) Determine the period of time during which active efforts were not
24 provided;

25 “(B) Order the department to provide those services necessary for the
26 provision of active efforts;

27 “(C) Order the department to continue placement of the Indian child
28 pursuant to the placement preferences under section 23, chapter 14, Oregon
29 Laws 2020 (first special session); and

30 “(D) Order the department to continue to foster relationships with any

1 individuals identified by the department as long-term placement resources
2 meeting the placement preferences under section 23, chapter 14, Oregon Laws
3 2020 (first special session).

4 “(8) In addition to findings of fact required by subsection (2) of this sec-
5 tion, the court may order the department to consider additional information
6 in developing the case plan or concurrent case plan.

7 “(9) Any final decision of the court made pursuant to the hearing provided
8 in subsection (1) of this section is appealable under ORS 419A.200.

9 **“SECTION 74.** ORS 419B.452, as amended by section 59, chapter 14,
10 Oregon Laws 2020 (first special session), is amended to read:

11 “419B.452. Except when a child or ward has been surrendered for adoption
12 or the parents’ rights have been terminated, the court shall send a copy of
13 the report required by ORS 419B.440 to the parents and shall notify the
14 parents either that a hearing will be held or that the parents may request
15 a hearing at which time they may ask for modifications in the care, treat-
16 ment and supervision of the child or ward. If the court finds that informing
17 the parents of the identity and location of the foster parents of the child or
18 ward is not in the best interest of the child or ward, the court may order
19 such information deleted from the report before sending the report to the
20 parents. *[If there is reason to know, as described in section 15, chapter 14,*
21 *Oregon Laws 2020 (first special session), that an Indian child is involved]* **If**
22 **the child is an Indian child**, the court shall send a copy of the report to
23 the Indian child’s tribe as required by the notice requirements under section
24 16, chapter 14, Oregon Laws 2020 (first special session).

25 **“SECTION 75.** ORS 419B.532, as amended by section 51, chapter 14,
26 Oregon Laws 2020 (first special session), is amended to read:

27 “419B.532. (1) As used in this section, ‘former parent’ means a person who
28 was previously the legal parent of a ward and whose parental rights to the
29 ward have been terminated.

30 “(2)(a) In a proceeding under ORS 419B.500, the Department of Human

1 Services or a ward may file a motion to reinstate the parental rights of a
2 former parent if:

3 “(A)(i) The ward has not been adopted; or

4 “(ii) The ward was previously adopted but no longer has a legal parent;

5 “(B) No legal action to achieve the adoption of the ward has been initi-
6 ated under ORS 109.309 or 419B.529;

7 “(C) At least 18 months have passed since entry of the judgment termi-
8 nating the former parent’s parental rights to the ward or, in the event of an
9 appeal, at least six months have passed since issuance of an appellate judg-
10 ment affirming the termination judgment, whichever is later; and

11 “(D) Except as provided in paragraph (b) of this subsection, the ward is
12 at least 12 years of age at the time the motion to reinstate parental rights
13 is filed.

14 “(b) If the ward is under 12 years of age at the time the motion to rein-
15 state parental rights is filed, the court may allow the motion upon a showing
16 of good cause.

17 “(3) A motion to reinstate parental rights under this section must be in
18 writing and state with particularity the factual and legal grounds for the
19 motion.

20 “(4) The moving party shall provide a copy of the motion to reinstate
21 parental rights to the former parent and shall notify the court, the parties
22 and, if there is reason to know[, *as described in section 15, chapter 14, Oregon*
23 *Laws 2020 (first special session),*] that the ward is an Indian child, the tribe
24 that a copy of the motion has been provided.

25 “(5) If a motion to reinstate parental rights does not state a prima facie
26 case as to the facts that must be proved under subsection (6) of this section,
27 the court may deny the motion without a hearing.

28 “(6)(a) If a motion to reinstate parental rights states a prima facie case
29 as to the facts that must be proved under this subsection, the court shall
30 hold a hearing on the merits of the motion. The court shall grant the motion

1 if the moving party proves by clear and convincing evidence that:

2 “(A) The former parent’s conduct and conditions that led to the termi-
3 nation of parental rights have been ameliorated and the former parent is
4 presently fit;

5 “(B) The former parent wishes to have parental rights reinstated;

6 “(C) The ward consents to the reinstatement of parental rights; and

7 “(D) Reinstatement of parental rights is in the ward’s best interests.

8 “(b) In determining whether reinstatement of parental rights is in the
9 ward’s best interests under paragraph (a) of this subsection, the court shall
10 consider:

11 “(A) The ward’s health, safety, permanency, age, maturity and ability to
12 express the ward’s preferences;

13 “(B) The reasons that the former parent’s parental rights were terminated;

14 “(C) The former parent’s stated reasons for wishing to have parental
15 rights reinstated; and

16 “(D) The likely impact on the ward of the former parent’s past abuse or
17 neglect.

18 “(c) The moving party shall provide notice to the former parent of a
19 hearing on the merits under paragraph (a) of this subsection.

20 “(d) The department shall establish by rule procedures for investigating
21 the present fitness of the former parent and for providing appropriate reu-
22 nification services.

23 “(7) If the court grants the motion to reinstate parental rights under
24 subsection (6) of this section:

25 “(a) The court shall enter an order reinstating parental rights that shall
26 restore all parental rights and duties of the former parent as to the ward;

27 “(b) The ward shall continue as a ward of the court for at least six
28 months after entry of the order reinstating parental rights; and

29 “(c) The court shall conduct a permanency hearing as provided in ORS
30 419B.470 within 60 days after entering the order under paragraph (a) of this

1 subsection.

2 “(8) An order reinstating parental rights under this section does not va-
3 cate or otherwise affect the validity of the original judgment terminating the
4 parental rights of the former parent except to the extent that the order
5 reinstates parental rights.

6 “(9) In any proceeding under this section, the ward is entitled to have
7 counsel appointed at state expense if the ward is determined to be financially
8 eligible under the policies, procedures, standards and guidelines of the Public
9 Defense Services Commission.

10 **“SECTION 76.** ORS 419B.878, as amended by section 40, chapter 14,
11 Oregon Laws 2020 (first special session), is amended to read:

12 “419B.878. (1) When a court conducts a hearing, the court shall inquire
13 **and make a finding, [as described in] subject to the procedures under**
14 **section 15 (4), chapter 14, Oregon Laws 2020 (first special session), regard-**
15 **ing** whether a child is an Indian child.

16 “(2) If the court [*knows or has reason to know that an Indian child is in-*
17 *volved*] **enters an order described in section 15 (4)(b), chapter 14, Oregon**
18 **Laws 2020 (first special session), directing that the child be treated as**
19 **an Indian child**, the court shall enter an order requiring the Department
20 of Human Services to comply with the inquiry and notice provisions of
21 sections 15 and 16, chapter 14, Oregon Laws 2020 (first special session)[, *and*
22 *shall enter an order that the child be treated as an Indian child until such*
23 *time as the court determines that the child is not an Indian child*].

24 **“SECTION 77.** ORS 419B.923, as amended by section 60, chapter 14,
25 Oregon Laws 2020 (first special session), is amended to read:

26 “419B.923. (1) Except as otherwise provided in this section, on motion and
27 such notice and hearing as the court may direct, the court may modify or
28 set aside any order or judgment made by it. Reasons for modifying or setting
29 aside an order or judgment include, but are not limited to:

30 “(a) Clerical mistakes in judgments, orders or other parts of the record

1 and errors in the order or judgment arising from oversight or omission.
2 These mistakes and errors may be corrected by the court at any time on its
3 own motion or on the motion of a party and after notice as the court orders
4 to all parties who have appeared. During the pendency of an appeal, an order
5 or judgment may be corrected as provided in subsection (7) of this section.

6 “(b) Excusable neglect.

7 “(c) Newly discovered evidence that by due diligence could not have been
8 discovered in time to present it at the hearing from which the order or
9 judgment issued.

10 “(2) A motion to modify or set aside an order or judgment or request a
11 new hearing must be accompanied by an affidavit that states with reasonable
12 particularity the facts and legal basis for the motion.

13 “(3) A motion to modify or set aside an order or judgment must be made
14 within a reasonable time except no order or judgment pursuant to ORS
15 419B.527 may be set aside or modified during the pendency of a proceeding
16 for the adoption of the ward, nor after a petition for adoption has been
17 granted.

18 “(4) Except as provided in subsection (6) of this section, notice and a
19 hearing as provided in ORS 419B.195, 419B.198, 419B.201, 419B.205, 419B.208,
20 419B.310, 419B.325 and 419B.893 must be provided in any case when the effect
21 of modifying or setting aside the order or judgment will or may be to deprive
22 a parent of the legal custody of the child or ward, to place the child or ward
23 in an institution or agency or to transfer the child or ward from one insti-
24 tution or agency to another. The provisions of this subsection do not apply
25 to a parent whose rights have been terminated under ORS 419B.500 to
26 419B.524 or whose child has been permanently committed by order or judg-
27 ment of the court unless an appeal from the order or judgment is pending.

28 “(5) When *[there is]* **the person giving notice has** reason to know, as
29 described in section 15, chapter 14, Oregon Laws 2020 (first special session),
30 that an Indian child is involved, notice must be provided as required under

1 section 16, chapter 14, Oregon Laws 2020 (first special session).

2 “(6) Except when the child or ward is an Indian child, notice and a
3 hearing are not required when the effect of modifying or setting aside the
4 order or judgment will be to transfer the child or ward from one foster home
5 to another.

6 “(7) A motion under subsection (1) of this section may be filed with and
7 decided by the trial court during the time an appeal from a judgment is
8 pending before an appellate court. The moving party shall serve a copy of
9 the motion on the appellate court. The moving party shall file a copy of the
10 trial court’s order or judgment in the appellate court within seven days of
11 the date of the trial court order or judgment. Any necessary modification of
12 the appeal required by the court order or judgment must be pursuant to rule
13 of the appellate court.

14 “(8) This section does not limit the inherent power of a court to modify
15 an order or judgment within a reasonable time or the power of a court to
16 set aside an order or judgment for fraud upon the court.

17

18 **“FULL FAITH AND CREDIT AND INDIAN CHILD CUSTODY PRO-**
19 **CEEDINGS**

20

21 **“SECTION 78.** Section 63, chapter 14, Oregon Laws 2020 (first special
22 session), is amended to read:

23 **“Sec. 63.** The juvenile court shall give full faith and credit to the public
24 acts, records and judicial proceedings of an Indian tribe applicable to an
25 Indian **child in a** child custody proceeding, **as defined in section 2, chap-**
26 **ter 14, Oregon Laws 2020 (first special session).**

27

28 **“CONFLICT OF LAWS AND ICWA**

29

30 **“SECTION 79.** Section 64, chapter 14, Oregon Laws 2020 (first special

1 session), is amended to read:

2 “**Sec. 64.** (1) If any provision of **section 7, 19, 32, 33, 39 or 65a of this**
3 **2021 Act**, sections 1 to 23, **chapter 14, Oregon Laws 2020 (first special**
4 **session)**, [*of this 2020 special session Act*] or the amendments to statutes
5 [*by sections 24 to 60 of this 2020 special session Act*] **and session law by**
6 **sections 1 to 5, 8 to 17, 20 to 30, 34 to 37, 40 to 64 and 65b to 78 of this**
7 **2021 Act** is found to [*contravene*] **provide a lower standard of protection**
8 **to the rights of an Indian child or the Indian child’s parent, Indian**
9 **custodian or tribe than** the Indian Child Welfare Act [*(25 U.S.C. 1901 et*
10 *seq.)*],]:

11 “(a) **The higher standard of protection in the Indian Child Welfare**
12 **Act shall control; and**

13 “(b) It shall not serve to render inoperative any remaining provisions of
14 **section 7, 19, 32, 33, 39 or 65a of this 2021 Act**, sections 1 to 23, **chapter**
15 **14, Oregon Laws 2020 (first special session)**, [*of this 2020 special session*
16 *Act*] or the amendments to statutes [*by sections 24 to 60 of this 2020 special*
17 *session Act*] **and session law by sections 1 to 5, 8 to 17, 20 to 30, 34 to**
18 **37, 40 to 64 and 65b to 78 of this 2021 Act** that may be held [*not to conflict*
19 *with*] **to provide a higher standard of protection than** the Indian Child
20 Welfare Act.

21 “(2) **As used in this section, ‘Indian Child Welfare Act’ means the**
22 **federal Indian Child Welfare Act (25 U.S.C. 1901 et seq.) and related**
23 **regulations.**

24

25 “**REPORT TO INTERIM COMMITTEES ON JUDICIARY**

26

27 “**SECTION 80.** Section 61, chapter 14, Oregon Laws 2020 (first special
28 session), is amended to read:

29 “**Sec. 61.** No later than September 15 of every even-numbered year, the
30 Department of Human Services and the Judicial Department shall report to

1 the interim committees of the Legislative Assembly relating to children re-
2 garding:

3 “(1) The number of Indian children involved in dependency proceedings
4 during the prior two-year period.

5 “(2) The average duration Indian children were in protective custody.

6 “(3) The ratio of Indian children to non-Indian children in protective
7 custody.

8 “(4) Which tribes the Indian children in protective custody were members
9 of or of which they were eligible for membership.

10 “(5) The number of Indian children in foster care who are in each of the
11 placement preference categories described in section 23, **chapter 14, Oregon**
12 **Laws 2020 (first special session)**, [*of this 2020 special session Act*] and the
13 number of those placements that have Indian parents in the home.

14 “(6) The number of Indian children placed in adoptive homes in each of
15 the placement preference categories described in section 23, **chapter 14,**
16 **Oregon Laws 2020 (first special session)**, [*of this 2020 special session Act*]
17 and the number of those placements that have Indian parents in the home.

18 “(7) The number of available placements and common barriers to recruit-
19 ment and retention of appropriate placements.

20 “(8) The number of times the court [*determined*] **found** that good cause
21 existed to deviate from the statutory placement preferences under section
22 **23, chapter 14, Oregon Laws 2020 (first special session)**, **when making**
23 **a finding regarding the placement of a child in a dependency proceed-**
24 **ing** [*of this 2020 special session Act*].

25 “(9) The number of cases that were transferred to tribal court under sec-
26 tion 14, **chapter 14, Oregon Laws 2020 (first special session)** [*of this 2020*
27 *special session Act*].

28 “(10) The number of times the court found good cause to decline to
29 transfer jurisdiction of a [*case*] **dependency proceeding** to tribal court upon
30 request and the most common reasons the court found good cause to decline

1 a transfer petition.

2 “(11) The efforts the Department of Human Services and the Judicial De-
3 partment have taken to ensure compliance with the provisions of sections 1
4 to 23, **chapter 14, Oregon Laws 2020 (first special session)**, [*of this 2020*
5 *special session Act*] and the amendments to statutes by sections 24 to 60,
6 **chapter 14, Oregon Laws 2020 (first special session)**, in dependency
7 **proceedings** [*of this 2020 special session Act*].

8 “(12) **The number of ICWA compliance reports, as defined in ORS**
9 **109.304, in which the department reported the petitioner’s documenta-**
10 **tion was insufficient for the court to make a finding regarding**
11 **whether the petitioner complied with the inquiry or notice require-**
12 **ments under section 15 (2) or 16 (2), chapter 14, Oregon Laws 2020 (first**
13 **special session).**

14 “(13) **The total number and the ratio of all ICWA compliance re-**
15 **ports that indicated there was a reason to know that the child was an**
16 **Indian child.**

17 **“SECTION 81. No later than March 15, 2024, the Department of**
18 **Human Services shall submit a report to the interim committees of**
19 **the Legislative Assembly related to the judiciary describing the**
20 **department’s implementation of tribal customary adoption as de-**
21 **scribed in section 65a of this 2021 Act, as an alternative permanency**
22 **option for wards who are Indian children and the department’s rec-**
23 **ommendations for proposed legislation to improve the tribal custom-**
24 **ary adoption process.**

25

26 **“CHILD WELFARE SERVICE PROVIDERS**

27

28 **“SECTION 82. (1) It is the policy of this state that an individual**
29 **may not be disqualified from providing child welfare services to a child**
30 **or ward:**

1 “(a) For the sole reason that the individual received child welfare
2 services as a child or youth;

3 “(b) For the sole reason that the individual is a person with a dis-
4 ability; or

5 “(c) On the basis of race, religion, national origin, sex, age, marital
6 status, sexual orientation, gender expression or disability.

7 “(2) Subsection (1) of this section applies to any person providing
8 child welfare services to a child or ward, including but not limited to
9 foster parents, proctor foster parents, adoptive parents, relative
10 caregivers, safety providers and direct service providers.

11

12 “NONRETALIATION AGAINST CHILDREN, WARDS AND YOUTH

13

14 “SECTION 83. It is the policy of this state that a child, ward or
15 youth may not be prohibited from, disciplined for or retaliated against
16 for publicly or privately speaking about the child, ward or youth’s ex-
17 perience receiving child welfare services.

18

19 “MISCELLANEOUS

20

21 “SECTION 84. (1) The amendments to section 61, chapter 14, Oregon
22 Laws 2020 (first special session), by section 80 of this 2021 Act become
23 operative on January 2, 2023.

24 “SECTION 85. (1) Sections 7, 19, 32, 33, 39 and 65a of this 2021 Act
25 and the amendments to statutes and session law by sections 1 to 5, 8
26 to 17, 20 to 30, 34 to 37, 40 to 64 and 65b to 79 of this 2021 Act become
27 operative on January 2, 2022.

28 “(2) The Department of Justice, Department of Human Services and
29 State Court Administrator may take any action before the operative
30 date specified in subsection (1) of this section that is necessary for the

1 department or administrator to exercise, on and after the operative
2 date specified in subsection (1) of this section, all of the duties, func-
3 tions and powers conferred on the department or the administrator
4 by sections 7, 19, 32, 33, 39 and 65a of this 2021 Act and the amendments
5 to statutes and session law by sections 1 to 5, 8 to 17, 20 to 30, 34 to
6 37, 40 to 64 and 65b to 79 of this 2021 Act.

7 **“SECTION 86. The unit captions used in this 2021 Act are provided
8 only for the convenience of the reader and do not become part of the
9 statutory law of this state or express any legislative intent in the
10 enactment of this 2021 Act.**

11 **“SECTION 87. This 2021 Act being necessary for the immediate
12 preservation of the public peace, health and safety, an emergency is
13 declared to exist, and this 2021 Act takes effect on its passage.”.**
