30 "(b) Complies with United States Environmental Protection Agency poli-

cies and regulations related to private metal property, including testing and
labeling requirements;

"(c) Maintains a fixed place of business at which the person engages in
the business of selling vehicle repair parts;

"(d) Holds any licenses required by federal or state law or local ordinance
for conducting all applicable business activity;

7 "(e) Clearly and legibly marks the private metal property:

8 "(A) With the vehicle identification number of the vehicle from which the
9 private metal property was removed or with an alternative number;

"(B) With the date the private metal property was removed from the ve-hicle; and

"(C) In English and in a permanent manner, including but not limited to engraving or the use of permanent ink or a permanent label; and

"(f) Provides the vehicle identification number of the vehicle from which the private metal property was removed upon the request of a law enforcement official, if the person used an alternative number instead of the vehicle identification number.".

apply to conduct occurring on or after the effective date of this 2021
