

Requested by Senator HANSELL

**PROPOSED AMENDMENTS TO  
A-ENGROSSED HOUSE BILL 2221**

1 Delete lines 4 through 22 of the printed A-engrossed bill and insert:

2 **“SECTION 1. (1) As used in this section:**

3 **“(a) ‘State agency’ means any state officer, board, commission,**  
4 **corporation, institution, department or other state organization in the**  
5 **executive department, as defined in ORS 174.112, or legislative depart-**  
6 **ment, as defined in ORS 174.114.**

7 **“(b) ‘State agency,’ notwithstanding ORS 182.460, 284.118, 284.375,**  
8 **377.836, 421.352 and 757.552, includes semi-independent state agencies**  
9 **listed in ORS 182.454, the Oregon Tourism Commission, the Oregon**  
10 **Film and Video Office, the Travel Information Council, the Children’s**  
11 **Trust Fund of Oregon Foundation, Oregon Corrections Enterprises and**  
12 **the Oregon Utility Notification Center.**

13 **“(c) ‘State agency’ includes a public university listed in ORS 352.002.**

14 **“(2) No later than 30 days after a state agency begins paying an**  
15 **employee an annual salary greater than the amount determined under**  
16 **subsection (3) of this section, the state agency shall ensure that the**  
17 **following information is accessible to the general public on the Inter-**  
18 **net:**

19 **“(a) The source of funds for the salary; and**

20 **“(b) An explanation of why the salary is justified based on wage**  
21 **data for comparable positions.**

1       **“(3)(a) For calendar year 2022, subsection (2) of this section applies**  
2 **to annual salaries greater than \$250,000.**

3       **“(b) Beginning in 2022, and every year thereafter, the Oregon De-**  
4 **partment of Administrative Services shall determine the percentage**  
5 **increase or decrease in the cost of living for the previous calendar**  
6 **year, based on changes in the Consumer Price Index for All Urban**  
7 **Consumers, West Region (All Items), as published by the Bureau of**  
8 **Labor Statistics of the United States Department of Labor. On or be-**  
9 **fore July 1 of the year in which the Oregon Department of Adminis-**  
10 **trative Services makes the determination required by this subsection,**  
11 **the department shall adjust the annual salary amount to which sub-**  
12 **section (2) of this section applies for the following calendar year by**  
13 **multiplying the annual salary amount applicable to the calendar year**  
14 **in which the adjustment is made by the percentage amount deter-**  
15 **mined under this subsection. The adjusted annual salary amount ap-**  
16 **plies to payments to employees on or after January 1 of the subsequent**  
17 **year.**

18       **“(4) A public university listed in ORS 352.002 is required to comply**  
19 **with this section only with regard to positions funded with general**  
20 **funds available to the university that consist of student tuition and**  
21 **state appropriations.**

22       **“(5) A state agency subject to ORS chapter 240 satisfies the re-**  
23 **quirements of subsection (2) of this section if the Oregon Department**  
24 **of Administrative Services publishes the information required by sub-**  
25 **section (2) of this section on the department’s website at least**  
26 **biennially.**

27       **“(6)(a) A state agency subject to ORS chapter 240 shall report**  
28 **biennially to the Oregon Department of Administrative Services on**  
29 **employees subject to this section.**

30       **“(b) A state agency not subject to ORS chapter 240 shall report**

1 **biennially to an appropriate committee or interim committee of the**  
2 **Legislative Assembly on employees subject to this section.”.**
