SECTION 5. Notwithstanding any other law limiting expenditures, the amount of \$8,990,705 is established for the biennium beginning July 1, 2021, as the maximum limit for payment of expenses by the Oregon Watershed Enhancement Board from lottery moneys deposited into the Watershed Conservation Operating Fund established under ORS 541.945, for operating expenses, activities and projects to implement Article XV, section 4b, of the Oregon Constitution.

Notwithstanding any other law limiting expenditures, 10 the following amounts are established for the biennium beginning July 11 1, 2021, as the maximum limits for payment of expenses from fees, 12 moneys or other revenues, including Miscellaneous Receipts, but ex-13 cluding lottery funds and federal funds, collected or received by the 14 Oregon Watershed Enhancement Board, for the following purposes:

"SECTION 8. (1) The Oregon Watershed Enhancement Board shall establish by rule a process for allocating on a quarterly basis available moneys in the Natural Resources Subaccount of the Parks and Natural Resources Fund, established under ORS 541.942, to fulfill the biennial allocations made in this 2021 Act. Except as provided in subsection (2) of this section, all quarterly allocations shall be set at one-eighth of the biennial allocations.

HB 5037-1 6/1/21 Proposed Amendments to HB 5037 "(2) If, in any quarter, the moneys transferred from the Oregon State Lottery Fund to the Parks and Natural Resources Fund are insufficient to pay for the quarterly allocations established under subsection (1) of this section, the allocations shall be reduced proportionately by amounts sufficient to accommodate the revenue shortfall.

"SECTION 9. This 2021 Act being necessary for the immediate
preservation of the public peace, health and safety, an emergency is
declared to exist, and this 2021 Act takes effect July 1, 2021.".
