**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 3159**

1 On page 4 of the printed A-engrossed bill, line 26, delete “8 (1)” and insert
2 “11 (1)”.

3 After line 34, insert:

4 **“SECTION 8. Notwithstanding any other provision of law, the**
5 **General Fund appropriation made to the Oregon Health Authority by**
6 **section 1 (3), chapter __, Oregon Laws 2021 (Enrolled House Bill 5024),**
7 **for the biennium beginning July 1, 2021, for central services, state as-**
8 **essments and enterprise-wide costs, is increased by \$9,768,195, for the**
9 **purposes of carrying out sections 1 to 5 of this 2021 Act.**

10 **“SECTION 9. Notwithstanding any other law limiting expenditures,**
11 **the limitation on expenditures established by section 2 (3), chapter __,**
12 **Oregon Laws 2021 (Enrolled House Bill 5024), for the biennium begin-**
13 **ning July 1, 2021, as the maximum limit for payment of expenses from**
14 **fees, moneys or other revenues, including Miscellaneous Receipts, to-**
15 **bacco tax receipts, marijuana tax receipts, beer and wine tax receipts,**
16 **provider taxes and Medicare receipts, but excluding lottery funds and**
17 **federal funds not described in section 2, chapter __, Oregon Laws 2021**
18 **(Enrolled House Bill 5024), collected or received by the Oregon Health**
19 **Authority, for central services, state assessments and enterprise-wide**
20 **costs, is increased by \$5,624,767, for the purposes of carrying out**
21 **sections 1 to 5 of this 2021 Act.**

1 **“SECTION 10. Notwithstanding any other law limiting expenditures,**
2 **the limitation on expenditures established by section 5 (3), chapter __,**
3 **Oregon Laws 2021 (Enrolled House Bill 5024), for the biennium begin-**
4 **ning July 1, 2021, as the maximum limit for payment of expenses from**
5 **federal funds, excluding federal funds described in section 2, chapter**
6 **__, Oregon Laws 2021 (Enrolled House Bill 5024), collected or received**
7 **by the Oregon Health Authority, for central services, state assess-**
8 **ments and enterprise-wide costs, is increased by \$2,842,387, for the**
9 **purposes of carrying out sections 1 to 5 of this 2021 Act.”.**

10 In line 35, delete “8” and insert “11”.

11 In line 43, delete “9” and insert “12”.
