**PROPOSED AMENDMENTS TO
B-ENGROSSED HOUSE BILL 3000**

1 On page 14 of the printed B-engrossed bill, delete lines 9 through 24 and
2 insert:

3 **“SECTION 16a. (1) A person licensed under ORS 571.281 may, within**
4 **the boundaries of this state, transport to or receive from:**

5 **“(a) A person licensed under ORS 571.281 or a laboratory licensed**
6 **under ORS 475B.560 industrial hemp or an industrial hemp commodity**
7 **that contains no more tetrahydrocannabinol than allowed by the State**
8 **Department of Agriculture by rule if the industrial hemp or industrial**
9 **hemp used in the industrial hemp commodity originated from a crop**
10 **inspected under ORS 571.281 (7) that was found to not contain an av-**
11 **erage tetrahydrocannabinol concentration exceeding the concentration**
12 **specified by the department by rule.**

13 **“(b) A person licensed under ORS 475B.090, 475B.100 or 475B.105 in-**
14 **dustrial hemp or an industrial hemp commodity or product that con-**
15 **tains no more tetrahydrocannabinol than allowed by the Oregon**
16 **Liquor Control Commission by rule if the industrial hemp or industrial**
17 **hemp used in the industrial hemp commodity or product originated**
18 **from a crop inspected under ORS 571.281 (7) that was found to not**
19 **contain an average tetrahydrocannabinol concentration exceeding the**
20 **concentration specified by the department by rule.**

21 **“(2) Industrial hemp or an industrial hemp commodity or product**

1 transported or received as described in this section may not be con-
2 sidered a ‘marijuana item.’”.

3 On page 29, after line 14, insert:

7 **“SECTION 46. Notwithstanding any other law limiting expenditures,**
8 **the limitation on expenditures established by section 1 (2), chapter __,**
9 **Oregon Laws 2021 (Enrolled House Bill 5018), for the biennium begin-**
10 **ning July 1, 2021, as the maximum limit for payment of expenses from**
11 **fees, moneys or other revenues, including Miscellaneous Receipts, but**
12 **excluding lottery funds and federal funds, collected or received by the**
13 **Oregon Liquor Control Commission for marijuana regulation - recre-**
14 **ational, is increased by \$399,007.**

15 **“SECTION 47. Notwithstanding any other provision of law, the**
16 **General Fund appropriation made to the Oregon Health Authority by**
17 **section 1 (1), chapter __, Oregon Laws 2021 (Enrolled House Bill 5024),**
18 **for the biennium beginning July 1, 2021, for health systems, health**
19 **policy and analytics, and public health, is increased by \$730,917.**

20 **“SECTION 48. Notwithstanding any other law limiting expenditures,**
21 **the limitation on expenditures established by section 3, chapter __,**
22 **Oregon Laws 2021 (Enrolled House Bill 5005), for the biennium begin-**
23 **ning July 1, 2021, as the maximum limit for payment of expenses from**
24 **fees, moneys or other revenues, including Miscellaneous Receipts, but**
25 **excluding lottery funds and federal funds, collected or received by the**
26 **Oregon Criminal Justice Commission, is increased by \$3,000,000 for**
27 **additional Illegal Marijuana Market Enforcement Grant Program**
28 **grants.”.**

29 In line 18, delete “45a” and insert “49”.

30 In line 32, delete “46” and insert “50”.

1 In line 38, delete "47" and insert "51".
