**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 749**

1 On page 2 of the printed A-engrossed bill, after line 41, insert:

2 “(d) The date of the referral agent’s last visit to the facility and whether
3 the visit was in person or a virtual tour as permitted under subsection (2)(b)
4 of this section.”.

5 Delete line 45.

6 On page 3, delete line 1 and insert:

7 “(b) Refer a client to a residential care program unless within the prior
8 24 months, the agent has personally toured the program or, if the tour oc-
9 curred during a time when personal tours were prohibited by a federal, state
10 or local emergency declaration, virtually toured the program.”.

11 In line 41, delete “\$750” and insert “\$325”.

12 In line 43, delete “\$750” and insert “\$325”.

13 On page 6, after line 27, insert:

14 **“SECTION 5. Notwithstanding any other provision of law, the**
15 **General Fund appropriation made to the Department of Human Ser-**
16 **vices by section 1 (2), chapter __, Oregon Laws 2021 (Enrolled Senate**
17 **Bill 5529), for the biennium beginning July 1, 2021, for state assess-**
18 **ments and enterprise-wide costs, is increased by \$467,993, which may**
19 **be expended for carrying out the provisions of this 2021 Act.**

20 **“SECTION 6. Notwithstanding any other law limiting expenditures,**
21 **the limitation on expenditures established by section 2 (2), chapter __,**

1 **Oregon Laws 2021 (Enrolled Senate Bill 5529), for the biennium begin-**
2 **ning July 1, 2021, as the maximum limits for payment of expenses from**
3 **fees, moneys or other revenues, including Miscellaneous Receipts and**
4 **Medicare receipts and including federal funds for indirect cost recov-**
5 **ery, Social Security Supplemental Security Income recoveries and the**
6 **Child Care and Development Fund, but excluding lottery funds and**
7 **federal funds not described in section 2, chapter __, Oregon Laws 2021**
8 **(Enrolled Senate Bill 5529), collected or received by the Department**
9 **of Human Services, for state assessments and enterprise-wide costs,**
10 **is increased by \$10,660 for the purpose of carrying out the provisions**
11 **of this 2021 Act.**

12 **“SECTION 7. Notwithstanding any other law limiting expenditures,**
13 **the limitation on expenditures established by section 2 (8), chapter __,**
14 **Oregon Laws 2021 (Enrolled Senate Bill 5529), for the biennium begin-**
15 **ning July 1, 2021, as the maximum limits for payment of expenses from**
16 **fees, moneys or other revenues, including Miscellaneous Receipts and**
17 **Medicare receipts and including federal funds for indirect cost recov-**
18 **ery, Social Security Supplemental Security Income recoveries and the**
19 **Child Care and Development Fund, but excluding lottery funds and**
20 **federal funds not described in section 2, chapter __, Oregon Laws 2021**
21 **(Enrolled Senate Bill 5529), collected or received by the Department**
22 **of Human Services, for shared services, is increased by \$628,913 for the**
23 **purpose of carrying out the provisions of this 2021 Act.**

24 **“SECTION 8. Notwithstanding any other law limiting expenditures,**
25 **the limitation on expenditures established by section 3 (2), chapter __,**
26 **Oregon Laws 2021 (Enrolled Senate Bill 5529), for the biennium begin-**
27 **ning July 1, 2021, as the maximum limit for payment of expenses from**
28 **federal funds, excluding federal funds described in section 2, chapter**
29 **__, Oregon Laws 2021 (Enrolled Senate Bill 5529), collected or received**
30 **by the Department of Human Services, for state assessments and**

1 **enterprise-wide costs, is increased by \$253,709 for the purpose of car-**
2 **rying out the provisions of this 2021 Act.”.**

3 In line 28, delete “5” and insert “9”.

4 In line 35, delete “6” and insert “10”.

5 In line 37, delete “7” and insert “11”.
