**Re: I OPPOSE [SJM 4]&[SB 618]&[SB 619]...WITH EXTREME PREJUDICE!**

[SJM 4]&[SB 618]&[SB 619] are individual and separate, racist legislation, intentionally designed to; support, promulgate, defend and institutionalize the, "*Black Victimhood Industrial Complex*" at taxpayer's expense.

**This legislation is racist, divisive and attempts to incorporate systemic racism into Oregon law.**

[SJM 4] **exerts:** "Whereas as a result of historical and continued discrimination, African American descendants of slaves continue to suffer debilitating economic, educational and health hardships, including an unemployment rate more than twice the current white unemployment rate and an average of six percent of the wealth of white families, a disparity which has worsened, not improved, over time; and Whereas African Americans have been unjustly targeted by law enforcement and criminal justice procedures, incarcerated at disproportionate rates and subsequently excluded from full participation in the benefits of citizenship that include voting, employment, housing and health care; and Whereas a preponderance of scholarly and legal evidentiary documentation constitutes the basis for inquiry into the ongoing effects of the institution of chattel slavery and its legacy of persistent systemic structures of discrimination on living African descendants of slaves in the United States;"

***There is more of this cry-baby-bullsh\*t. Citizens really need to read all of it to appreciate the blatant racism.***

[SB 618]: "SECTION 1. The Oregon Department of Administrative Services shall study methods of providing reparations for slavery to Black Oregonians and report to an appropriate committee or interim committee of the Legislative Assembly no later than September 15, 2022. SECTION 2. Section 1 of this 2021 Act is repealed on January 2, 2023."

***\*I recommend the aforementioned Department of Administrative Services, give the author(s) of [SB 618] the "finger" and refuse to comply using terse and profane language in the poignant communicative process.***

[SB 619] **exerts:** "The Department of Revenue shall establish a program to pay reparations to Black Oregonians who can demonstrate heritage in slavery and who submit an application to the department no later than December 31, 2022.

**(3) The department shall pay to each eligible applicant the amount of \$123,000 in the form of an annuity payable annually for the life of the applicant."**
