Dear Chair Patterson and Members of the Committee:

On behalf of the American Society for Reproductive Medicine (ASRM), I write to express **support for Senate Bill 168**, requiring health benefit plans to cover fertility and reproductive endocrinology services for men and women.

ASRM is a multidisciplinary organization of nearly 8,000 professionals dedicated to the advancement of the science and practice of reproductive medicine. Distinguished members of ASRM include obstetricians and gynecologists, urologists, reproductive endocrinologists, embryologists, mental health professionals and others.

Infertility, recognized by the American Medical Association and the World Health Organization as a disease that impacts as many as 7.3 million couples in the United States, can, untreated, upend the dream of building a family. ASRM strongly supports efforts to ensure that all Americans – regardless of zip code, race, ethnicity, sexual orientation or economic status – can access affordable, equitable reproductive medicine.

Fertility treatments are expensive and whether or not they will be covered by insurance can be dependent upon one's economic status or employer. Despite significant strides in coverage in recent years, many patients still pay thousands of dollars for infertility care out of pocket. In fact, research shows only one in four people get the treatment they need to overcome infertility, and cost is the top-cited barrier to care. The average cost of an IVF cycle in the United States is approximately \$15,000. Sixty-seven percent of patients report spending \$10,000 or more to build their families.
