RE: SB 148 Support for IDA Initiative

Dear Chair Jama, Vice-Chair Linthicum, and Members of the Committee,

Our Children Oregon's (OCO) mission is to be a voice and force for the common good for all Oregon children, ensuring all children have the resources and opportunities they need to reach their full potential. OCO is the result of the merger between two historic Oregon non-profits: The Children's Trust Fund of Oregon and Children First For Oregon. We elevate data and lived experience to prioritize children and center communities. We continue to connect a community of 115 advocates, coalitions, and organizations through The Children's Agenda, a legislative agenda championing equitable state legislative policies and shared investments to improving the lives of Oregon's children and their families.

Strengthening the Oregon Individual Development Account (IDA) Initiative is a priority issue on the 2021 Children's Agenda. We support the renewal of the IDA Initiative Tax Credit for the next six years. In addition, we support the request of the IDA Initiative for additional funding of \$7 million in General Fund appropriations in the next biennium as more Oregonians seek to participate in this important program.

IDAs have been a life-changing way to help low-income Oregonian families gain financial stability and raise their children with the resources to grow up healthy and the opportunities to achieve their full potential. Through the Oregon IDA Initiative's matched savings program and financial skill-building services, families can build towards important goals like owning a home and sending their kids to college.

Even before the pandemic, many children in Oregon were living in households impacted by economic insecurity. Data in 2018 from the Annie E. Casey Foundation Key Indicators showed that 1 in 6 children in Oregon lived in poverty, 1 in 3 lived in households where parents lacked secure employment, and 1 in 3 lived in households with a high housing cost burden.

<a href="Oregon Households with Children">Oregon Households with Children</a>, based on data from the U.S. Census Bureau's Household Pulse Survey, households with children had less confidence in their ability to make the next month's housing payment compared to households without children.

More than 3,500 Oregonians are currently saving in IDAs, and more than 15,000 have saved since the program's creation in 1999. Collectively, IDA savers have saved more than \$28 million of their own money in order to pursue the goals of purchasing their own home, starting a small business, paying for college, or preparing for unforeseen emergencies. Post-saver surveys have indicated that IDA savers also demonstrate improved financial capabilities in areas such as saving and budgeting.

IDAs offer matched savings which can support families and communities facing the financial impacts of COVID. IDAs can both help people keep from falling behind, and position people to stabilize and move forward as recovery begins. In times of crisis like COVID-19 and the wildfires, IDAs are one of the best tools we have to support families who are financially hit the hardest, including those with low-incomes and communities of color. By supporting SB 148, we are investing in an equitable recovery for all Oregonian communities. IDAs are already in place and ready to make a difference in our community.
