Re: **I OPPOSE [HB 3230]**...*Taxpayer's may not want to pay taxes to the State of Oregon any more.*

**[HB 3230] exert states**, "SECTION 1. (1) The universal representation program is established in the Oregon Department of Administrative Services. **The department shall contract with a nonprofit organization registered in this state for at least the preceding six months that addresses and executes worker relief as the organization's primary purpose to serve as the fiscal agent to award grants to organizations to provide services related to immigration matters, including but not limited to:** (a) Legal services; (b) Community-embedded navigators to guide persons who are at risk of deportation into accessing universal representation; (c) Assistance with case costs for immigration legal services in affirmative applications and removal defense, including bond proceedings and merit proceedings for detained persons; (d) Development of capacity and training to support immigration legal service providers and community navigation;..."

**[HB 3230] exert states**, "SECTION 3. In addition to and not in lieu of any other appropriation, there is appropriated to the Oregon Department of Administrative Services, **for the biennium beginning July 1, 2021, out of the General Fund, the amount of \$10,000,000, for purposes of implementing section 1 of this 2021 Act. SECTION 4.** This 2021 Act being necessary for the immediate preservation of the public peace, health and safety, **an emergency is declared to exist**, and this 2021 Act takes effect on its passage."

[\$10,000,000] of taxpayer's money to set-up a "law firm" to aid and abet illegal immigration by providing "free legal services." This is yet another abomination emanating from the rat-infested Politburo in Salem.
