- Worked with SRCI Management Peggy H Miller and Kurt Larson to start the Meals on Wheels and Malheur County on Aging and Community services (MCACS) food programs, which have served over 40,000 Hot and frozen meals to homebound, poverty stricken and underrepresented senior citizens in the cities of Vale, Nyssa and Ontario, OR. This program continues today.
- Served as Chair and Vice Chair of the Multicultural Group.
- Ran and help run the Native American group.
- -One of the founders and artists of the Native American Prison Art project (NAPAP) whose state and nationwide sales have helped Clackamas County based 501(c)3 Red Lodge Transitional services to purchase a home in Clackamas County which is used to provide safe and sober transitional housing to Native American women who are paroling to society from Coffee Creek Correctional Facility and need a safe home and transitional services.
- -Original Artist and mentor for the African American Art Program (AAAP) at SRCI which partners with Bend, OR based 501(c)3
- -Visions of Hope. Inmate art sales from this program has generated over \$300,000 for VOH.
- Corresponded with my sentencing Judge Michael H. Marcus and various SRCI management to set up fundraisers to help support the local school children of the Ontario School District, which has the 12th highest poverty level of the 197 school districts in Oregon.
- Spent four years working with Walmart, The Boys and Girls Club of America, Krispy Kreme, SRCI Superintendant B.Cain and met with ODOC Director Collette Peters to try and create a sustainable community bridge to support the local school children through donut fundraisers. Although the Krispy Kreme fundraiser never got scheduled, there is currently a similar fundraiser on the agenda for mid 2021, which is donut sales to purchase backpacks and school supplies for the children of the Ontario School District.
- -Personal donations of items to the "Christmas Shoebox Project" through Morning Sun Yellow Pony and Take A Stand Ministries to provide boxes of needed items to the homeless and youth (ages 0-18) in need.
- -Personal donations of stuffed animals to kids with cancer in an Australian hospital.
- I do my best to be a good representative of the inmates at SRCI and participate in many other projects including making hundreds of "origami cranes". I was also quoted in the local paper, The Argus Observer, August 30, 2017, about our Native American Pow Wow and the purpose of our annual gathering. Prison pow wow article:
