Senators & Representatives,

GREETINGS AND GOOD MORNING/AFTERNOON. MY NAMES DANIEL NEPOMUCENO, AN INMATE AT THE OREGON DEPARTMENT OF CORRECTIONS. I RECENTLY CAME ACROSS INFORMATION CONCERNING BILL, SB 141 - RETROACTIVE., THAT IS ASKING FOR THOSE SENTENCE UNDER MEASURE 110 TO BE ALLOWED TO EARN GOOD TIME. BEING AN INDIVIDUAL CONVICTED AND SENTENCE UNDER SAID MEASURE, I WANTED TO REACH OUT AND SHARE MY THOUGHTS, REASONS, AND REALITY OF THE NEGATIVE AND ADVERSE EFFECTS IT HAS ON US AS INMATES, AND TO AN EXTENT ON OUR FELLOW OREGONIANS.

IVE BEEN INCARCERATED FOR 8½ YEARS, ON A MANDATORY MINIMUM SENTENCE OF 25 YEARS. MY MANDATORY SENTENCE HAS NO GOOD TIME TO EARN, OR TO EARN A SENTENCE REDUCTION, AND HAS LESSER INCENTIVES AVAILABLE. THEREBY, MY REHABILITATION OPPORTUNITIES AND PRIORITY IS MINIMAL TO NONE. I BELIEVE THIS FORM OF IMPRISONMENT IS DISCOURAGING, UNUSUAL, DRACONIAN, AND COUNTER-PRODUCTIVE TO ONES GROWTH AND DEVELOPMENT OF WORK/LIFE SKILLS, AND IT LIVES US NO HOPE AND REASON TO WANT TO TAKE STEPS FORWARD. FURTHERMORE, IT STRIKES US OUT WITH OUR COUNSELORS, STAFF, PAROLE BOARD, ETC., TO BE CATEGORIZED AS "NON-IMPORTANT" AND "HIGH RISK", DUE TO OUR 110 SENTENCE. FOR EXAMPLE, WHEN I ARRIVED AT TCCI I CONTACTED MY COUNSELOR AND ABOUT A WEEK LATER I GOT A PRE-WRITTEN RESPONSE SAYING, BECAUSE OF MY ACRES SCORE /SENTENCE I WASNT GUNNA BE AMONGST THEIR "PRIORITY" CASE-

LOAD. I THINK PRISON IS AND SHOULD BE A PLACE TO LEARN FROM ONE'S MISTAKE, UTILIZING IT AS A LESSON TO BE A BETTER PERSON. IT MAKES NO SENSE AT ALL IF PEOPLE ARE LOOKED AWAY WITH MANDATORY SENTENCES AND NOT HAVE OPPORTUNITIES TO EARN TWO TIME / EARN SENTENCE REDUCTION VIA - PRODUCTIVITY, DISPLAYING BETTERMENT & ADVANCEMENT. THESE FEELINGS OF HOPE AND GROWTH WILL SPARK MOTIVATION AND DETERMINATION WITHIN ONE. CHANGE AND ADVANCEMENT BEGINS WITH WILLINGNESS AND AVAILABILITY. AN INCENTIVE WILL HELP TO WORK TOWARD THAT GOAL, EARNING SENTENCE REDUCTION WILL BOOST MORALE AND SELF-WILL, AND MAKE RE-ENTRY TO SOCIETY BETTER, WITH NEW SKILLS WE PREVIOUSLY LACKED. HENCEFORTH, BECOMING A PROACTIVE, ACTIVE, AND POSITIVE COMMUNITY MEMBER, AND MAKING OUR REGION A SAFER PLACE, SO IT DEFEATS THE PURPOSE OF AN INMATE WHO HAS SHOWN CHANGE AND IMPROVEMENT, TO BE KEPT INCARCERATED LONG-TERM.. LASTLY, I THINK IT WOULD ALSO HAVE A POSITIVE IMPACT ON OUR ECONOMY (OREGON). FOR TAX-PAYERS MONEY WOULD BE A SMALLER/LESSER INVESTMENT IN KEEPING / PAYING FOR LONG-TERM INMATES (UNDER M-11). THUS, MORE MONEY WOULD BE AVAILABLE TO RE-DIRECT IT TO THE EDUCATIONAL DEPARTMENT, TRANSPORTATION DEPART., AGRICULTURAL DEPART., CREATE NEW JOBS, ETC.. THIS PROGRESSIVE STATE OF MIND AND UNDERSTANDING CAN ONLY BRING HOPE AND PROSPERITY FOR US ALL AS OREGONIANS. SO YOU HAVE THE OPPORTUNITY TO TRULY SHOW WHAT CAN BE ACCOMPLISHED BY GIVING US (UNDER M-11) A SECOND CHANCE TO DISPLAY OUR FULL POTENTIAL. A "YES" VOTE TO BILL, SB191 - RETROACTIVE, WILL SET THE STAGE AND BE THE UNISHING LIGHT TO ALL NATIONALLY.. I TRULY THANK YOU FOR YOUR TIME & ATTENTION.
