





More Secure Futures



A neglected or abused child paired with a CASA volunteer is more likely to find a safe, permanent home and half as likely to reenter the child welfare system. Children with CASA volunteers, especially children of color, are more likely to have a plan for permanency, a key predictor of future success.

Value of CASA Volunteers



For many children, their advocate remains the one constant in their otherwise chaotic life, particularly during the unprecedented challenges brought on by the COVID-19 pandemic. Children with a CASA volunteer tend to perform better academically and behaviorally in school, and they are more likely to receive all court-ordered services.

More Support Needed



Courts rely on the impartial perspective of trained and supported CASA volunteers. More than 93% of judges report a positive overall experience with the CASA program. Oregon law mandates every child in foster care must be assigned a CASA, but without adequate funding and additional volunteers, Oregon cannot meet this mandate – leaving nearly half of foster children without a CASA.

CASA Saves Money



One year of CASA advocacy costs just 4.8% of what it costs the state for a year of foster care. A single CASA staff member can train and supervise up to 30 volunteers who, in turn, can advocate for as many as 75 children. CASA's core reliance on trained and supported community volunteers ensures both compassion and efficiency.

Support HB 2387 and HB 2738



HB 2387 – Finalize the fiscal transition from DAS to Oregon CASA Network. As the funding hub and statewide coordinating entity, OCN will increase statewide efficiencies, local program capacity and support for local CASA programs.

HB 2738 – Invest \$5.92 million to improve CASA operations, increase outreach, train new volunteers, support more neglected and abused children and create a statewide distance training and learning program for CASA volunteers, which will strengthen training efforts and provide flexibility beyond the COVID-19 pandemic.
