SENATE BILL 129



Currently, TSPC is limited by statute to collecting fees related to licensure.

The revenue projections within the Governor's Proposed Budget include two primary revenue changes to allow TSPC to meet its modified service level over the next several biennia:

- **General licensure fee increase of 25% (raises about \$1.6 million)**
 - Example a \$182 teacher license fee will increase to \$228
- **New fees, including: (Approximately \$793,000)**
 - Disciplinary sanctions
 - School district annual service assessments
 - Educator preparation program approval assessments

These fees would require new statutory authority : SB 129.
