Chair Wagner, Vice Chair Girod, and Members of the Committee,

For the record, my name is Adriana Cvitkovic (she/her) and I am here today representing the Oregon Food Bank. At OFB, we know that **hunger is a *symptom* of harmful policies and systems that create barriers for people to thrive.** That is why a key part of our mission is to bring people impacted by harmful policies closer to decision makers.

**People who experience hunger are experts of their own lives,** and policymakers should listen to their expertise. We must work to create more avenues for engagement, and not return to pre-pandemic systems with limited opportunities for public input.

Remote access via telephone, video, or other virtual means provides a beneficial alternative to in-person participation, **especially for those living in poverty and on low incomes.** Barriers such as the cost of driving, cost of childcare, and taking time off work to participate in-person at government hearings and meetings can be avoided by providing remote access options.

**Breaking down barriers is part of ending hunger.** At Oregon Food Bank, we commit to removing barriers to food access and to participation in democracy. **HB 2560 is a meaningful step towards removing barriers** that make the public's rightful participation in government processes more challenging.

**The COVID-19 pandemic has increased hunger in Oregon to a historic level.**

- Pre-pandemic, Oregon's food insecurity rate was around 9.8%
- In 2020, Oregon's food insecurity rate increased to nearly 25%<sup>1</sup>

As a state, we have a lot of work ahead of us to remedy the crisis of the COVID-19 pandemic. We will need many tools and strategies to tackle such a large issue, especially those that center access and could increase participation of communities most impacted by the pandemic.

That is why **Oregon Food Bank strongly urges your support for House Bill 2560** - because providing remote access to government hearings and meetings will allow more Oregonians to participate in our democracy, and help us create change to end hunger in Oregon for good.
