Measure makes no sense at all; in two hours after a person allegedly drove while intoxicated, neighbors reporting neighbors scenario I suppose.

A breath test after the fact, proposed law (SB 201) would not account for alcohol consumed up to two hours after person stops

driving. Exactly how would that work in the judiciary of proving that the driver was actually driving drunk or consuming alcohol because they legally can when not operating a vehicle?
