Dear Chair Beyer and Members of the Committee,

I am writing to offer BRING's support for Senate Bill 582-1, which will modernize Oregon's recycling system. Among other things, the bill will require producers that sell packaging in Oregon to share the responsibility and costs for the recycling system; develop a uniform statewide list of products that can be recycled; and prohibit brands from making deceptive or misleading claims about the recyclability of products on their packaging.

All of these are positive and needed changes in our state. Oregonians care deeply about recycling. SB582-1 will make recycling less confusing and ensure that more of the materials in curbside bins will be recycled, as opposed to going into the trash. The bill will require that recycling be done in a way that benefits the environment and does not harm vulnerable citizens, an important nod to the environmental justice issues that must become more prominent in all of our discussions about how we deal with waste. We are very excited that the legislation includes resources so that communities around the state can improve their waste reduction and reuse programs.

BRING is an advocate for EPR programs, which requires producers to participate in the process of disposing of products at the end of their useful life. SB582-1 follows a shared extended producer responsibility model that leverages the parts of the current system that are working well, while bringing producers into the process so that recycling is more accessible to all Oregonians. Brand owners and manufacturers have an important role to play in ensuring their packaging waste doesn't clutter Oregon's landfills, waterways, forests, and communities. They must be part of the solution for transforming products back into reusable materials whenever possible. Extended Producer Responsibility models also encourage companies to redesign their packaging to reduce waste or make it easier to reuse or recycle.

SB582-1 is the result of a consensus process that engaged stakeholders over the course of two and a half years. Oregon is a leader when it comes to EPR and residents across the state already enjoy other programs, including PaintCare, E-Cycles and, within the next year, a safe collection system for prescription medicines. BRING supporters fully agree that EPR should be part of the solution to modernizing Oregon's recycling system. Attached are their signatures and comments.
