I am the owner of a fitness facility in Canby Oregon, the Governors shut downs have had such a negative effect on my customers, my employees, my own livelihood & the ability to continue my business. High blood pressure, diabetes and chronic disease is a high risk factor for MANY diseases and illnesses. To quarantine healthy individuals, close businesses, take away incomes and one's ability to survive has never in the history of our country been done. The vulnerable and the unhealthy need to take personal responsibility to protect themselves and ruining so many peoples jobs is without evidence and merit is criminal. Governor Brown made a decision to use Oregonians and our businesses as a tool to get power and money from the Federal Government. The extreme measures she has chosen have hurt Oregon and the recovery will be many years to come, and it appears all for control of the citizen, the very citizen who pays the bills.

I took the Oregon Health Authorities weekly report from February 18, 2021 and listed by industry the source of infection, it is quite clear that NO businesses should have been closed of any size. (included) NO businesses should be under any rules or restrictions to operate including social distancing and masks. - I have 14000 square feet with 30 foot ceilings, special air filters. We average 30 people per hour

- There have been "0" cases of Covid sourced to fitness in Oregon
- Fitness is NOT recreation, it is hard work and takes a commitment. Do YOU exercise? Why or why not?
- Fitness is a health essential, citizens who practice fitness are healthy and able to fight disease better I provide the following services as a one of a kind business in Canby:
 - Cardiac, Stroke, Occupational Rehab which is done through physical therapy intake
 - Medicare Provider for Fitness & Disease mobility
 - General Fitness all age groups
 - Nutritional Education
 - Personal Wellness one on one with highly educated professionals
 - Professional equipment for disease management both physical and mental

I attempted to continue with therapies and rehab during the shut downs but consumer complaints to OSHA and the OHA made it so difficult I ultimately suspended those critical activities. The threats we received from those agencies were ridiculous. The continued moving of the goal posts have made it a priority this bill be passed so that no business in OREGON is ever forced into failure again. The Governors powers are too great, we the people own our Government.
