HB 4037

(8:35 am) Requires Oregon Department of Administrative Services to use reasonable efforts to lease certain unused or underutilized state real property to City of Salem for use as transitional housing accommodations upon certain terms.

HB 4051

(9:05 am) Directs Housing and Community Services Department to study issues relating to housing and to report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2023.
