#### Public Hearing

HB 4021 - Extends period in which taxpayers, upon transfer of ownership of homestead or moving manufactured structure or floating home out of state, may discontinue participation in homestead property tax deferral program in assessment year.

HB 4115 - Directs Oregon Investment Council to publish annually complete list of assets held in investment funds.
