#### **Public Hearing**

HB 4114

(8:05 am) Requires members of district school board for common school district or union high school district to file verified statement of economic interest with Oregon Government Ethics Commission.

HB 4140

(8:30 am) Expands duties of Oregon Government Ethics Commission to conduct investigations, make findings and impose penalties for violations of public meetings law.

HB 4107

(9:00 am) Directs Legislative Policy and Research Director to study use of impact statements in legislative deliberations and to report findings to Legislative Policy and Research Committee on or before February 1, 2023.

#### **Work Session**

HB 4087

CARRIED OVER FROM THE 2/8/2022 AGENDA: Requires, on or after January 1, 2023, officials of public bodies to grant news media representatives access to scenes of wildfires or natural disasters on public lands that are otherwise closed to public.

HB 4133

Requires electronic voter registration system to allow qualified individual to register to vote if individual has Social Security number.

  - **Register by phone:** 833-588-4500 (U.S. toll free). You will be given a phone number to call into the meeting.
- Registration closes one hour before the meeting is scheduled to begin.
- A public access kiosk is at the Capitol Building for anyone without access to a phone or computer to join a meeting by video.
- Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
- Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
