SB 1586

CARRIED OVER FROM THE 2/8/22 AGENDA: Clarifies prohibitions regarding provisions that may not be included in agreements between employers and former, current or prospective employees.

SB 1513

CARRIED OVER FROM THE 2/8/22 AGENDA: Prohibits employer from taking adverse employment action against employee employed in certain manufacturing establishments who refuses to work mandatory overtime shift unless employer has provided employee with at least two weeks' advance notice of overtime shift.

SB 1565

CARRIED OVER FROM THE 2/8/22 AGENDA: Makes unlawful practice for place of public accommodation to refuse to accept United States coins or currency as payment for goods and services.

SB 1562

CARRIED OVER FROM THE 2/8/22 AGENDA: Authorizes Health Licensing Office to issue sign language interpreter license to qualified applicant.

SB 1549

CARRIED OVER FROM THE 2/8/22 AGENDA: Requires Oregon Health Authority to issue temporary staffing agency license to qualified applicant.

Removes requirement that licensee member of Oregon Board of Maritime Pilots be resident of this state.
