Public Hearing

SB 1582

Authorizes board of directors of rural fire protection district to annex to district lands that are within seven road miles of fire station within district, or are brought within seven road miles of fire station within district by new road, and that are not subject to assessments for fire protection by district.

Work Session

SB 1501

Directs State Board of Forestry to adopt single rule package on or before November 30, 2022, to implement Private Forest Accord Report.

SB 1502 ** **Subsequent Referral(s) to Finance and Revenue Creates income or corporate excise tax credit allowed to small forestland owner that elects to observe riparian timber harvest restriction applicable to large forestland owner, in lieu of using harvest option available to small forestland owner. SB 1546 ** **Subsequent Referral(s) to Ways and Means

1546 ** **Subsequent Referral(s) to Ways and Means Establishes Elliott State Research Forest consisting of lands formerly constituting Elliott State Forest.

Public Hearing and Possible Work Session

SB 1532 **

**Subsequent Referral(s) to Ways and Means

Instructs Oregon State University Extension Service to expand Center for Small Farms and Community Food Systems through certain hiring.

SB 1533

Makes federally recognized Indian tribes in Oregon eligible for certain grants related to clean air shelters and smoke filtration systems.

Public Hearing

SB 1534

Establishes state policy to increase carbon sequestration in natural and working lands and waters.

SB 1564

Allows State Department of Agriculture to, based on supply of and demand for industrial hemp, refuse to issue industrial hemp grower license for amount of time department determines necessary.

SB 1573 ** **Subsequent Referral(s) to Ways and Means Appropriates \$50 million to State Forestry Department to fund increased forest thinning operations in specified wildfire-prone counties.
