## TASK FORCE ON UNIVERSAL HEALTH CARE

## Statutory Requirements<sup>3</sup>

The task force consists of 20 members.<sup>4</sup> In making appointments, the Governor must ensure that there is no disproportionate influence by any individual, organization, government, industry, business, or profession in any decision-making by the task force and no actual or potential conflicts of interest. Members of the Legislative Assembly appointed to the task force are nonvoting members and may act in an advisory capacity only. Members must be appointed no later than May 31, 2020.

The President of the Senate must appoint two members from among members of the Senate, including one member from the majority party (MANNING) and one member from the minority party (ANDERSON). The Speaker of the House of Representatives must appoint two members from among members of the House of Representatives, including one member from the majority party (WILDE) and one member from the minority party (HAYDEN).

The Governor must appoint 13 members, subject to confirmation by the Senate. Gubernatorial appointees must be residents of this state who represent diverse social identities and areas of expertise, including:

- rural health (**CHADWICK; GOLDBERG**);
- quality assurance and health care accountability (**SANTA**);
- fiscal management and change management (**GEORGE**);
- social services (**DILL**);
- public health services (**COLLINS, STANPHILL**);
- medical and surgical services (**METZ**);
- alternative therapy services (**JUNKEER**);
- services for persons with disabilities (**ROGERS**); and
- nursing services (**SIMILA**).

The task force must include at least one member who:

- has an active license to provide health care in this state (JUNKINS);
- has an active license to provide mental or behavioral health care in this state (**RAMIREZ**);
- has expertise, based on knowledge and experience, in advocating for health care equity (**CLAYBROOKS, SHEKETOFF**); and
- has personal experience in seeking and receiving health care in this state to treat complex or multiple chronic illnesses or disabilities.

There are three nonvoting members of the task force:

- the director of the Oregon Health Authority, or the director's designee (ALLEN);
- the director of the Department of Consumer and Business Services, or the director's designee (SAVAGE); and
- a member of the Association of Oregon Counties, selected by the association (HALL).

## Duties and Authority

The task force must:<sup>5</sup>

- recommend the design of the Health Care for All Oregon Plan, a universal health care system, administered by the Health Care for All Oregon Board, that is equitable, affordable and comprehensive, provides high quality health care, and is publicly funded and available to every individual residing in Oregon;
- elect one of its members to serve as chairperson and one to serve as vice chairperson;
- establish an advisory committee to provide input from a consumer perspective and that includes specified qualifications;
- adhere to the values and principles established by the Legislative Assembly;
- develop cost estimates for the plan;
- consider how the plan will impact the structure of existing state and local boards and commissions, counties, cities and special service districts, as well as the United States Government, other states and Indian tribes;
- consider the issues raised in the report entitled “A Comprehensive Assessment of Four Options for Financing Health Care Delivery in Oregon”;
- investigate other states’ attempts at providing universal health coverage and using single payer health care financing systems, including the outcomes of the attempts;
- take into account the work by existing health care professional boards and commissions to incorporate important aspects of the work of the health care professional boards and commissions into recommendations for the plan;
- engage in a public process to solicit public input which includes input from rural and underserved communities, the solicitation of public comments statewide while providing to the public evidence-based information developed by the task force; and the solicitation of specified perspectives; and
- make findings and recommendations for the design of the plan and the Health Care for All Oregon Board and submit a report of its findings, recommendations, and other specified information to the 2021 regular session of the Legislative Assembly.

The task force may:<sup>6</sup>

- adopt rules necessary for the operation of the task force;
- establish additional advisory or technical committees the task force considers necessary;
- apply for public or private grants from nonprofit organizations for the costs of research; and
- explore other specified topics.
