

What is the Compass Project?

The Compass Project was created by the Office of Developmental Disabilities Services (ODDS) to improve the way people with intellectual and developmental disabilities participate in services. The Compass Project is a large body of work that includes updates to:

- Person-centered planning
- Individual Support Plans (ISP)
- Oregon Needs Assessment (ONA)
- Service Group Framework
- Provider Rate Models
- Waivers, K plan, policy and rule
- Trainings.




- Focusing on person-centeredness as expressed through the revised ISP process
- Replacing multiple assessments with the Oregon Needs Assessment (ONA)
- Implementing new transparent rate models
- Simplifying movement between services or settings
- Making updates in eXPRS system to support Compass changes

What will remain the same...


- Eligibility

- Led by professionals


Future hopes:

Oregon Needs Assessment (ONA)

 ODDS created this single, universal assessment by combining key elements of multiple tools that were used across the state. Starting in 2018 once a year, an assessor reviews the ONA with each person to customize specific services and supports.



Reliable and Valid Assessment Tool

- Simplify movement across service settings
- Increased precision in process and outcome of identifying support needs
- Accurate and consistent in capturing supports



Transparency and Consistency in ONA Service Groups and Payment Categories

- Present a consistent way of determining rate categories and in-home hour allotments
- Clearly communicate how service groups are determined
- Provide people a better idea of how the certified ONA assessor determined the appropriate service group.



ONA to Resources Process Flow



ONA: Service Groups Based on Needs

Based on ONA assessment, adults, children, and adolescents are assigned a service group that corresponds to their assessed support needs.

| Adult 18+ | Adolescent 12 - 17 | Child 4 - 11 | Infant/Toddler 0 - 3 |
|-----------|--------------------|-------------------|----------------------------|
| Very Low | Very Low | Low to Very Low | |
| Low | Low | | |
| Moderate | Moderate | Moderate | Infant/Toddler Supports |
| High | High | High to Very High | |
| Very High | Very High | | |

Summary: Payment Categories

- Service groups determine in-home hour allotments and some provider rates
- Higher service group reflects higher level of need - resulting in higher in-home hour allotments and higher rates for providers


