


#### RAISING FUNDS

- Revenue sources
  - Fuels tax
  - Weight-mile tax
  - Increased DMV vehicle fees
  - Payroll tax
  - Bike purchase fee
  - New vehicle tax
- Total impact
  - The average passenger vehicle driver has paid less than one cent per mile and the average worker has paid less than \$1 a week in payroll tax.



#### **IMPACT OF TRANSIT FUNDING**

- Role in wildfires and pandemic
  - With legislative support, recipients repurposed STIF funds toward maintenance of essential services
  - Funding allowed transit providers to better maintain service availability and to use vehicle fleets to support meal delivery, senior transportation, and transportation to vaccination centers.






#### SAFE ROUTES TO SCHOOLS







The Safe Routes to Schools program has invested \$48 million in 70 projects across Oregon. These projects include 445 crossings, 167 curb ramps, 124 sidewalk improvements and 33 lighting upgrades, helping kids get to school safely.








#### **COMPLETED PROJECTS**

#### PROJECTS UNDER CONSTRUCTION



US 26 (SE Powell Blvd)

Outer Powell (122<sup>nd</sup> to 136<sup>th</sup>) is substantially complete. Remainder of project is at 60% design.



Two bridges are currently under construction. A third bridge and additional projects will go to bid in early 2023






#### **GOING FORWARD**
