

## HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 4077

9 **“SECTION 20. (1) In addition to and not in lieu of any other appropriation, there is ap-**  
10 **propriated to the Department of Environmental Quality, for the biennium ending June 30,**  
11 **2023, out of the General Fund, the amount of \$324,520, for implementing section 12 of this**  
12 **2022 Act and to provide administrative support for the Environmental Justice Council.**

13 **“(2) Notwithstanding any other provision of law, the General Fund appropriation made**  
14 **to the Oregon Health Authority by section 1 (1), chapter 668, Oregon Laws 2021, for the**  
15 **biennium ending June 30, 2023, for health systems, health policy and analytics, and public**  
16 **health, is increased by \$123,586 for implementing section 12 of this 2022 Act.**

17 **“(3) Notwithstanding any other provision of law, the General Fund appropriation made**  
18 **to the Higher Education Coordinating Commission by section 1 (8), chapter 660, Oregon Laws**  
19 **2021, for the biennium ending June 30, 2023, for public university statewide programs, is in-**  
20 **creased by \$191,355 for the Institute for Natural Resources and the Portland State University**  
21 **Population Research Center, to carry out the provisions of section 12 of this 2022 Act.**

22 **“(4) Notwithstanding any other law limiting expenditures, the limitation on expenditures**  
23 **established by section 2 (3), chapter 425, Oregon Laws 2021, for the biennium ending June 30,**  
24 **2023, as the maximum limit for payment of expenses from fees, moneys or other revenues,**  
25 **including Miscellaneous Receipts and federal funds received from charges, but excluding lot-**  
26 **tery funds and federal funds not described in section 2, chapter 425, Oregon Laws 2021, col-**  
27 **lected or received by the Oregon Department of Administrative Services, for the office of**  
28 **Enterprise Information Services, is increased by \$129,937 to carry out the provisions of sec-**  
29 **tion 12 of this 2022 Act.”.**
