**PROPOSED AMENDMENTS TO
SENATE BILL 1501**

1 On page 3 of the printed bill, line 12, after “to” delete the rest of the line
2 and insert a colon.

3 Delete lines 13 through 15 and insert:

4 “(a) An operation, other than an operation described in section 16 (3)(a)
5 of this 2022 Act, for which a notification is filed:

6 “(A) On or after January 1, 2024.

7 “(B) Before January 1, 2024, if the operation is not completed on or before
8 December 31, 2023.

9 “(b) An operation described in section 16 (3)(a) of this 2022 Act for which
10 a notification is filed:

11 “(A) On or after July 1, 2024.

12 “(B) Before July 1, 2024, if the operation is not completed on or before
13 June 30, 2023.”.

14 On page 9, after line 29 insert:

15 **“SECTION 23a. (1) As used in this section, ‘small forestland’ has the
16 meaning given that term in ORS 527.678.**

17 **“(2) The reporting requirement described in section 23 (5) of this
18 2022 Act applies when a beaver is taken, as described in section 23 (4)
19 of this 2022 Act, on small forestland on or after July 1, 2024.”.**

20 On page 21, after line 26 insert:

21 **“SECTION 45a. (1) As used in this section, ‘small forestland’ means**

1 forestland that has an owner that owns or holds common ownership
2 interest in less than 5,000 acres of forestland in this state.

3 “(2) The inspection provisions set forth in section 44 of this 2022 Act
4 and the monitoring provisions set forth in section 45 of this 2022 Act
5 apply to operations on small forestland after July 1, 2024.”.

6 On page 22, after line 25 insert:

7 “SECTION 46a. (1) As used in this section, ‘small forestland’ means
8 forestland that has an owner that owns or holds common ownership
9 interest in less than 5,000 acres of forestland in this state.

10 “(2) The amendments to ORS 527.680 by section 46 of this 2022 Act
11 authorize the State Forester to require financial assurance related to
12 an operation on small forestland on or after July 1, 2024.”.

13 On page 23, after line 20 insert:

14 “SECTION 47a. (1) As used in this section, ‘small forestland’ means
15 forestland that has an owner that owns or holds common ownership
16 interest in less than 5,000 acres of forestland in this state.

17 “(2) The amendments to ORS 527.685 by section 47 of this 2022 Act
18 do not apply to a violation or significant violation related to small
19 forestland that occurs before July 1, 2024.”.

20 On page 26, after line 8 insert:

21 “SECTION 51a. (1) As used in this section, ‘small forestland’ means
22 forestland that has an owner that owns or holds common ownership
23 interest in less than 5,000 acres of forestland in this state.

24 “(2) Rules described in section 51 of this 2022 Act do not apply to
25 activities on small forestland that occur before July 1, 2024.”.
