**PROPOSED AMENDMENTS TO
HOUSE BILL 4004**

1 On page 1 of the printed bill, delete lines 5 through 27.

2 On page 2, delete lines 1 through 18 and insert:

3 **“SECTION 1. (1) As used in this section:**

4 **“(a) ‘Behavioral health care’ means services and supports for indi-**
5 **viduals with mental health or substance use disorders.**

6 **“(b) ‘Provider’ means:**

7 **“(A) A mental health or substance use disorder crisis line provider;**

8 **“(B) An Urban Indian Health Program in this state;**

9 **“(C) A Tribal Behavioral Health Program grant recipient in this**
10 **state; or**

11 **“(D) An entity:**

12 **“(i) That provides behavioral health care to adults or youth, of**
13 **which at least 50 percent are uninsured, enrolled in the state medical**
14 **assistance program or enrolled in Medicare;**

15 **“(ii) That is not a hospital; and**

16 **“(iii) That:**

17 **“(I) Has been certified by the Oregon Health Authority to provide**
18 **behavioral health care;**

19 **“(II) Provides behavioral health care through a program contract-**
20 **ing with or administered by the Oregon Youth Authority;**

21 **“(III) Provides behavioral health rehabilitation services through a**

1 program contracting with or administered by the Department of Hu-
2 man Services;

3 “(IV) Is a licensed opioid treatment program;

4 “(V) Provides withdrawal management services; or

5 “(VI) Is a sobering center.

6 “(2) The Oregon Health Authority shall administer a program to
7 distribute grants to providers.

8 “(3) A provider may use a grant under subsection (2) of this section
9 to:

10 “(a) Increase compensation for the provider’s staff;

11 “(b) Pay a retention bonus to an individual on the provider’s staff
12 if necessary to prevent the individual from leaving the provider’s em-
13 ploy; or

14 “(c) Hire new staff and provide a hiring bonus, if necessary to re-
15 cruit new staff.

16 “(4) A provider must use at least 75 percent of the grant on direct
17 compensation to the provider’s staff in the form of wages, benefits and
18 bonuses. The remainder may be spent on programs or other
19 noncompensatory means to increase workforce retention or recruit-
20 ment.

21 “(5) Notwithstanding the definition of ‘compensation’ in ORS
22 652.210, a hiring or retention bonus paid under subsection (3) of this
23 section is not a violation of ORS 652.220.

24 “(6) Providers must report to the Oregon Health Authority, in the
25 form and manner prescribed by the authority, on how the grants were
26 spent and whether the expenditures resulted in improved compen-
27 sation for staff.

28 “(7) Each grant shall be a percentage of the funds available under
29 section 5 of this 2022 Act that represents a provider’s staffing costs,
30 for both filled and vacant positions, relative to the staffing costs of

1 all providers in this state. Applicants for grants must state in the ap-
2 plication how the grant will be spent in accordance with subsection (3)
3 of this section.

4 “(8) Any portion of a grant that is not spent as provided in this
5 section constitutes an overpayment that the Oregon Health Authority
6 shall recover from a provider.

7 “(9) The Oregon Health Authority shall adopt rules necessary to
8 carry out the provisions of this section.

9 **“SECTION 2. (1) The Oregon Health Authority shall contract with
10 nurses and behavioral health professionals to provide care in adult and
11 child residential behavioral health treatment facilities, opioid treat-
12 ment programs, withdrawal management programs and sobering cen-
13 ters in this state to address staffing shortages at such facilities caused
14 by the COVID-19 pandemic.**

15 **“(2) The authority shall seek any necessary approval from the
16 Centers for Medicare and Medicaid Services to secure federal financial
17 participation in the costs of contracts described in subsection (1) of
18 this section if funding from the Federal Emergency Management
19 Agency is unavailable.”.**

20 On page 4, line 7, after “of” insert “adjudicated”.

21 In line 8, after “each” insert “adjudicated”.

22 In line 12, delete “May 1” and insert “May 31”.
