## PROPOSED AMENDMENTS TO HOUSE BILL 4134

"(4)(a) If labor and delivery services are provided to an individual insured under a health benefit plan or a health care service contract at an out-ofnetwork health care facility due solely to the diversion of the individual from an in-network health care facility during a state or federally declared public health emergency, the health benefit plan or health care service contract:

"(A) Shall reimburse the out-of-network provider in accordance with 42
 U.S.C. 300gg-111(c) or in accordance with a method adopted by the Depart ment of Consumer and Business Services by rule; and

"(B) May not impose a deductible, out-of-pocket maximum, copayment or
 coinsurance requirement that exceeds the deductible, out-of-pocket maximum,
 copayment or coinsurance applicable to in-network providers of labor and
 delivery services.

"(b) This subsection does not apply to services provided by an in-network
 provider at an out-of-network health care facility.".

"(2) An out-of-network provider that is licensed or certified in this state may not bill an individual insured under a health benefit plan or a health care service contract for the costs of labor or delivery services provided by the out-of-network provider if the services are provided by the out-of-network provider due solely to the diversion of the individual from an in-network provider during a state or federally declared public health emergency.

"(3) Subsection (2) of this section does not prohibit any provider from billing an individual insured under a health benefit plan or health care service contract for coinsurance, copayments or deductibles applicable to labor and delivery services provided by in-network providers under the terms of the health benefit plan or health care service contract.
