Written testimony for the legislation

Specifies conditions under which licensing board, commission or agency may suspend or deny occupational or professional license on basis of applicant's or licensee's criminal history, moral character or similar qualification.

Currently the system allows for criminals- co killers in Oregon and "should be criminals" (as well) to be licensed as therapists in Oregon.

When a therapist is governed by regulations it only matters if the investigative body allows for the proper investigation be done when we submit what I had given them.

From my experience all they had to say was no we are not going to look into the matter and we won't write you back.

When a agency claims to protect the public I find it odd they have the power to say no they will not investigate just simply because of who I am and what I'm attempting to accomplish. (Full disclosure)

It appears Oregon laws do not require any public rights for the investigation process let me explain.

In 2013 my ex-girlfriend Tiffany Jenks told me "John they want to kill me" and she said three times crying "I'm not going to die tonight I'm not going to die tonight I'm not going to die tonight"

Later that same night Tiffany was killed. SHOT by what clearly was 3 people in a car... the driver is named Michelle Worden-Brose.

I began my own investigation and the first big clue came when I looked in the phone she had of mine and it contained 6 audio recordings.

A person on the audio was her therapist

And they had two sessions (and she recorded with his permission) that is sad for him because in the recordings he talked about how "she can't touch him" because he has a girlfriend at home otherwise he would be OK with that" and when she said she's going to "kill herself" he said then "why are you here".

I've never heard a person more desperate to die and a doctor more willing to help in

this case but more importantly the right of the public was removed when I was stopped by the investigating body for something they call a "conspiracy theory" as frustrating as it was to know everyone was covering up this case that did not stop me from submitting multiple requests for investigations however I assume they will lie to you about why they never did look into this doctor.

The doctor told her

"there's a war going on, between the light and the dark, and people of the light, are being attacked by people of the dark, and I'm going to tell you that's going to get a lot worse,

and she said

"they know who I am"

and he said

"they don't know who you are and you should never tell anybody who you are nobody that doesn't know doesn't need to know you know why because it will make you a target and targets get shot at first"

now he has some clear explaining to do she was shot three days later and yet somehow I believe he's still a licensed therapist but wait it gets worse

Apple told me her iCloud was deleted all her stuff inside two days before she was dead.

her family drove her dead body in their car five hours

police said I wanted a warrant for the evidence and that's a lie

and my 3 year old child has been without a father because of this corruption and likely will forever but the most offensive thing in this entire cover up of the murder at Blue Lake park is not even the dead girl or this licensing division it's that the girl

who took my girlfriend from the bar,

provided the gun

drove the car

kidnapped her

and abused her

Drove 15 minutes away at the planned location

handed the gun to the shooter

who proceeded to murder Tiffany

and that co killer who handed the gun for murder is now a licensed therapist. In Oregon

No one in the world could believe such a story Michelle warden-Brosey (who was as part of my girlfriend Tiffany Jenks murder at Blue Lake Park Fairview Oregon and a

girl who allowed her 12 year old child in the room (while having sex with her boyfriend).
