Beware of the “contractors” on this list.

None of them have a valid license to work. They are on this list for one or more of the following:

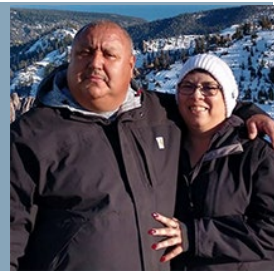
- They took homeowner money up front, then did little or no work.
- They failed to pay CCB fines for violating regulations, including working as a contractor without a CCB license.
- They owe homeowners money, based on a court judgment.

**Joann Jacobo Bustinza & Robert
“Bobby” Reyes**



UNPAID DEBT: \$67,079

Joann Jacobo Bustinza & Robert (AKA Bobby) Reyes are operating out of the Multnomah/Marion/Polk County areas and are unlicensed contractors. They are known to do concrete work, the majority of which results in homeowner complaints for substandard work. They are known to request and accept large down payments with all checks to be made payable to Bookkeeper "Jo Ann Bustinza."

Joann Jacobo Bustinza & Robert "Bobby" Reyes are habitual offenders.



Steven Antonio Behrent

UNPAID DEBT: \$11,599.22

Working in western Oregon, Steven takes large down payments and does not complete the work or return payment. The work he does is not to industry standard. He uses a CCB license number associated with another company without permission and uses a business name of "Hood Mountain Construction".



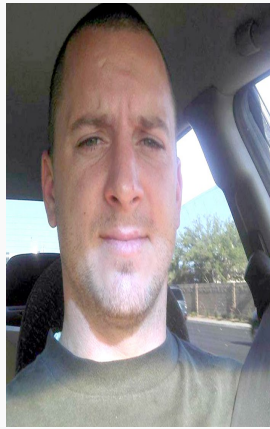
Kevin Glen Whiting

UNPAID DEBT: \$16,642.11

Known to do business in Lane, Linn, Coos, Deschutes, Benton and surrounding counties. Whiting is known to do business as Apex Appliance Repair, Premier Appliance and Refrigeration and Willamette Appliance Service. Whiting performs extremely dangerous electrical installations that he's not qualified to perform. Whiting will collect the money up front, start the job, then claim he needs to order parts abandoning the job. The majority of his work results in complaints for substandard work. Kevin Glen Whiting is a habitual offender.



Bobby James McQuillan Jr.



UNPAID DEBT: \$23,250.19

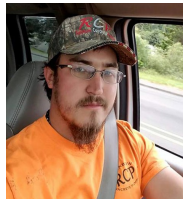
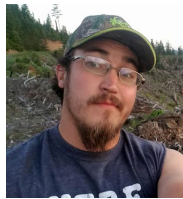
He is known to work in Roseburg Oregon and all surrounding areas. Bobby James McQuillan Jr is unlicensed, unqualified and offering remodeling work which he does not have the abilities to perform. The majority of his work results in complaints for substandard work. Bobby James McQuillan Jr is a habitual offender.



Austin Lewis Medford

UNPAID DEBT: \$29,767.67

Works in Coos Bay and Surrounding areas. Austin Lewis Medford is unlicensed offering concrete work that he is unqualified to perform. Austin Lewis Medford is a habitual offender.



Oloseni Aisea & MaryAnn Michelle Aau

UNPAID DEBT: \$49,415.09

Doing business in the Portland and surrounding areas. They primarily do concrete work and have had several customer complaints. They are habitual offenders.

UNPAID DEBT: \$32,257.24

He is known to work in Jackson county and surrounding areas. He claims to be a carpenter but is not qualified to perform any construction activities in the State of Oregon. Christopher Lee Lane is a habitual offender.



Dean Hoyt Stevens

UNPAID DEBT: \$45,890.78

Doing business as: Absolute Quality Roofing. Stevens hands out his business card and a list of references. He takes 50 percent of the bid up front and takes off never to be seen again. Stevens is known to primarily work in Lane county but also works in all surrounding counties.



Casey G Daugherty Theresa M Daugherty

UNPAID DEBT: \$27,219.51

Takes downpayments without providing finished products. Offer installation while being unlicensed.

Doing business as: Willamette Custom Woodworks

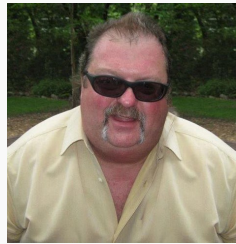
James Gabriel

UNPAID DEBT: \$67,088.74

Working without a CCB license, habitual offender. Gabriel primarily works in Western Oregon (Florence area). The majority of his work results in complaints for substandard work. He is



known to request and accept large down payments without performing any work.



Scott "Randy" Randall Merriweather

UNPAID DEBT: \$20,269.18

Working without a license, habitual offender. Goes by "Pastor Randy". Merriweather primarily works in the Salem Oregon and surrounding Marion County area.



Gregory Mason Miller

UNPAID DEBT: \$311,105.52

Gregory Mason Miller is an unlicensed home inspector who has been falsely using another contractor's license number for several years. Miller primarily operates in Central and Eastern Oregon but is also known to operate in the Portland area and the Columbia Gorge. Miller is a habitual offender.

UPDATE 6-6-18: Sentenced to 5 years in prison.

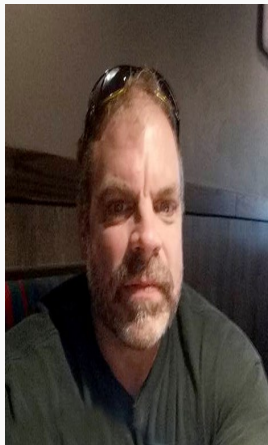
Jose Francisco Alvarez-Guerrero

Continued to work after license suspended. Outstanding debt resulting from complaints for substandard work.

UNPAID DEBT: \$34,992.35

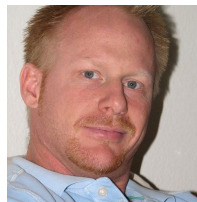
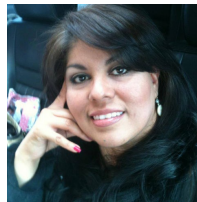
Working without a CCB license. Outstanding fines and homeowner debt.
