Re: Support for SB 1579 – Economic Equity Investment Program

Chair Taylor, Vice-Chair Knopp, and members of the Senate Committee on Labor and Business:

On behalf of the Micronsian Islander Community (MIC), I would like to share our full support of SB 1579 - Economic Equity Investment Program. As a Salem-based nonprofit serving statewide, with the majority of our communities in Marion, Polk, Multnomah, Clackamas, Washington and Union counties, MIC works to help Micronesian and Pacific Islander families, including citizens from the Compact of Free Association, with resource building and social support programs from focusing on chronic diseases, prenatal care, and access to healthcare and housing.

Housing Instability is not a new concept to Oregon. As of January 2020, it is estimated that Oregon has 14,655 people experiencing homelessness on any given day, as reported in the United States Interagency Council on Homelessness [1]. Further, the 2021 Housing Needs Analysis from the Oregon Housing and Community Services reported that 85% of homeowners in Oregon identified as white non-Hispanic. The study further demonstrated the large disparities in homeownership among Oregon residents: "as of 2021, only 59% American Indians or Alaska Natives, 39% of Black or African Americans, 29% of Pacific Islanders, 53% of other races are homeowners" [2]. Furthermore, the needs assessment recommended that Oregon must explore methods to assist homeowners, to ensure greater homeownership opportunities are available to Black, Indigenous, and Communities of Color (BIPOC).
