# STATE BOARD OF EXAMINERS FOR SPEECH-LANGUAGE PATHOLOGY AND AUDIOLOGY

The Governor has appointed the following individuals to the State Board of Examiners for Speech-Language Pathology and Audiology subject to Senate confirmation.<sup>1</sup>

#### **New Appointee**

Kristy Cousineau of Gresham

#### Reappointee

Jazzmen Vega-Heath of Eugene

#### Terms

Cousineau: October 5, 2023 – June 30, 2027 Vega-Heath: July 1, 2023 – June 30, 2027

#### **Appointment/Confirmation Authority**

ORS 681.400 (2021)

#### Statement of Economic Interest<sup>2</sup>

Not required.

#### **Composition**<sup>3</sup>

The board consists of eight Oregon residents, including: <sup>4</sup>

- two licensed audiologists (FONG, SLOUGH);
- two licensed speech-language pathologists (CONSTANZA-SMITH, MARTIN);
- one certified speech-language pathology assistant (COUSINEAU)
- one licensed medical practitioner with American Board of Otolaryngology certification (HARGUNANI);
- two public members who are not otherwise eligible, and who are not related to an audiologist, speech-language pathologist, or a licensed medical practitioner with American Board of Otolaryngology (VEGA-HEATH, WILLIAMS).

Board members required to be licensed audiologists or licensed speech-language pathologists may be selected from a list of nominees, submitted by any applicable professional organization.

Members serve three-year terms and must be removed immediately if the member:

- is not a resident of this state;
- has three consecutive unexcused absences; or
- is not a licensed or retired audiologist or speech-language pathologist.

The board selects its chair and vice chair. A majority of the members constitutes a quorum. The board must meet at least once every year.<sup>5</sup>

#### Duties<sup>6</sup>

The board regulates the practice of audiology and speech-language pathology. The board must:

- administer licensing and certification for speech-language pathologists, audiologists, and speech-language pathology assistants;
- adopt rules to define the role of speech-language pathology assistants;
- administer, coordinate, and enforce the provisions assigned to the board;
- receive and investigate complaints;
- conduct hearings and keep records and minutes of the hearings;
- adopt rules and regulations, including governing ethical standards of practice; and
- adopt a seal by which the board must authenticate its proceedings.

The board may:

- issue temporary and conditional licenses, waive specified licensing requirements, and impose additional specified fees;
- refuse to issue or renew licenses; suspend or revoke licenses; and reprimand or place on probation any licensee or registrant under specified conditions; and
- impose any disciplinary action and assess civil penalties.
