## **ELECTRICAL AND ELEVATOR BOARD**

The Governor has appointed the following individual to the Electrical and Elevator Board subject to Senate confirmation.<sup>1</sup>

# Reappointee

Robert McNeill of Portland

### **Term**

July 1, 2023 – June 30, 2027

## **Appointment/Confirmation Authority**

ORS 455.144 (2021)

## Statement of Economic Interest<sup>2</sup>

Not required.

## Composition<sup>3</sup>

The board consists of 15 members appointed by the Governor and subject to confirmation by the Senate, including:<sup>4</sup>

- a fire and casualty underwriter (VACANT);
- a representative of industrial plants regularly employing licensed electricians (LA DIEU);
- a person representing the power and light industry (SPENCER);
- an electrical equipment supplier who otherwise qualifies by experience in the industry (SCHACHER);
- an elevator manufacturer (MCNEILL);
- one member from the electrical equipment manufacturing industry who otherwise qualifies by experience and training in electricity (BARLOW);
- two journeyman electricians (FLEGEL, CURRIE);
- an electrical inspector (SONNABEND);
- two electrical contractors (KYLE, RICHARDS);
- a municipal building official (BUNGA);

- a journeyman elevator installer (LARZALERE);
- an owner or manager of a commercial office building (RUDDER); and
- a public member who does not receive compensation from any interest represented on the board (BEYER).

Members serve four-year terms and at the pleasure of the Governor. A member may not serve more than two full terms. The board selects one of its members as chair and another as vice chair. A majority of the members of a board constitutes a quorum for the transaction of business. The board must meet at least four times per year.<sup>5</sup>

#### **Duties**

The board assists the Director of the Department of Consumer and Business Services in administering the state electrical and elevator programs.<sup>6</sup> The board must:<sup>7</sup>

- administer and enforce the state's Electrical Safety Law, and adopt rules, as required, to do so;
- select two members to serve on the Construction Industry Energy Board;
- review amendments to the electrical provisions of the Low-Rise Residential Dwelling Code;
- receive, review, and make determinations on appeals; and
- adopt and administer standards for the delegation of a municipal electrical inspection program.

### The board may also:8

- adopt rules to administer the licensing, certification, or registration of persons regulated by the Electrical Safety Law;
- deny a license, certificate, registration, or application; or suspend, revoke, condition, or refuse to renew a license, certificate, or registration if the board makes specified findings;
- adopt specified exemptions from the license, permit, and product registration requirements of the Electrical Safety Law; and
- impose civil penalties for specified violations.
