Composition³

The board consists of nine Oregon residents, including:4

- six people with doctoral or master's degrees in psychology, who must be licensed or formerly licensed psychologists (DIAZ DEL RÍO, GREAVES, GOY, JASPER, MILLER, ZIEGLER); and
- three public members who are not otherwise eligible for appointment to the board and who aren't related to a licensed psychologist (HAGEN, JASANI, SCHERMER).

The licensed psychologists may be appointed from a list of nominees for each vacancy, submitted by any applicable professional organization. Members serve three-year terms. Every member must take an oath that they will faithfully and impartially discharge the duties of office. A member must be removed immediately if the member is not a resident; has three consecutive unexcused absences; or is not a licensed psychologist or retired psychologist.

The board selects its chair and vice chair.⁵ A majority of the board constitutes a quorum. The board must meet at least once a year, maintain records of all board proceedings, and maintain a register of all living psychologists licensed by the board.

Duties⁶

The board administers licensing for and oversees the practice of psychology, and the board has the power to:

- determine qualifications of applicants to practice psychology and prepare, conduct, and grade examinations;
- license new applicants, suspend or revoke licenses, and grant or deny license renewals;
- issue letters of reprimand and impose probationary periods;
- impose civil penalties;
- collect specified fees;
- investigate alleged violations;
- conduct hearings and investigations;
- adopt a common seal;
- formulate a code of professional conduct;
- establish standards of service, training, and educational qualifications;
- require fingerprints;
- prescribe, in consultation with the Oregon Board of Licensed Professional Counselors and Therapists, the duties of the Director of the Mental Health Regulatory Agency;
- adopt reasonable rules to carry out the statutes administered by the board; and
- institute and commence injunction proceedings in any circuit court in Oregon to enjoin the unlawful practice of psychology.
