OREGON STATE HOSPITAL ADVISORY BOARD

The Governor has appointed the following individual to the Oregon State Hospital Advisory Board subject to Senate confirmation.¹

Statement of Economic Interest²

Not required.

Composition³

The board consists of 16 members, 14 of whom are appointed by the Governor. Membership includes:⁴

- three advocates representing individuals with mental illness (SHEARN, VALENCIA, VACANT);
- three health care professionals working with individuals with mental illness (**FERREIRA**, KING, VACANT);
- two current or former consumers of mental health services, at least one of whom is a former patient of the Oregon State Hospital (OSH) in Salem (HASKINS, RUGGLES);
- one family member of a consumer of mental health services (WROLSTAD);
- two public members who live near the OSH in Salem, Marion County (VACANT, VACANT);
- three public employee bargaining unit members employed by the OSH in Salem, Marion County, nonvoting, as follows:
 - o one representative of board-certified physicians (VACANT);

- o one representative of board-certified nursing staff (VACANT); and
- one representative of direct care services staff (THOMA);
- one senator, appointed by the President of the Senate, nonvoting (LIEBER); and
- one representative, appointed by the Speaker of the House of Representatives, nonvoting (VACANT).

Governor appointees serve four-year terms; legislators serve two-year terms. The Governor selects voting members to be chair and vice chair. Voting members may not have a financial interest in the Oregon State Hospital located in Salem.

Duties⁵

The board must periodically review federal and state laws, administrative rules, policies, procedures, and protocols of the Oregon State Hospital related to patient safety, security, and care. It must report annually to the Legislative Assembly and may make recommendations to the superintendent of the Oregon State Hospital, the Director of the Oregon Health Authority, and the Legislative Assembly. The board may establish ad hoc committees to aid and advise the board in the performance of its functions.
