OREGON RETIREMENT SAVINGS BOARD

The Governor has appointed the following individuals to the Oregon Retirement Savings Board subject to Senate confirmation.¹

Composition³

The board consist of seven members, four of whom are appointed by the Governor, including:⁴

- a representative of employers (BACKUS);
- a representative with investments experience (GONZALEZ);
- a representative of an association representing employees (ANDERSON);
- a public member who is retired (**DEMONNIN**);
- the State Treasurer or the designee (READ);
- a senator, appointed by the President of the Senate, nonvoting and advisory (ANDERSON); and
- a representative appointed by the Speaker of the House of Representatives, nonvoting and advisory (D. NGUYEN).

Gubernatorial appointees serve four-year terms and are eligible for reappointment. The State Treasurer or designee serves as chair. A majority of the voting members constitutes a quorum.

Duties⁵

The board establishes, oversees, and has general fiduciary responsibility for a state-run retirement savings program.

The board must:

- develop a defined contribution retirement plan;
- not guarantee any rate of return or any interest rate on any contribution;
- adopt rules for administration of the plan;
- report each calendar year to the Governor and to the Legislative Assembly detailing the board's activities; and
- administer the Oregon Retirement Savings Plan Administrative Fund.

The board may:

- establish, implement, and maintain the plan;
- adopt rules for the general administration of the plan;
- direct the investment of the contributed funds;
- collect fees to defray the costs of administering the plan;
- contract for specified services;
- evaluate the need for, and procure, pooled private insurance of the plan;
- develop and implement an outreach plan to gain input and disseminate information about the defined contribution retirement plan and retirement savings in general;
- request that the Commissioner of the Bureau of Labor and Industries investigate employers to determine compliance; and
- enter into agreements with other states to provide services related to retirement savings plans administered by them and similar to the plan developed by the board.
