### STATE BOARD OF CHIROPRACTIC EXAMINERS

The Governor has appointed the following individuals to the State Board of Chiropractic Examiners, subject to Senate confirmation.<sup>1</sup>

## **New Appointee**

Corey O'Neill of Medford

## Reappointees

Karen Baranick of Clackamas Lori Schmidt of Coos Bay

#### **Terms**

Baranick: October 1, 2023 - September 30, 2026

O'Neill: October 5, 2023 – October 4, 2026 Schmidt: October 1, 2023 – June 30, 2027

## **Appointment/Confirmation Authority**

### Statement of Economic Interest<sup>2</sup>

## Composition<sup>3</sup>

The board consists of seven members who must be Oregon residents.<sup>4</sup> All members may serve recurring three-year terms. Membership includes:

- five licensed chiropractors who have practiced in Oregon for five years prior to appointment (ALLEY, BARANICK, FULLER, O'NEILL, WAGGONER); and
- two members of the public who are not chiropractors or a spouse, domestic partner, child, parent, or sibling of a chiropractor (**SCHMIDT**, VACANT).

Members are selected by the Governor from a list of three to five nominees submitted by any professional organization representing chiropractors. A member may be

removed immediately if they are not an Oregon resident, if they are not licensed, or if they have three consecutive unexcused absences.

Annually, the board elects its president, vice president and secretary-treasurer from its membership,<sup>5</sup> and must meet in January and July.<sup>6</sup>

#### Duties<sup>7</sup>

The board regulates chiropractic practice in Oregon. Its duties include;

- adopting a seal which is affixed to all licenses it issues;
- adopting rules for the administration and performance of its work;
- adopting minimum educational requirements for licensure; and
- appointing and forming peer review committees to evaluate complaints against chiropractic physicians.

#### The board may also:8

- with respect to complaints, conduct investigations and hearings, administer oaths, issue notices and subpoenas, enforce subpoenas, and impose penalties, including injunctions, probation, license suspension, denial or revocation, and assessment of costs;
- take testimony as to matters pertaining to its duties;
- establish standards and tests to determine the moral, intellectual, educational, scientific, technical and professional qualifications of license applicants;
- enforce statutory provisions and exercise general supervision;
- establish standards and procedures for certifying chiropractic assistants and establish continuing education requirements;
- establish standards for the use of ancillary personnel;
- enter into agreements to make its personnel and facilities available to other regulatory entities or other bodies interested in chiropractic practice;
- accept or approve schools, colleges, institutions, residencies, internships, and other trainings;
- establish licensure application requirements, review applications, and administer examinations;
- establish specialty certifications and related certificate requirements; and
- adopt relevant rules.
