BOARD OF BOILER RULES

Composition³

The board consists of 12 individuals with the following experiences or qualifications in Oregon, who are limited to two full four-year terms:⁴

- one owner and user (or representative and employee of an owner and user) of a high pressure boiler, with practical experience with high pressure boilers (LANGLEY);
- one manufacturer (or representative and employee of a manufacturer) of boilers or of pressure vessels (HENDRIX);
- one person who regularly inspects boilers and pressure vessels, employed by an insurer who writes boiler and pressure vessels explosion insurance policies (VACANT);
- one registered mechanical engineer (ANDERSON);

- one boilermaker (VACANT);
- one owner and user (or representative and employee of an owner and user) of a low pressure boiler (**RAPP**);
- one owner and user (or representative and employee of an owner and user) of a pressure vessel, with practical experience with pressure vessels (VACANT);
- one owner or employee of a business engaged in the installation and repair of boilers (DUNN);
- one steamfitter (BAIER);
- one practical steam operating engineer (LAMB);
- one member of the public not otherwise eligible for appointment (GARVEY); and
- the chief boiler inspector, the board's nonvoting secretary.

Duties⁵

The board formulates and promulgates rules for the safe construction, installation, inspection, operation, maintenance, and repair of boilers and pressure vessels. Its duties include:

- adopting rules for, and engaging in, administration, examinations, regulation, and enforcement;
- providing continuing education;
- setting fees; and
- hearing appeals and imposing fines.
