## **APPRAISER CERTIFICATION AND LICENSURE BOARD**

The Governor has appointed the following individuals to the Appraiser Certification and Licensure Board subject to Senate confirmation.<sup>1</sup>

#### **New Appointees**

Catherine Putegnat of Tigard Ed Rollins of Ione Owen Bartels of Portland

#### Terms

July 1, 2024 - June 30, 2028

#### **Appointment/Confirmation Authority**

ORS 674.305 (2023)

#### Statement of Economic Interest<sup>2</sup>

Not required.

### **Composition**<sup>3</sup>

The board is a semi-independent state agency that consists of eight members who must be Oregon residents, including:<sup>4</sup>

- five licensed or certified appraisers (BARTELS, DEGLOW, PULIS-TAPPOUNI, PUTEGNAT, UPHOLD);
- one employee of a financial institution or mortgage banker (ROLLINS);
- one representative of registered appraisal management companies (EGAN); and
- one public member who does not work in the industry and does not have a financial interest in any person who is required, or company whose employees or agents are required, to be licensed or certified as an appraiser (LADUE).

Members serve four-year terms for a maximum of two terms. The board must select one of its members as chairperson and another as vice chairperson.

#### **Duties**<sup>5</sup>

The board regulates and supervises real estate appraisal management companies. Its duties include:

- establishing a professional code of responsibility, programs, and education requirements for the certification, licensure, or registration of regulated people and entities;
- providing for the administration and enforcement;
- certifying or licensing appraisers and registering appraiser assistants and appraisal management companies, and supervising their activities for compliance with applicable regulations;
- establishing, maintaining, and transmitting a roster of state certified appraisers and state licensed appraisers to the Appraisal Subcommittee of the Federal Financial Institutions Examination Council, at least annually;
- establishing, collecting, and remitting the annual fees for the certification, licensure, and registration of regulated entities; and
- establishing a subcommittee composed of three members of the board to review and make recommendations on alleged violations.

The board may also: 6

- issue subpoenas to compel the production of persons and documents;
- impose civil penalties;
- require fingerprints of applicants, employees, contractors, vendors, and volunteers;
- suspend, revoke, or deny the issuance or renewal of the certificate, license, or registration of a regulated entity; reprimand a regulated entity; and require additional education of a regulated entity;
- inspect appraisal activity records maintained by regulated entities; and
- enter into reciprocal licensing agreements with states.
