- one permitted, certified public accountant employed in private industry, education, or government, or actively engaged in the practice of public accountancy (ROBINSON);
- one member of the general public (STEELE); and
- one licensed public accountant actively engaged in the practice of public accountancy (MORRIS).

Members may serve up to three consecutive three-year terms.

Duties⁴

The board is responsible for licensing and regulating Certified Public Accountants, Public Accountants, and public accounting firms. It may:

- adopt rules necessary for administration, including rules of professional conduct and standards of practice;
- appoint and fix compensation for officers; appoint advisory committees; delegate administrative and enforcement duties; collect fees; obtain criminal records; and
- engage in regulatory activities including the conduct of investigations and hearings, and imposing penalties.
