Work Session

HB 3208

Authorizes Environmental Quality Commission to annually adjust, by up to three percent, fees associated with water quality programs administered by Department of Environmental Quality.

HB 3123

Requires Oregon State University Extension Service and College of Agricultural Sciences of Oregon State University to study fate and transport of perflouroalkyl and polyfluoroalkyl substances (PFAS) found in biosolids applied to agricultural fields.

HB 2161 **

**Subsequent Referral(s) to Tax Expenditures

Makes certain changes to calculation of small forestland owner tax credit.

HB 2685 **

**Subsequent Referral(s) to Revenue

Restores availability of income or corporate excise tax credit for processing or collection of woody biomass.

HB 2687

Authorizes State Department of Agriculture to issue public applicator licenses and public trainee certificates to employees of federally recognized Indian tribes for purposes of pesticide application on certain lands adjacent to tribal lands.

Directs Oregon State University Extension Service and Oregon State University Agricultural Experiment Station to establish agricultural water management technical assistance program.

HB 3100

Establishes certain requirements concerning integrated state water resources strategy.

HB 3321

Directs Oregon Health Authority to study small community water systems.
