HB 3100

HB

Establishes certain requirements concerning integrated state water resources strategy.

3366 \*\* \*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys to Oregon Watershed Enhancement Board for deposit in Oregon Agricultural Heritage Fund for hiring related to Oregon agricultural heritage programs.

#### HB 3575

Instructs Water Resources Commission to make funding decisions for loans and grants awarded from Water Supply Development Account twice each year.

## **Public Hearing**

## HB 2238

Authorizes Director of Department of State Lands to adopt rules establishing fees related to removal or fill permit applications, wetland delineation reports and general authorizations.

HB 2929

Authorizes Water Resources Department to seek injunctive relief if person has engaged, or is about to engage, in activity that is or will be violation of certain water laws.

- HB 2631 \*\*
  - \*\*Subsequent Referral(s) to Ways and Means Provides that compensation for loss or injury to livestock or working dogs under wolf depredation compensation and financial assistance grant program must be based on multiplier of not more than seven times fair market value of livestock or working dogs and recommendation of county advisory committee.

#### HB 2633

Allows person who submits application for compensation under wolf depredation compensation and financial assistance grant program to amend application.
