- HB 2757 ** **Subsequent Referral(s) to Revenue
Expands and provides funding for coordinated crisis services system including 9-8-8 suicide prevention and behavioral health crisis hotline.
- HB 2485 ** **Subsequent Referral(s) to Ways and Means
Requires Portland State University, subject to sufficient moneys being appropriated, to enhance state's capacity to educate public mental health and addiction treatment providers by July 1, 2028, by materially increasing number of graduates from relevant degree programs.
- HB 2696 ** **Subsequent Referral(s) to Ways and Means
Authorizes Health Licensing Office to issue sign language interpreter license to qualified applicant.
- HB 2743 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from General Fund to Oregon Health Authority for Oregon Medical Coordination Center.
