Public Hearing

SB 608 A

Requires Oregon Health Authority, every three years, to conduct survey of retail pharmacies enrolled as providers in state medical assistance program regarding pharmacies' dispensing costs.

SB 376 A

Provides authority to Director of Department of Consumer and Business Services to require health care service contractors to file annual National Association of Insurance Commissioners own risk and solvency assessment summary reports and corporate governance annual disclosure reports.

SB 1043 A

CARRIED OVER FROM THE 5/3/2023 MEETING: Requires hospitals and other specified facilities that provide substance use disorder treatment to provide to specified patients upon discharge or release two doses of opioid overdose reversal medication and necessary medical supplies to administer medication.

SB 965 A

CARRIED OVER FROM THE 5/3/2023 MEETING: Allows Oregon Health Authority to conduct off-site investigation after receiving certain complaints against hospitals.

Work Session

SB 217 A

Requires that cosmetology curriculum taught by school meet standards established by Board of Cosmetology and be approved by Health Licensing Office.

SB 303 A

Requires psilocybin service center to collect and aggregate specified data and submit aggregated data to Oregon Health Authority.

SB 226

CARRIED OVER FROM THE 5/3/2023 MEETING: Removes requirement that Oregon State Board of Nursing notify State Board of Pharmacy upon authorizing nurse practitioner or clinical nurse specialist to dispense prescription drugs.

SB 227

CARRIED OVER FROM THE 5/3/2023 MEETING: During emergency declared by Governor, allows Oregon State Board of Nursing to issue limited license to practice nursing to nurse licensed in another jurisdiction and to issue limited certificate as nursing assistant to nursing assistant authorized to practice in another jurisdiction.

SB 969

CARRIED OVER FROM THE 5/3/2023 MEETING: Removes requirement that Oregon State Board of Nursing certify as nursing assistant any qualified applicant.

SB 703

CARRIED OVER FROM THE 5/3/2023 MEETING: Requires passage of specified examination for certification as nursing assistant.

SB 189 A

CARRIED OVER FROM THE 5/3/2023 MEETING: Allows health care facility to transfer human pathological waste, which includes biopsy materials, human tissues and anatomical parts that emanate from surgeries, autopsies and obstetrical and laboratory procedures on humans, to donor of pathological waste or authorized representative of donor if waste is intended for cremation, interment or other final disposition.

Note change: SB 1043 A, SB 965 A, SB 226, SB 227, SB 969, SB 703 and SB 189 A have been added to the agenda.
