Public Hearing

HB 2282

Authorizes Department of Consumer and Business Services to contract with more than five independent review organizations at one time.

HB 2292

Provides, with respect to contract with landscape contracting business, right of rescission within three business days after contract execution.

HB 2675

Provides that state structural specialty code does not apply to structure located on farm or forest operation and used for purpose related to agriculture that requires not more than 20 persons to occupy structure at any one time outside of harvest season or not more than 40 persons to occupy structure at any one time during harvest season.

HB 2054 **

**Subsequent Referral(s) to Ways and Means

Provides that district attorneys and deputy district attorneys qualify as police officers under Public Employees Retirement System.

HB 2507 **

**Subsequent Referral(s) to Tax Expenditures

Allows exception to requirement for property tax exemption that property of industry apprenticeship or training trust be actually and exclusively occupied and used for purposes of industry apprenticeship or training trust for occasional use by corporation exempt from federal income tax for purposes for which corporation is granted federal exemption.

HB 2764 **

**Subsequent Referral(s) to Ways and Means

Establishes Endangered Missing Person Alert System.
